## INDEPENDENT AUDITORS' REPORT

To the Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of East Oregonian Publishing Company Profit Sharing and Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have an audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution, Charles Schwab Trust Bank, as of June 30, 2024, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters – Supplemental Schedule Required by ERISA**

Their report dated March 29, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). **Note 1 – Description of Plan**

The following description of the East Oregonian Publishing Company Profit Sharing and Retirement (“the Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan was established on July 31, 1984. It is a defined contribution plan providing benefits to eligible employees of East Oregonian Publishing Company (“the Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

All employees over eighteen years of age and not classified as on call are eligible to participate in the Plan after completing two months of service. Employees are eligible for the profit-sharing portion of the Plan after completing one year of service.

Contributions

Participants may contribute up to 100% of their compensation (as defined in the Plan document), subject to the maximum dollar amounts allowed by law. Contributions from participants can be either pre-tax deferrals or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Unless an employee has voluntarily enrolled in the Plan or has declined to participate in the Plan, all newly eligible participants are automatically enrolled in the Plan at a default rate of three percent and increasing by one percent each year via automatic escalation up to six percent.

Participants may also contribute amounts representing distributions from other qualified plans (“rollovers from other qualified plans”)

The Company makes matching contributions of 25 percent of the participants’ eligible contributions that do not exceed 6 percent of their annual compensation from initial enrollment through 35 months of employment, 25 percent of the participants’ eligible contribution on the first 8 percent of annual compensation from 36 months through 95 months of employment, and 25 percent of the participants’ eligible contributions on the first 10 percent of annual compensation from 96 months of employment and on, including amounts deferred as catch-up contributions. In addition, the Plan may make a profit-sharing contribution each year, as determined by the Plan’s board of directors based on the Plan’s profitability. For the year ended June 30, 2024, there were no profit-sharing contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and an allocation of the employer contributions and plan earnings (losses), less an allocation of administrative expenses. Allocations are determined in accordance with the Plan’s provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants have full discretion to direct their proportionate share (vested and non-vested) of Plan assets to a variety of investment funds.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The employer matching and profit-sharing contributions and the earnings thereon vest based on the number of years of continuous service. A participant becomes 100% vested after six years of credited service, reaching the normal retirement age of 65, upon death, or becoming totally disabled physically or mentally.

Notes Receivable from Participants

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loan term may not extend beyond five years unless the loan is used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

On termination of service, a participant may elect to receive the value of his or her vested account in a lump-sum amount or annual installments over a term not to exceed the life expectancy of the Participant and the Participant's spouse, if any. If their account balance is over \$5,000 at the time of termination, participants may also elect to keep their accounts in the plan until a future date. If the value of a participant's vested account balance is \$1,000 or less, the participant will receive an immediate cash-out of his/her account balance as soon as administratively feasible. If the value of the participant's vested account balance is between \$1,000 and \$5,000, the participant may elect a cash distribution or rollover to an individual retirement account.

In the event of hardship (as defined by the Plan document), participants may withdraw some or all of their account balances, subject to the requirements of the Plan document.

Forfeited Accounts

Forfeitures of unvested benefits due to termination of employment are used to offset administrative costs. Forfeitures in excess of administrative costs, if any, are allocated among the accounts of eligible employees based upon the ratio of the participants' gross wage to the total of all participants gross wages. For the years ended June 30, 2024 and 2023, there was a total of \$8,221 and \$3,167, respectively, forfeited from participant accounts. Forfeitures and related earnings of \$8,221 were used to offset administrative costs.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the note regarding discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default in accordance with Plan provisions, the participant's loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan will distribute the excess contributions and related earnings to the applicable participants as soon as possible, and the Plan sponsor will pay any excise tax for the late payments.

Payment of Benefits

Benefits paid to participants are recorded when payment is initiated.

Administrative Expenses

Administrative expenses are paid first by plan forfeitures available and any remaining balance of expenses are paid by the Plan. Loan administration and distribution expenses are charged to the participant's account. In addition to the fees deducted from the Plan earnings, certain plan administrative expenses are paid directly by the Plan sponsor and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through April 12, 2025, the date the audited financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

Fair value is defined as an exit price, representing the amount that would be used to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair values as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following describes the valuation methodology used for the Plan's assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

*Mutual Funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trusts:* These are valued at the NAV of units of a common collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to these investments.

**Note 5 – Investment in the Stable Value Fund**

During the years ended June 30, 2024 and 2023, the Plan held investments in a fully benefit responsive investment contract with Morley Financial Services, Inc. (Morley), a subsidiary of Principal Financial Group. Morley maintains the contributions in a pooled account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully-benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Morley, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Morley. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with plan participants is not probable.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

**Note 7 – Tax Status**

The Company has adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended and restated since the volume submitter received the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
