INDEPENDENT AUDITOR'S REPORT

To the Trustees of

Report on the Audited Financial Statements

Opinion

We have audited the financial statements of ILWU Warehouse Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, which comprise the statements of net assets available for benefits and benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in its net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of ILWU Warehouse Welfare Fund as of June 30, 2024 and 2023, and the changes in net assets available for benefits and the changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ILWU Warehouse Welfare Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ILWU Warehouse Welfare Fund's ability to continue as a going concern for one year after the date that the financial statements are issued.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of ILWU Warehouse Welfare Fund (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

Mutual Funds: The Plan’s mutual funds are recorded at fair value based on quoted prices in active markets (Level 1).

Money Market Accounts: The Plan’s money market accounts are recorded at cost, which approximates fair value (Level 2).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain investment-related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Employer Contributions

Contributions are billed monthly based upon employment information provided by employers and rates specified in applicable collective bargaining agreements. Contributions outstanding as of year end are accrued.

Employer Receivable

Employer contributions due but not paid at year-end are recorded as employer contributions receivable. The carrying amount of contributions receivable is reduced for an allowance for credit losses that reflects management's best estimate of amounts that will not be collected. Factors which influence management's judgment in determining the appropriate allowance for credit losses include past collection experience, industry standards, current economic conditions, and expected future economic conditions. As of January 1, 2023 and December 31, 2023, the allowance was \$0. As of December 31, 2022, the allowance for doubtful accounts was \$0.

Participant Contributions

Contributions are recognized as income based on amounts received for coverage months during the year ended June 30. Amounts received in advance for coverage after June 30 are recorded as deferred revenue.

Claims Payable and Incurred But Not Reported

Estimated claims payable and incurred but not reported as of June 30, 2024 and 2023 includes an estimate of claims incurred prior to June 30, but paid after that date. These estimates were calculated based on claims experience.

Accumulated Eligibility Credits

The Plan provides eligibility for benefits on a lag-month basis. Hours worked in June provide for July eligibility. Accumulated eligibility credits represent the estimated liability for future benefits based on the participants' accumulated eligibility arising from hours worked through June 30. The Plan's benefit obligations are estimated by the Plan's management.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in mutual funds and money market accounts. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update (“ASU”) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure, and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023 using the modified retrospective approach. Comparative prior periods were not adjusted upon adoption. Upon adoption, there was no cumulative-effect adjustment to the opening fund balance.

2. DESCRIPTION OF THE PLAN

The Plan was established in 1953 as a result of a collective bargaining agreement between the union (Local 6 of the International Longshore Warehouse Union) and independent employers to provide welfare benefits for eligible employees and their dependents. The current Plan provides hospital, medical, dental, surgical, life, vision, drug, disability, and drug and alcohol rehabilitation benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

Medical, prescription, vision and life benefits are provided through service agreements with various health maintenance organizations and insurance carriers. Dental benefits are provided by the Plan on a self-funded basis or through an insured arrangement. Drug and alcohol rehabilitation benefits are provided through the Teamsters Assistance Program (“TAP”).

Eligibility rules under the Plan require a participant to work 80 hours or more before an employer is required to make contributions to the Plan or for such other number of hours as may be specified in a collective bargaining agreement or subscriber agreement. The Plan provides eligibility for benefits on a lag-month basis. Hours worked in June provide for July eligibility. Accumulated eligibility credits represent the estimated liability for future benefits based on the participants’ accumulated eligibility arising from hours worked through June 30.

Certain retirees may receive benefits through the Plan upon approval by the Board of Trustees (the “Trustees”). Although these benefits may be provided by the Plan, they are not guaranteed. The Trustees reserve the right to reduce or discontinue benefits or to increase co-payments. Retiree benefits are only available to a very limited number of participants. The net present value of the Plan’s obligations for expected future retiree benefits as of June 30, 2024 and 2023, was determined to be immaterial by the Plan’s consultant.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (“COBRA”), has been adopted by the Plan.

Participants should refer to the Summary Plan Description and Plan amendments for more complete information.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated February 1955, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by employer and retiree contributions and by contributions from members electing COBRA coverage. The monthly employer contribution rate is specified in the collective bargaining agreements. Retiree and COBRA contribution rates are determined by the Trustees.

6. CASH CONCENTRATIONS

The Plan places its cash with a financial institution deemed to be creditworthy. The balances are insured by the Federal Deposit Insurance Corporation ("FDIC") for up to \$250,000. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's net assets and changes in net assets available for benefits. The Plan's cash at June 30, 2024 and 2023 consisted of the following:

8. MAJOR EMPLOYER

The Plan had five employers that were considered major employers in the Plan for the years ended June 30, 2024 and 2023. The five employers revenue is greater than 10% so they are considered major employers which make up 72% of contributions in 2024 and 77% in 2023. In the event these employers suspend contributions, the Plan would terminate coverage to the employers' participants, as required under the Plan document. The Plan would retain the risk of current fixed administrative expenses until the appropriate adjustments were made.


