INDEPENDENT AUDITOR'S REPORT

The Board of Trustees
Teamsters Local Union No. 856 Health and Welfare Fund

Opinion

We have audited the accompanying financial statements of Teamsters Local Union No. 856 Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTE 1: Description of the Plan

The following description of the Teamsters Local Union No. 856 Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General.

The Plan was created by a Declaration of Trust dated December 1, 1964 pursuant to a collective bargaining agreement between the Freight Checkers, Clerical Employees and Helpers Union Local No. 856 and certain employers. The Plan was created for the purpose of providing insurance benefits for eligible employees and their dependents. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

A. Benefits

The Plan provides health, dental, prescription drug, vision, life and accidental death and dismemberment coverage to eligible employees, their dependents and retirees to the level provided in their respective collective bargaining or subscription agreements, which include insured provider, and direct-pay plans. Eligible participants elect their medical and dental provider annually through the open enrollment process.

B. Eligibility

Generally, eligibility extends on a monthly basis to covered employees who are compensated for 80 hours or more in the preceding month unless disabled. Eligibility of dependents is generally coincident with that of the employee. Qualified retirees maintain eligibility through employer payments or self-payment of the monthly contributions. The Plan provides, in accordance with the COBRA provisions of federal law, that employees may self-pay contributions to maintain eligibility.

C. Funding Policy

Contracting employers contribute monthly for all covered employees at the monthly rate specified in their respective collective bargaining or subscription agreements for the benefits specified. Employer contribution rates vary depending upon subscribed coverage and/or the terms of the agreement last negotiated. The costs of the postretirement benefits are shared by the Plan's participating employers and retirees. In addition to the deductibles and co-payments, retirees, on average paid 29% of the estimated cost of postretirement benefits for the fiscal years ended June 30, 2024 and 2023.

D. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to

purposes other than for the exclusive benefit of the participants and shall be done subject to the provisions set forth in ERISA.

NOTE 2: Summary of Significant Accounting Policies

A. Method of Accounting

The Trust uses the accrual method of accounting to maintain its accounting records, and these financial statements have been prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, incurred but not reported claims, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

C. Retiree Benefits

Certain benefits provided to retirees are being funded by current employer contributions and monthly co-payments from retirees. Although these benefits are currently provided by the Plan, they are not guaranteed, and the Board of Trustees reserves the right to reduce or discontinue benefits or increase co-payments. The calculation of an accounting obligation does not, in and of itself, imply that there is any legal liability to provide the benefits valued. Nor is there any implication that the Plan is required to implement a funding policy to satisfy the projected expense. Additionally, in the Retiree Summary Plan Description (SPD), Article II, Section 3, Part D, of the Rules and Regulations governing retiree self-payments specifically provides, “the foregoing rates are subject to change at any time at the discretion of the Trustees” and Article VII, Section 1 of the Retiree SPD specifically states that, “the Board of Trustees expressly reserves the right, in its sole discretion at any time and from time to time, but upon a non-discriminatory basis: (a) to terminate or amend either the amount or condition with respect to any benefits even though such termination or amendment affects claims which have already accrued.

D. Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The board of trustees determines the appropriateness of the Plan's investment offerings, and monitors investment performance. See Note 5 for discussion of fair value measurements.

E. Interest and Dividends

Interest and dividends are reported at their stated rate from their respective financial institutions. For the fiscal years ended June 30, 2024 and 2023, the interest earned was \$84,502 and \$63,717, respectively. For the fiscal years ended June 30, 2024 and 2023, the dividends earned were \$1,950,496 and \$1,260,635, respectively.

F. Reclassifications

Certain reclassifications have been made to the prior year amounts to conform to the current year presentation.

G. Postretirement Benefits

The amount reported as the postretirement benefit obligation at June 30, 2024 and June 30, 2023 represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers.

The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service to the participating employer rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary, and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant, and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement), between the valuation date and the expected date of payment.

Some of the more significant assumptions used in the valuations as of June 30, 2024 and 2023 are as follows:

The Weighted-average Mortality Discount Rate for 2024 and 2023 was 5.25% and 5.00%, respectively. These rates are from the January 2024 and 2023 non-seasonal actuarial valuation of the Western Conference of Teamsters Pension Plan.

The assumed health care cost trend rates used to measure the expected increase in the cost of benefits are based on the following components by participant group:

Indemnity Medical Benefit – The trend rate for claims costs was 5.25% in 2023 and 5.00% in 2024. Thereafter, the trend rate decreases by 25 basis points each year until 2028, at which time it reaches the rate of 4.00%.

Prescription Drug Benefit – The trend rate for claims costs was 5.25% in 2023 and 5.00% in 2024. Thereafter, the trend rate decreases by 25 basis points each year until 2028, at which time it reaches the rate of 4.00%.

Insured HMO Medical/Drug Plan – The trend rate for claims costs was 5.25% in 2023 and 5.00% in 2024. Thereafter, the trend rate decreases by 25 basis points each year until 2028, at which time it reaches the rate of 4.00%.

Stop-Loss and PPO Access Fees – The trend rate for claims costs was 5.25% in 2023 and 5.00% in 2024. Thereafter, the trend rate decreases by 25 basis points each year until 2028, at which time it reaches the rate of 4.00%.

Retiree Self-Pays - The trend rate is 3.00% for 2023 through 2028.

Dental - The trend rate is 3.00% for 2023 through 2028.

Vision - The trend rate is 2.00% for 2023 through 2028.

Administrative Costs – The trend rate is 4.00% for 2023 through 2028.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

H. Other Plan Benefits

Estimated claims payable for claims received but not paid have been estimated by analyzing open claims, and claims paid after the balance sheet date for services provided prior to the balance sheet date.

Estimated claims incurred but not reported as of June 30, 2024 and 2023 have been estimated by applying statistical methods to historical experience, and by analyzing subsequently reported claims.

Estimated future benefits based on participants' accumulated eligibility are computed as follows. Participating employees earn eligibility credit by being compensated for 80 hours in a month, which provides coverage for the subsequent month. The liability for eligibility credits earned in June, 2024 and 2023 for benefit coverage in July, 2024 and 2023 have been estimated by using the Plan records of premiums paid for and claims incurred in July, 2024 and 2023, respectively. Other post-employment benefit obligations, other than postretirement benefits were determined to be de-minimis.

Health claims incurred by retired participants, but not reported at the fiscal year end, are included in the postretirement benefit obligation.

Stop-loss recoveries are netted against benefit payments on the statement of changes in net assets available for benefits. For the fiscal years ended June 30, 2024 and 2023, the recoveries received were \$795,617 and \$3,002,118, respectively.

NOTE 3: Tax Status

The Trust, established under the Plan to hold the Plan's assets, is intended to qualify pursuant to Section 501 (c) 9 of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsors believe that the Trust, as amended, continues to qualify and to operate

NOTE 5: Fair Value Measurements

The Plan's investments are stated at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes the Plan's investments, other than those recorded at Net Asset Value (NAV). The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses Level 1 for investments held, other than those recorded at NAV.

NOTE 6: Investments

The Plan's investments are held in a banking institution, registered investment companies, a pooled separate account, and in a mortgage investment fund. Changes were not required on the statement of net assets available for benefits or the statements of changes in net assets available for benefits with the adoption of the Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) No. 2016-01 related to the investments held in The Plan.

NOTE 7: Benefit Obligations

The Statements of Changes in the Plan's Benefit Obligations for the fiscal years ended June 30, 2024 and 2023 reflect the changes in benefit obligations from the beginning of the Plan year to the end of the Plan year.

The Plan's deficiency of net assets over benefit obligations at June 30, 2024 and 2023, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rates provided by the current bargaining agreement. It is expected that the deficiency will be funded through future increases in the collectively bargained contribution rates.

The weighted-average health care cost-trend rate assumption for postretirement benefit obligations (see Note 2) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of June 30, 2024 and 2023 by \$26,614,900 and \$32,349,800, respectively.

NOTE 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as the trading market. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits. The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

NOTE 11: Concentration of Cash

The Plan's financial assets that are potentially subject to credit risk include cash and cash equivalents. Balances are held at financial institutions deemed to be creditworthy. At times, the Plan may have cash and cash equivalents at a financial institution in excess of Federal Deposit Insurance Company insured limits of \$250,000 per institution.

NOTE 12: Subsequent Events

Subsequent events have been evaluated through April 11, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no new material event or transaction which would require an additional adjustment to, or disclosure in, the accompanying financial statements.
