### NOTES TO FINANCIAL STATEMENTS

June 30, 2024 and 2023

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Medical Faculty Associates 401(a) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan was established by Medical Faculty Associates, Inc. ("MFA" or the "Company") on July 1, 2000. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is a defined contribution retirement plan, which provides retirement benefits to qualified employees of MFA on a noncontributory basis. Benefits are funded by fixed dollar annuities issued by the Teachers Insurance and Annuity Association ("TIAA"), the TIAA Real Estate Account (a pooled separate account), variable annuity accounts offered by the College Retirement Equities Fund ("CREF"), the TIAA Access Annuities (variable annuities), and various mutual funds, Brokerage Link account and a guaranteed income fund held by Fidelity Management Trust Company ("Fidelity"). TIAA and CREF are the insurance companies for the TIAA and CREF assets and Fidelity is the custodian and the trustee of the remaining Plan assets.

Effective January 1, 2018, the Plan was frozen to new participants and contributions (employer and rollover) may not be made to the Plan. A separate 403(b) plan sponsored by the Company is administered and allows for employee contributions.

##### **Termination**

MFA intends to continue the Plan indefinitely but reserves the right to modify or discontinue the Plan at any time. In the event of Plan termination, participants will immediately become 100% vested in their account balances, and the benefits accrued by participants prior to the date of discontinuance cannot be adversely affected.

##### **Contributions**

Prior to January 1, 2018, the amount of any contribution by the Company was determined each year and was discretionary. At the discretion of the board of directors, the Company could contribute additional funds to the Plan retrospectively.

Each participant's account is credited with the allocation of the employer's contribution and Plan earnings (losses) and charged with an allocation of the administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Participation and Vesting**

Employees were eligible to participate in the Plan if they have attained age 21 and completed three months of service. Vesting in the Plan is based on years of service. A participant is vested in accordance with the following.

For the participants employed prior to January 1, 2007, their accounts were 0% vested until they reached five years of service, at which point they became 100% vested. Contributions to Plan accounts of participants who terminate employment with MFA before vesting are forfeited, and such forfeitures are used to reduce MFA's subsequent Plan contributions, to pay administrative expenses, or for any other purpose permitted under ERISA and the Internal Revenue Code (the "Code"). As of June 30, 2024 and 2023, unallocated forfeitures totaled \$12,955,166 and \$11,777,548, respectively. During the year ended June 30, 2024, forfeitures of \$97,384 were used to reduce administrative expenses.

***Retirement***

The normal retirement date of each participant is the last day of the fiscal year in which the participant attains age 65. When an employee reaches the normal retirement age, an employee will become 100% vested in the Plan.

***Payment of Benefits***

Payment of benefits from the Plan is permitted upon termination of employment, death or disability. Upon termination of service, participants may elect to receive a lump-sum distribution. They may also elect to receive benefit payments under any of the lifetime income benefits available through the TIAA Traditional annuity or may maintain their investments in the investments held by Fidelity. Vested Plan participants who terminate employment from MFA prior to retirement may continue to maintain balances in the Plan. Minimum required distributions for participants who have reached age 73 also apply per Internal Revenue Service ("IRS") regulations.

***Investment Options***

Participants may elect to allocate MFA contributions among various mutual funds, BrokerageLink account and a fixed annuity contract (Empower Guaranteed Income Fund) at Fidelity and a fixed annuity contract ("TIAA Traditional"), a pooled separate account and variable annuity accounts at TIAA and CREF. Effective January 1, 2007, new participants could only elect Fidelity investment options for MFA contributions.

***Notes Receivable from Participants***

The Plan permits loans to qualifying participants of a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their Fidelity investment balances. Principal and interest paid by the participant are reinvested into their account. Participants may only have one loan outstanding at any time. Loans made for the purchase of a primary residence must be repaid within 15 years. Loans for all other purposes must be repaid in five years. The interest rate is determined by the prime rate plus 2%. Interest rates are fixed for the duration of the loan. Interest rates ranged from 5.25% to 10.50% at June 30, 2024 and 2023.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP") and is permitted under the United States Department of Labor's reporting and disclosure requirements. Accordingly, certain additions and related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligations are incurred. Contributions are recognized when received by the Plan.

***Investment Valuation and Income Recognition***

Investments are reflected at their fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract plus earnings at the guaranteed crediting rates, less withdrawals and fees. Fair value of mutual funds, CREF variable annuities, TIAA Access Annuities and the TIAA pooled separate account represent the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance companies. The TIAA Traditional Annuity is valued at the accumulated value of contributions plus interest credited to date less withdrawals and fees, which approximates fair value. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

In the statement of changes in net assets available for benefits - modified cash basis, the Plan presents the net appreciation in the fair value of its investments, which consists of realized gains or losses and the unrealized appreciation (depreciation) on those investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

***Other Income***

The Plan has a revenue sharing agreement with Fidelity where the Plan receives an agreed amount from the service provider that can be used to pay for allowable Plan Administrator expenses.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid from the accounts of Plan participants for actions initiated by the participants, such as loan and origination fees. Other administrative expenses of the Plan are paid by the MFA, a party-in-interest. In addition, certain accounting and administrative functions of the Plan are performed by employees of MFA at no cost to the Plan.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of the modified cash basis financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from management's estimates.

***Risks and Uncertainties***

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.
- Level 3 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at June 30, 2024 and 2023. There have been no changes in valuation methodologies used at June 30, 2024 and 2023 or transfers between levels.

***Mutual Funds and Self Directed Brokerage Account***

Valued at the net asset value (“NAV”) of shares held by the Plan. Because these funds are traded daily on an active exchange and are valued primarily on the basis of market quotations, official closing prices, or on the basis of information furnished by a pricing service, they are classified as Level 1.

***Registered investment companies***

The fair values of accumulation units held by the Plan in the CREF accounts (registered investment companies held as variable annuity accounts) are based on each account’s daily NAV. CREF accounts are not exchange-traded. Data for NAVs are available daily to plan administrators and client investors on NASDAQ’s website (Level 1) and provides sufficient corroborative evidence to ascertain the relationship between each fund’s NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources.

***TIAA Traditional Annuities***

Valued at the amount that would be received at the reporting date if amounts were withdrawn or funds transferred within the Plan prior to maturity. A participant can only withdraw from the non-fully benefit-responsive TIAA Traditional Annuities according to the predetermined installment plan. These assets are classified as Level 3 due to lack of observable transactions or similar investment instruments.

The TIAA Traditional Annuities are a guaranteed (by TIAA’s claim paying ability) annuity, which guarantees principal and pays a minimum guaranteed interest, currently 3% during the accumulation phase. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis. When declared, the additional amounts remain in effect for the declaration year that begins each March 1 and are not guaranteed for future years. Together the guaranteed minimum and additional amounts make up the crediting rate in the accumulation phase. TIAA groups premium dollars received over defined periods into vintages for the purposes of determining the crediting rate for the applicable declaration year during the accumulation period. As of June 30, 2024 and 2023, the crediting rate was 5.50% and 6.25%, respectively, for the Group Retirement Annuity (“GRA”).

***TIAA Access Annuities (variable annuities)***

Valued at the NAV of units of a separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

***Insurance Company Pooled Separate Account***

Valued at NAV of accumulation units held by the Plan at year end. NAV, calculated daily, is applied to daily purchase and sale transactions in addition to being used to value ending market values. Data for NAV is available daily to plan administrators and client investors on NASDAQ’s website. Transfers out of this account are limited to once per quarter. These assets are classified as Level 2 because, while the funds have a quoted NAV, they have certain restrictions impacting participants’ ability to transact.

<sup>(a)</sup> This category represents investments in TIAA Access Annuities. These funds are separate accounts of TIAA, an insurance company. It is a variable annuity and is registered with the Securities and Exchange Commission as an investment company under the Investment Company Act of 1940. It operates as a unit investment trust. As such, it will invest in shares of underlying mutual funds. Contributions to TIAA Access Annuities buy accumulation units whose value is calculated daily. There are no unfunded commitments. These funds seek to balance equity and fixed income investments based on anticipated retirement date.

**NOTE 4 - CONTRACTS WITH INSURANCE COMPANY**

The Plan invests in Empower Guaranteed Income Fund ("GIF"), which is a fully benefit-responsive group annuity product issued by Empower Annuity Insurance Company of America ("EAICA") or, as applicable, Empower Annuity Insurance Company of America of New York ("ELAINY"). Amounts invested in the GIF are deposited in Empower Retirement's general account. Payment obligations and the fulfillment of any guarantees specified in the group annuity contract are claims supported by the full faith and credit of EAICA or ELAINY. Interest is credited on contract balances using a single "portfolio rate" approach.

The Plan's ability to receive amounts due under this portion of the contract is dependent on the issuer's ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 5 - INCOME TAX STATUS**

The Plan received a favorable determination letter from the IRS on December 23, 2011, which affirmed that the Plan was designed with the applicable requirements of the Code Section 401(a) (qualified plan). Although, the Plan has been amended and restated since the date of this determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - INFORMATION CERTIFIED BY THE PLAN CUSTODIANS**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, and Fidelity, custodians of the Plan, have certified that the following information included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits - modified cash basis as of June 30, 2024 and 2023.
- Net investment income interest on notes receivable from participants and other income, as shown in the statement of changes in net assets available for benefits - modified cash basis. for the year ended June 30, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of June 30, 2024.

**NOTE 7 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, BrokerageLink account, variable annuity accounts, pooled separate accounts or annuity contracts managed by Fidelity, TIAA and CREF. Fidelity is the trustee and TIAA and CREF, as insurance companies, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The transactions related to the Fidelity revenue sharing agreement are also party-in-interest transactions.
