Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Carnegie Institution of Washington Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of matter – Basis of accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) as of June 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Carnegie Institution of Washington Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established by the Carnegie Institution of Washington (the “Institution” or “Employer”) on July 1, 1954. The Plan is a defined contribution, money purchase plan that provides retirement benefits to eligible employees of the Institution on a noncontributory basis. The Teachers Insurance and Annuity Association of America (“TIAA”) and College Retirement Equities Fund (“CREF”) (together, “TIAA and CREF”), or (the “Custodians”) serve as the Plan’s custodians. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Participant Accounts

Each participant’s account is credited with the Institution’s contributions and an allocation of Plan earnings, and charged with withdrawals and an allocation of investment losses and administrative expenses. Allocations are based on participant earnings or account balances on a daily basis. Upon enrollment in the Plan, a participant may direct employer contributions in any of the investment options offered by the Plan in increments of whole number percentages.

Participation and Vesting

Under the Plan, all employees are eligible to enroll for participation in the Plan from their first day of employment, except part-time, temporary and seasonal employees, nonresident alien, and leased employees. Participants become fully vested after completion of one year of service. If a participant terminates prior to vesting, the amounts included in the Plan will be forfeited and used by the Institution to be applied against future contributions for remaining participants.

For the year ended June 30, 2024, \$175,498 of funds were applied from the forfeiture account. As of June 30, 2024 and 2023, \$840 and \$167,894 remained in the forfeiture account, respectively.

Notes Receivable from Participants

Notes receivables from participants are not permitted under the Plan.

Contributions

The Plan stipulates that the Institution will contribute an amount equal to a percentage of each participant’s gross salary for the Plan year, which is actuarially determined based on the age of the participant. These contributions are invested in funds as directed by the participants. The maximum annual earnings of each participant upon which the Institution’s contributions are based cannot exceed \$345,000 and \$330,000 for calendar years ended December 31, 2024 and 2023, respectively. Additionally, the Institution’s annual contributions on behalf of the Plan participant cannot exceed \$69,000 and \$66,000 for calendar years ended December 31, 2024 and 2023, respectively, as set by the Internal Revenue Service (“IRS”).

Benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive either a lump-sum distribution equal to the value of the participant’s vested interest in his or her account, or through

various installment or annuity options available under the Plan. Minimum required distributions for participants who have reached age 73 also apply per IRS regulations.

Termination

The Institution intends to continue the Plan indefinitely, but reserves the right to amend, modify, terminate, or discontinue further contributions or payments under the Plan at any time subject to the provisions of ERISA. In the event of a complete or partial termination of the Plan or discontinuance of contributions, all individual accounts will become nonforfeitable to the extent funded.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Presentation

The Plan's accounting records are maintained on the modified cash basis of accounting, modified to state the Plan's investments at fair value. Employer contributions are recorded when received by the Plan custodians. Benefits are recorded when paid.

Administrative Expenses

The Institution provides various administrative and other services to the Plan at no charge. Certain other administrative expenses are paid directly out of the Plan.

Investments

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians.

Plan asset purchases and sales are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"), requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

NOTE 3 - INVESTMENTS AND INFORMATION CERTIFIED BY CUSTODIANS

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, the custodians of the Plan, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate. This certification also extends, to those investments, if any, which TIAA, FSB, a federal saving association, from the beginning of the plan's reporting period through July 14, 2023 and thereafter TIAA Trust, N.A., a national trust bank, held as a directed trustee or custodian that were record kept by TIAA. This certification

is provided by TIAA on behalf of TIAA, FSB and TIAA Trust, N.A. pursuant to agreements providing TIAA with specific authority to certify plan records as required.

NOTE 4 - FAIR VALUE MEASUREMENT

Accounting standards provides the framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2024 and 2023.

The Plan's Level 1 investments are valued at fair value at the close of business each day and invest principally in equity securities, fixed income instruments, other mutual funds, real estate holdings and short-term instruments in accordance with each account's and fund's investment objectives. Account and fund holdings are generally valued using market quotations or prices obtained from independent pricing services. Funds are available for transactions at the closing unit value on any day the New York Stock Exchange is open for business.

The fair values of accumulation units held by the Plan in registered investment companies held as variable annuity accounts are based on each account's daily net asset value ("NAV"), which is considered by Plan management to be the best approximation of fair value. Variable annuity accounts are not exchange traded. Data for NAVs are available daily to plan administrators and client investors on National Association of Securities Dealers Automated Quotations website, and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources.

The fair value of the Plan's interest in the TIAA Real Estate Account (a pooled separate account) is based on the fund's daily NAV, which is considered by Plan management to be the best approximation of fair value. The unit value of the fund is calculated daily and available to plan administrators and client investors on NASDAQ's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet participant redemption, transfer or cash withdrawal requests.

Investments in TIAA Traditional Annuity contracts are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Contract value is deemed to approximate fair value for Retirement Annuity ("RA") and Retirement Choice Annuities ("RC") contracts based on observation of recent participant investments at contract value and by comparison of historical and current yields of highly rated long-term corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts.

There are no unrealized gains or losses from the TIAA Traditional Annuity guaranteed investment contracts included in the statement of changes in net assets available for benefits - modified cash basis as the contracts are recorded at contract value, which approximates fair value for purposes of the net assets available for benefits - modified cash basis.

The Plan's Level 3 assets for the year ended June 30, 2024 included purchases of \$3,701,078. There were no transfers into or out of Level 3 during 2024 and 2023.

NOTE 5 - TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity contracts are guaranteed fixed annuity contracts available as investment options to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through the individual Retirement Annuities ("RA"), and Retirement Choice Annuities ("RC") and Retirement Choice Plus Annuities ("RCP"), contract types, which determines the applicability of

certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. Participants' principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA contracts, the crediting interest rate was 5.50% and 6.25% as of June 30, 2024 and 2023, respectively. The crediting interest rate for accumulating RC contracts was 5.75% and 6.50% as of June 30, 2024 and 2023, respectively. The crediting interest rates for RCP contracts was 5.50% and 6.25% as of June 30, 2024 and 2023, respectively.

All RA contracts require withdrawals in the form of a lifetime payout annuity or in periodic installments over a 10-year period. Because this provision is considered to restrict participants' "reasonable access" to their contract balances, RA contracts are not considered to be fully benefit-responsive investment contracts. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits - modified cash basis. Under the RC contracts, distributions may be withdrawn in a single lump sum within 120 days of termination, subject to a 2.5% surrender charge. All other withdrawals and transfers must be spread over 84 monthly installments.

All RCP contracts allow for lump sum transfers and withdrawals at any time without surrender charges. However, under some contracts, transfers to competing funds must first be transferred to non-competing funds where they must remain for 90 days. This provision is considered to provide participants with "reasonable access" to their contract balances, making RCP contracts fully benefit-responsive investment contracts. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits - modified cash basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 6 - RELATED PARTIES

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are the Plan's custodians as defined by the Plan and, therefore, these transactions all qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by employees of the Institution. No such employee receives compensation from the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

NOTE 7 - TAX EXEMPT STATUS

The Plan adopted a non-standardized defined contribution pre-approved plan document sponsored by TIAA. The non-standard defined contribution plan has received an opinion letter dated June 30, 2014, from the IRS as to the non-standard defined contribution plan's qualified status. The non-standard defined contribution plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provision of the Internal Revenue Code.

The Plan Administrator has analyzed tax positions taken by the Plan and concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

NOTE 9 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through April 15, 2025, which is the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.
