Basis for Opinion

Year Ended June 30, 2024

1. Description of plan:

The following description of the Critical Path Institute 403(B) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established July 1, 2005, and has been amended several times since that date.

General:

The Sponsor of the Plan is Critical Path Institute (Sponsor).

The Plan is a defined contribution retirement plan with 403(b) provisions consisting of a salary reduction arrangement. All employees of the Sponsor working more than twenty hours per week are eligible to participate in the Plan upon hire. Participants must complete one month of service prior to becoming eligible for the safe harbor matching and discretionary non-elective provisions of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant contributions:

Participants can elect to defer a percentage of their pre-tax compensation to the Plan, subject to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). The Plan also permits eligible participants to make additional voluntary contributions of Roth deferrals and qualified rollovers from other retirement plans.

Employer contributions:

Under the safe harbor provisions of the Plan, the employer will contribute and allocate to each participant's matching account an amount equal to 100% of the participant's elective deferrals, up to 5% of the participant's compensation. The Sponsor shall also make additional non-elective contributions of 3% of compensation to each eligible participant's account. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions. Contributions are subject to statutory limitations.

Participants' accounts:

Each participant's account is credited with the participant's elective deferral, employer, and rollover contributions, actual earnings thereon and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their elective deferral contributions, safe harbor contributions, non-elective employer contributions and any rollover contributions made to the Plan, plus actual earnings thereon.

Year Ended June 30, 2024

1. Description of plan (continued):

Investment options:

Upon enrollment in the Plan, a participant may direct contributions into any of several investment options. Participants may change their investment options at any time.

Payment of benefits:

On termination of service due to death, disability, retirement, or election at age 59½, a participant will receive the value of the participant's vested interest in his or her account as a lump-sum distribution or may elect to take partial payments, installment payments or purchase an annuity contract, pursuant to the terms of the Plan. Participants with account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

Participant loans:

Participants may obtain loans from the Plan. All loans require written spousal consent, cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less), and must be a minimum of \$1,000. The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a longer period. All loans will provide for the repayment of interest at the prime rate on the date of the loan. The participant's individual account serves as collateral for the loan and, in the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statement of net assets available for benefits as notes receivable from participants.

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the elective deferral portion of his/her individual account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses, or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Summary of significant accounting policies (continued):

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent event:

The Plan has evaluated the events that have occurred subsequent to June 30, 2024 through April 15, 2024, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor has adopted a volume submitter 403(b) plan as published by Ascensus LLC, who obtained its latest opinion letter on January 1, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts - TIAA Real Estate Fund: This account invests primarily in real estate properties and real estate related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The account sometimes holds securities to facilitate liquidity. The securities are priced using values obtained from independent pricing sources. The unit value of this fund (net asset value) is calculated daily. The net asset value is used as a practical expedient to estimate fair value.

Pooled separate accounts - All Other: These funds' assets are invested in registered investment companies. The funds are valued at the net asset value of units of the separate account. The net asset value of the units is determined daily and includes adjustments for investment fees. The net asset value is used as a practical expedient to estimate fair value.

Investment contracts with insurance company: Fair value is determined by TIAA and CREF by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Equity funds: These funds consist of professionally managed investment products primarily invested in equity instruments to create a diversified pool of securities to achieve growth objectives.

Fixed income funds: These funds consist of professionally managed investment products primarily invested in debt instruments with the objective of generating income.

Target date funds: These funds consist of a blend of investments that are re-balanced over time to address retirement goals. Funds with longer horizons are invested more aggressively to achieve growth objectives while shorter-term funds are invested in more conservative securities with the objective of generating income.

Real estate fund: This fund consists of direct ownership interest in real estate and indirect interests in real estate through real estate-related securities. Transfers out of this fund must generally be at least \$1,000 (except for systematic transfers, which must be at least \$100) or the entire fund balance, whichever is less.

5. Investment certification:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest income and dividends for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TIAA and CREF and Ascensus LLC.

6. Related party and party in interest transactions:

Certain Plan investments are managed by TIAA and CREF and Ascensus, LLC. The Plan paid certain expenses to TIAA and CREF and Ascensus, LLC and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

7. Investment contracts with insurance company:

For 2024 and 2023, the Plan holds both benefit-responsive and non benefit-responsive investment contracts with TIAA and CREF who maintains the contributions of each contract in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by TIAA and CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Both investments are reported at contract value. Contract value for the non benefit-responsive contract approximates fair value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield for the benefit-responsive contract, based on both actual earnings and the interest rate credited to participants, was 4% for 2024 and 2023. The crediting interest rate is based upon an agreed-upon formula, and is reviewed on a semi-annual basis for resetting. The crediting interest rate for the non benefit-responsive contract was approximately 4% for 2024 and 2023.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date. The contracts also do not allow lump-sum cash withdrawals, and transfers must be spread over a period of ten annual installments (or five annual installments for withdrawals after termination of employment).

9. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

10. Risks and uncertainties:

The Plan invests in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by subprime mortgage loans. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rate. In addition, the Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
