INDEPENDENT AUDITORS' REPORT

To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Gracelight Community Health 403(b) Thrift Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Gracelight Community Health 403(b) Thrift Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Gracelight Community Health 403(b) Thrift Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of Gracelight Community Health 403(b) Thrift Plan (“the Plan”) provides only general information. Participants should refer to the Plan’s documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 403(b) plan which covers all eligible employees of Gracelight Community Health (“GCH”) as defined in the Plan. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan became effective on January 1, 2002 and was most recently amended effective November 1, 2021. The amendments included the following:

- If an employee terminates their employment and their total vested account balance, including any rollover contributions, does not exceed \$5,000, their total vested account balance will be distributed from the plan.
- Each participant who satisfies the requirements of Section 1.3(b)(2) for a payroll period determined according to the following formula: Fixed Percentage. Such allocation shall be an amount equal to 100% of his Salary Reduction Contributions described in Section 1.3(a) that were deferred during that payroll period while he or she satisfied the participation requirements for Employer Matching Contributions, and that do not exceed 3% of his or her compensation received during that payroll period while he or she satisfied the participation requirements for Employer Matching contributions.
- Section 8.4(b) is changed by the addition of the following sentence at the end thereof: A participant must provide a representation that he or she has insufficient cash or other liquid assets reasonably available to satisfy the immediate and heavy financial need.

Contributions

Each year, the participants may contribute to the Plan with a percentage or fixed dollar amount up to the maximum determined by the Internal Revenue Service Code, from their eligible compensation as defined in the Plan. GCH makes a matching contribution to the Plan equal to each participant’s voluntary contribution up to a maximum of 3% of the participant’s compensation. In addition, GCH contributes an additional 3% each pay period on behalf of eligible participants. For the plan year ended June 30, 2024, GCH made matching contributions up to 3%, and base contributions equal to 3% of the participants’ eligible compensation for a total of \$715,500. Participants who have attained the age of 50 by the Plan year-end may also make catch-up deferrals. Furthermore, the Plan accepts contributions that are rolled over from other qualified plans.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, discretionary employer matching contribution (if any), discretionary employer base contribution (if any), and an allocation of plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan, continued

Vesting

Participants are fully vested, at all times and in all events, in their contributions. A participant is 100% vested in the matching contributions after five years of service. Upon a participant's death, permanent disability while employed by GCH, or upon retirement or after normal retirement age, the participant becomes 100% vested.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by Mutual of America Life Insurance Company ("Mutual of America"). They may change their investment options at any time.

Plan Loans

Participants may borrow against their Mutual of America or Voya Retirement Insurance and Annuity Company ("Voya") account balances. The maximum loan term is five years, or longer for the purchase of a principal residence. The minimum amount is \$1,000 while the maximum amount is the lesser of \$50,000 or 50% of their vested employee contribution account balances. The maximum number of loans outstanding at any time is one and, for loans at Voya, only one loan request may be made within a period. The loans do not reduce the balance of participants' accounts unless the loan goes into default.

Loans from Mutual of America are secured by the balance in the participant's general account representing an amount equal to 120% of the loan balance and bear interest at a rate that is 3% higher than the general account interest rate applied to amounts held in the general account as collateral security. Loans from Voya require the participant to transfer an equal amount of the loan value from the investment options to the regular loan fund account; the interest rate is equal to Moody's Effective Interest Rate and is subject to adjustment at the annual anniversary date. As such, the quarterly payment can change yearly as a result of the changes in the interest rate.

Principal and interest are repaid directly to Mutual of America and Voya by the participant. The loans are funded by Voya and are not reflected in the Plan. Mutual of America's loans are secured within the general account. As such, the loan balances are reflected within the general account balance of the Plan.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the fair value of the participant's account balance, in equal installment payments over a fixed period of time, or an annuity for a period not exceeding life expectancy.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are used to reduce the employer contributions for the Plan year. During the year ended June 30, 2024, \$225,072 of the forfeited amounts was used to reduce the employer contributions. There was \$212 of available forfeitures at June 30, 2024.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results may differ from those estimates.

Administrative Expenses

The Plan incurs fees and administrative costs which are assessed by a third-party administrator. GCH absorbs certain costs of the Plan including professional fees. Transaction charges are paid by the participants.

Risks and Uncertainties

The Plan invests in various investment securities. Investments securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risk associated with the investment securities that changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

Subsequent Events

Management has evaluated subsequent events through April 15, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Plan Loans

The Plan custodians allow plan loans, in which participants request loans using the asset of the Plan as collateral for the loans. As of June 30, 2024, outstanding balances were \$84,467 for Mutual of America and \$3,412 for Voya loans, respectively. Interest rates were 5.85% for Mutual of America and 5.14% for Voya.

7. Plan Termination

Although it has not expressed any intent to do so, GCH has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA.

8. Tax Status

The Plan presently does not have a tax determination letter from the Internal Revenue Service (“IRS”) since 403(b) plans currently are not required to submit plans to the IRS for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Service Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
