Opinion

We have audited the accompanying financial statements of Inlandboatmen's Union of the Pacific National 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Plan is a defined contribution plan covering employees of employers signatory to a collective bargaining agreement or other special agreement who have one hour of service and have met all other eligibility provisions dictated by the Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accounts of the Plan are maintained on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also allows catch-up contributions for participants who attain age 50 before the close of the calendar year.

D. Participant Accounts

Each participant's individual account is credited with the participant's elective salary deferral contributions, allocations of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or on account balances, as defined. Participant accounts are valued on a daily basis. The benefit to which the participant is entitled is the benefit that can be provided from the participant's account.

E. Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon.

F. Payment of Benefits

Participants may elect to receive the value of their account as a lump-sum distribution or annual installments upon termination, retirement, death, or disability. The Plan also permits distributions at age 59½, or in the event of financial hardship, as defined by the Plan. Mandatory distributions greater than \$1,000 will be paid directly to an IRA. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

G. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms may not exceed five years. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest is paid ratably by participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

H. Plan Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan by letter dated June 3, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Board of Trustees believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Board of Trustees to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - FAIR VALUE MEASUREMENTS AND INCOME RECOGNITION

Financial Accounting Standards Board (FASB) Accounting Codification (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Mutual funds – valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The common/collective trust is valued based on the NAV of units (or equivalents), which is based on the values of the underlying assets, held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. Redemptions may be made on a daily basis with no restrictions. The investment is a direct filing entity with the Department of Labor. There are no unfunded commitments as of June 30, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 4 - NONEXEMPT TRANSACTIONS

During the Plan years ended June 30, 2024 and 2023, certain participating employers failed to remit employee 401(k) deferral contributions for certain payroll periods within the timeframe prescribed by the Plan Document. These are deemed prohibited transactions by the participating employers in accordance with ERISA and the IRC.

The Board of Trustees has requested the lost earnings from the contributing employers. Filing Form 5330 with the IRS and paying the appropriate excise tax is the responsibility of the employers.
