Independent Auditors' Report

To the Plan Participants and Plan Administrator
Wellstar Health System, Inc. Supplemental Retirement Savings Plan:

Opinion

We have audited the financial statements of Wellstar Health System, Inc. Supplemental Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the year ended June 30, 2024, in accordance with U.S. generally accepted accounting principles.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting



from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. (1) Description of Plan

The following description of Wellstar Health System, Inc. Supplemental Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined-contribution plan, which covers substantially all employees of Wellstar Health System, Inc. and Affiliates (the Plan Sponsor and administrator or Wellstar). Employees of Wellstar MCG Health, Inc. and Affiliates were eligible to participate in the Plan effective August 4, 2024 (see Note 8 for further detail). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. State Street Bank and Trust, Transamerica Financial Life Insurance Company, Transamerica Life Insurance Company and Lincoln National Life Insurance Company serve as the Plan's trustees and custodians.

(b) Eligibility

All employees who are employed by Wellstar are eligible to participate in the Plan unless the employee is a nonresident alien or an employee of a controlled group or affiliated service group employer that does not adopt the Plan. New employees are automatically enrolled as soon as administratively practicable after January 1, 2020, or immediately upon hire date at a 1% contribution rate and have a sixty-day window to decline enrollment.

Wellstar amended the Plan to add an automatic escalation provision to participants' elective deferral rates effective January 1, 2022. Participants' annual elective deferral percentage will be increased by 1% on January 1st of each subsequent year up to a maximum of 4%.

(c) Participant Accounts

The Plan maintains separate participant-directed investment accounts and a personal choice retirement account. These accounts consist of the participants' contributions, the Plan Sponsor's matching contributions, and the investment earnings and losses thereon.

(d) Contributions

Participants may contribute up to the lesser of the maximum yearly limit or 100% of pretax annual compensation, as defined in the Plan, and participants age 50 or older can make catch-up contributions to the Plan.

Wellstar matches 50% of the first 4% of each participants' compensation contributed by the participant to the Plan, up to a maximum of 2% of compensation. Pro re nata team members, those who work on an as needed basis, must work at least 1,000 hours in the Plan year to receive matching contributions.

Wellstar makes a transition contribution to certain qualifying employees that meet certain age and years of service requirements. The contribution will be made annually following the completion of the Plan Sponsor fiscal year. The temporary annual transition contribution is as follows:

- Age 45 with at least 10 years of vesting service in the Wellstar Health System, Inc. Supplemental Retirement Savings Plan as of November 1, 2020 will be equal to an additional 2% contribution to the Plan for up to 3 years.
- Age 55 or older with at least 20 years of vesting service in the Wellstar Health System, Inc. Supplemental Retirement Savings Plan as of November 1, 2020 will be equal to an additional 7% contribution to the Plan for up to the shorter of 10 years or upon attaining 35 years of credited service in the Plan.

Wellstar makes an employer discretionary contribution to eligible participants up to 4% of eligible compensation, whether an employee contributes to the Plan or not. No contributions will be made for a Plan year for any participant who is not an employee on the last day of the Plan year with the exception for retirement (normal retirement age) and age 55 and 10 vesting periods of service with at least of 1,000 hours during the plan year as determined under the Plan. The contribution is payable following the end of each fiscal year and is contingent on Wellstar achieving certain financial performance standards. The employer discretionary and transition contribution receivable was \$83,778,280 and \$83,154,658, at June 30, 2024 and 2023, respectively. Wellstar paid the amounts due the Plan on October 28, 2024, and October 18, 2023, respectively.

(e) Vesting

Participants are immediately vested in their contributions and net value changes thereon. Participants are cliff vested 100% in Wellstar's matching contributions, employer discretionary contributions and transition contributions after three years of service.

(f) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding loan balance in the preceding 12 months or 50% of their vested account balance. Note terms generally range from one to twenty years. The notes bear interest ranging from 4.25% to 9.50%.

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan and loan policy.

(g) Forfeited Accounts

Forfeitures of employer contributions and the earnings on those contributions resulting from participants who separate from service prior to vesting are retained in the forfeiture account. Forfeitures, as permitted by the plan document, may be used by the plan administrator toward the payment of Wellstar matching contributions thereby reducing the contributions otherwise required to be made by Wellstar or to pay administrative expenses of the Plan. The forfeiture account totaled approximately \$77,000 and \$232,000 at June 30, 2024 and 2023, respectively. Wellstar used

approximately \$3,743,000 to reduce its matching contributions to the Plan and \$660,000 to pay plan administrative expenses during the year ended June 30, 2024.

(h) Distributions

A participant is entitled to his or her vested account balance upon termination of service, death, disability, or retirement.

(i) Investment Options

Participants may direct their contributions, employer contributions, and any related earnings into various investment options, including money market funds, mutual funds, pooled separate accounts and group annuity contracts. The Plan also allows participants to invest in the Charles Schwab & Co. Personal Choice Retirement Account, which enables each participant to self-direct his or her money into a full range of investment options, including individual stocks and bonds, as well as allowing access to over 800 additional mutual funds. The underlying assets of mutual funds are invested in equity securities, debt securities, and other securities investments options.

(j) Administrative Expenses

Plan administrative expenses that are not payable by the Plan are paid by Wellstar.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in accordance with U.S. generally accepted accounting principles.

(b) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Shares of mutual funds and money market funds are valued at quoted market prices. As of June 30, 2024 and 2023, the Plan invested in the Transamerica Capital Preservation Option and the Lincoln National Life Insurance Company Fixed Asset Account (Lincoln Fund), through which the Plan owns fully benefit responsive guaranteed investment contracts. The Plan's investment is presented at contract value, rather than fair value, in the statements of net assets available for benefits. The Plan invests in the Transamerica Capital Preservation Option, which is a separate account of Transamerica Life Insurance Company, which invests in separate accounts to accumulate value for retirement income for participants. The Plan also invests in the Lincoln Life Variable Annuity Account Q (VAA), which is a separate account of Lincoln National Life Insurance Company, which invests in accounts to accumulate value for retirement income for participants. VAA assets are allocated to one or more subaccounts, according to a participant's investment choices. Each

VAA subaccount consists solely of investments in one fund. Units held in the VAA are determined to have a readily determinable fair value.

Fully benefit-responsive contracts are valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The average market yield and guaranteed minimum interest rate for the Transamerica Capital Preservation Option was 2.33% and 1.20% respectively for the year ended June 30, 2024.

As of June 30, 2024, the average market yield of the Lincoln Fund was 4.02%. The guaranteed minimum interest rate was 3.50% for the year ended June 30, 2024.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the Plan to transact at contract value with the contract issuer. Examples of such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC, (2) premature termination of the contract, (3) plan termination or merger, (4) changes to the Plan's prohibition on competing investment contracts, or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Risks and Uncertainties

The Plan invests in various investment securities as directed by participants. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk

associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

(4) Tax Status

The Plan sponsor has adopted a volume submitter 403(b) plan document. The Internal Revenue Service (IRS) has issued an opinion, dated March 31, 2017, that the form of the volume submitter document is acceptable under Section 403(b) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believes that the Plan is designed and is being operated within the applicable requirements of the IRC, and, as such, is exempt from federal income taxes.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Fair Value Measurements

In accordance with Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of inputs used in related valuation techniques, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

When available, the Plan generally uses quoted market prices to determine fair value and classifies such items as Level 1. The Plan does not consider any of its investment holdings to be Level 2 or Level 3 securities.

(7) Related-Party and Party-in-Interest Transactions

The Plan Sponsor, administrator, trustees, and custodians described in Note 1 are each a party-in-interest to the Plan as defined by ERISA. Certain investments are managed by the trustee and therefore these transactions qualify as party-in-interest transactions.

(8) Subsequent Events

Effective August 29, 2023, Wellstar and AU Health System, Inc., a Georgia nonprofit corporation (AUHS), executed their affiliation (the Transaction) pursuant to a Membership Substitution Agreement. As a result of the Transaction, Wellstar became the sole corporate member of AUHS. AUHS changed its corporate legal name to Wellstar MCG Health, Inc. (WMCG), and the health system operated by AUHS became a part of the health system operated by Wellstar. By virtue of Wellstar becoming the sole corporate member of WMCG, Wellstar became the ultimate parent corporation of WMCG and its affiliates. The employees of WMCG and its affiliate entities became eligible to participate in the Plan effective August 4, 2024. Effective January 1, 2025, the assets of the WMCG Plan (AU Health System, Inc. 403(b) Retirement Savings Plan) were merged into the Plan.

Effective December 6, 2024, as a result of the aforementioned merger into the Plan, the Transamerica Capital Preservation Option investment was replaced with the Transamerica Guaranteed Investment Option.

The Plan has evaluated events subsequent to June 30, 2024 and through April 15, 2025, the date on which the financial statements were available to be issued and determined there were no other items to disclose.
