### **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Public Health Management Corporation Employees' Money Purchase Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **[1] General:**

The Plan is a defined-contribution money purchase pension plan covering substantially all employees of Public Health Management Corporation, Interim House, Inc., National Nursing Centers Consortium, and Health Promotion Council (collectively referred to as the "Company" or "Employer"). Employees must complete a year of service before entering the Plan. The Plan also covers employees who become permanently disabled or terminate employment during the fiscal year, provided that a contribution was made for the participant in the preceding Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Vanguard Fiduciary Trust Company ("Vanguard") is the custodian and trustee of the Plan, and The Vanguard Group, Inc. maintains the participant records and provide other administrative services to the Plan.

#### **[2] Contributions:**

Effective July 1, 2006, the amount of the Employer contribution for each eligible person who was hired on or after July 1, 2006 and who has not completed five years of vesting service shall be equal to 6% of the participant's compensation. The amount of the Employer contribution for each eligible person hired prior to July 1, 2006 shall be equal to 9% of the participant's compensation. A participant receiving a contribution of 6% is eligible to receive a contribution of 9% after completing five years of vesting service. In addition, the Employer shall make an Employer contribution of 5% of annual compensation in excess of the integration level as of the last day of the Plan year, as defined in the Plan document.

There are no employee elective deferral contributions allowed by the Plan. Participants may contribute amounts representing distributions from other qualified defined-benefit or contribution plans.

#### **[3] Participant accounts:**

Participants are provided with a selection of securities of various registered investment companies and a stable value asset fund in which to invest contributions. Each participant's account is credited or charged with an allocation of (1) the Company's contributions, (2) the Plan's earnings and losses, and (3) administrative expenses. Allocations are based upon a participant's earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**[4] Vesting:**

Participant vesting is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 and over	100%

A participant is 100% vested upon (1) reaching retirement age, (2) becoming disabled, or (3) the completion of five or more years of credited service.

**[5] Notes receivable from participants:**

The Plan does not provide for loans to participants.

**[6] Payment of benefits:**

Upon termination of service, a participant may receive either a lump-sum amount equal to the value of his or her vested account; a qualified annuity, with installments payable over a period of time which shall not exceed the life expectancy of the participant and a surviving spouse; or other alternative modes of payment permitted by law.

The Plan administrator may elect to authorize an automatic lump-sum distribution for terminated participants whose vested account balances are less than \$5,000. Distribution of a terminated participant's vested account balance will occur as soon as administratively practicable after termination of employment.

**[7] Forfeitures:**

Forfeited nonvested accounts are used to reduce future contributions by the Company and pay Plan expenses. During the year ended June 30, 2024, forfeitures of approximately \$400,000 were used to reduce Employer contributions. As of June 30, 2024 and 2023, forfeited nonvested accounts totaled approximately \$461,000 and \$433,000, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**[1] Basis of accounting:**

The accompanying financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**[2] Use of estimates:**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements, and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**[3] Investment valuation and income recognition:**

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**[4] Plan expenses:**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

**[5] Benefit payments:**

Benefits are recorded when paid.

### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and related activity in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended June 30, 2024, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

### NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term; the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of June 30, 2024 or 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

**NOTE E - CONTRACT WITH INSURANCE COMPANY**

**Group annuity contract:**

The Plan has a Group Annuity Contract with Standard Insurance Company ("Standard") related to Standard's Stable Asset II Fund, which is a benefit-responsive investment contract. Standard maintains the contributions in an unallocated fund, whose assets are invested with other assets in the general account of Standard. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest account contract issuer is contractually obligated to repay the principal, as well as interest, at a specified rate that is guaranteed to the Plan.

As described in Note B, because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Standard, represents contributions made under the account, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. As of June 30, 2024 and 2023, contract value of the guaranteed interest contract was \$3,192,039 and \$3,420,241, respectively.

#### **NOTE E - CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

##### **Group annuity contract: (continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based upon a formula agreed upon with the issuer, and is established on the first day of each quarter but may not be less than 1%. At the end of each guarantee period, contributions and interest earned from the account may be invested into any of the Plan's investment options; however, if written instructions specifying the participant's choice of investment option are not received at least 30 days before the maturity date, the contributions and interest earned will automatically be reinvested in a guaranteed account of the same term at the current rate.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, and
- (4) the failure of the trust to qualify for exemption under ERISA.

The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. If the issuer believes the Plan is not abiding by state and federal law;
2. If the Plan has not rendered the performance necessary to comply with the terms of the contract;
3. If the balance in all the Plan's investment funds falls below \$250,000;
4. If the Internal Revenue Service disqualifies the Plan; or
5. If the Plan has not adopted within a reasonable period of time.

#### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are shares of registered investment companies managed by Vanguard. The Plan paid certain expenses related to Plan operation and investment activity to various service providers. These transactions are party-in-interest transactions. Fees paid by the Plan were \$139,864 for the year ended June 30, 2024.

Vanguard provides certain administrative services to the Plan and receives revenue from mutual fund providers for services Vanguard provides to the funds. This revenue is used to offset certain amounts owed to Vanguard for its administrative services to the Plan. If the revenue received by Vanguard from such mutual fund service providers exceeds the amounts owed, Vanguard remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During the year ended June 30, 2024, \$22,500 was used to pay Plan expenses.

### **NOTE G - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated October 5, 2012 that the Plan was qualified under the Internal Revenue Code ("IRC") and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the tax determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of the investments as of June 30, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

### **NOTE J - REGISTERED INVESTMENT COMPANY FEES**

Certain investments in registered investment companies are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

### **NOTE K - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through April 15, 2025, which is the date the financial statements were available to be issued.
