### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Northwest Metal Crafts Trust Fund (the “Plan”) is a multiemployer health and welfare plan established on May 27, 1952 to provide benefits to eligible union members under collective bargaining agreements with contributing employers. The Plan is subject to provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

**A. Administration**

The Board of Trustees (the “Board”) is the Plan sponsor and Plan administrator. The Board established a trust (the “Trust”) to receive employer contributions and maintain assets of the Plan for provision of benefits, and entered into an Administrative Service Agreement with a third-party administrator to process claims and pay benefits in accordance with terms of the Plan. The Board appointed an investment manager to provide professional investment management services and delegated to the investment manager responsibility for managing investments subject to the Plan’s investment policy and Board approval. Costs of administering the Plan are paid by the Plan.

**B. Funding and Eligibility**

Active employees whose employers contribute on their behalf may participate in the Plan. Hours reported by contributing employers are credited to a participant’s “hour bank.” Initial medical benefits eligibility begins on the first day of the second calendar month following the month in which a participant’s hour bank reaches 160. During the first month of coverage, 160 hours are deducted from a participant’s hour bank, and each subsequent month of coverage 140 hours are deducted. Coverage continues for each month that a participant maintains a minimum of 140 hours in his or her hour bank. Dental benefits eligibility is provided under dental hour bank provisions set forth in the Plan. A full-time employee of a participating employer who is not covered under collective bargaining may be eligible for the Plan provided such employee is enrolled and the employer makes contributions on his or her behalf, as determined by the Board.

Employees who do not have enough hours to maintain eligibility have the option to continue coverage under self-pay provisions of the Plan. Employees who are covered under the Plan preceding retirement and satisfy certain age and service requirements as defined in the Plan may qualify for retiree benefits. Retirees self-pay a portion of the cost of benefits. The Board determines monthly contribution rates and adjusts rates as necessary based on the costs of providing Plan benefits.

**C. Benefits**

The Plan provides medical, dental, prescription drug, vision, time loss, life, disability and accidental death and disability benefits for eligible members and their dependents. Benefits are paid by the Plan except for life, disability and accidental death and dismemberment and disability benefits which are fully insured under contracts with an insurance company. The Plan maintains a stop loss insurance contract to limit its exposure to individual claims exceeding a specific dollar limit. Medical benefits for Medicare eligible retirees are provided under a fully insured plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting and Estimates**

The financial statements of the Plan are prepared on the accrual basis of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**B. Cash and Cash Equivalents**

The Plan considers all highly liquid debt instruments purchased with an original maturity of three months or less to be cash equivalents. Bank deposits may at times exceed the federally insured limit of \$250,000 per bank.

**C. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income and investment expense are reported on an accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 - CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The actuarial present value of postretirement benefit obligations is calculated based on certain assumptions pertaining to interest rates, participant demographics, healthcare inflation rates and other assumptions which are subject to change. Due to uncertainties inherent in the assumption and estimation process it is at least reasonably possible that changes in assumptions and estimations in the near term would be material to the financial statements.

Three employers accounted for approximately 60% and 68% of employer contributions during the years ended June 30, 2024 and 2023, respectively. Contributions receivable from these three employers accounted for approximately 63% and 65% in 2024 and 2023, respectively.

Plan investments are exposed to various risks, such as interest rate, market fluctuations and credit risk. Due to the risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is at least reasonably possible that changes in risk in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated

by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimate of assumptions that market participants would use in pricing the asset or liability.

The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. It is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded. Government debt securities are valued using pricing models maximizing the use of observable inputs for similar securities. The following tables summarize the Plan's investments based on the inputs used to value them at June 30:

**NOTE 6 - BENEFIT OBLIGATIONS OTHER THAN POSTRETIREMENT BENEFIT OBLIGATIONS**

**A. Claims Incurred But Not Reported**

Plan obligations at June 30 for claims incurred but not reported at that date are estimated by the Plan's consultant. Such estimated amounts are included in the accompanying financial statements at undiscounted costs and totaled \$1,414,000 and \$1,133,000 at June 30, 2024 and 2023, respectively.

**B. Lag Months**

In order to properly match the eligibility earned for hours worked in the last two months of the fiscal year to the estimated benefit costs incurred by the Plan in the subsequent two month period, a liability is estimated based on the average monthly cost of coverage for active members. The estimated lag month liability was approximately \$812,000 and \$791,000 at June 30, 2024 and 2023, respectively.

**C. Hour Bank**

Active members must work a minimum of 140 hours per month in covered employment to maintain eligibility for benefits. Hours worked in excess of 140 hours per month are accumulated in an hour bank up to a maximum accumulation of 420 hours. Continuation of benefits under the hour bank provision is available to participants during months they do not meet the minimum 140 hour service requirement. The estimated liability for benefit continuation is based on participants' bank hours accumulated at year end and an estimate of the monthly cost of coverage calculated by the Plan's consultant. The estimated hour bank liability is \$2,150,000 and \$2,196,000 at June 30, 2024 and 2023, respectively.

**NOTE 7 - POSTRETIREMENT BENEFIT OBLIGATIONS**

The postretirement benefit obligation represents the actuarial present value of projected payments attributable under the Plan's provisions to the service members rendered up to the valuation date, reduced by the actuarial present value of employer contributions expected to be received on behalf of active participants in future years and retiree self-pays. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents, (2) active employees who are fully eligible for benefits and (3) participants who are not yet fully eligible for benefits. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the amount attributable to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation was determined by Healthcare Actuaries and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money through discounts for interest and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following significant assumptions are used in the valuation as of June 30, 2024 (2023):

Weighted-Average Discount Rate:	5.28% (4.91%)
Medical Inflation Rate:	6.80% (6.00%) pre-Medicare and 4.90% (5.40%) Medicare; both grading to an ultimate rate of 4.04%

The increase in the weighted-average discount rate from 4.91% to 5.28% and changes to the medical inflation rate for pre-medicare assumptions decreased the postretirement benefit obligations by \$170,000.

The weighted-average health care cost-trend rate assumption has a significant effect on amounts reported in the accompanying financial statements. If the assumed rate increased by one percentage point in each year, it would increase the obligation as of June 30, 2024 and 2023 by \$467,000 and \$3,967,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

The Plan collects the contributions for itself and the Puget Sound Employers-Boilermakers Apprenticeship and Training Trust (the "Training Trust"). The amount owed to the Training Trust was \$27,892 and \$20,822 in 2024 and 2023, respectively.

**NOTE 9 - INCOME TAX STATUS**

The Trust established under the Plan is intended to qualify for tax exempt status pertaining to Section 501(c)(9) of the Internal Revenue Code (the "Code"). The Plan administrator and Plan legal counsel believe the Plan is designed and operated in compliance with Code requirements, and the trust qualifies for exemption from federal income tax.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 - TRUST TERMINATION**

Upon termination of the Plan, any and all monies remaining in the Plan, after the payment of all expenses, shall be paid out in accordance with the Trust Agreement to the persons entitled thereto, until such monies have been exhausted. The Board of Trustees is authorized and empowered to withdraw or transfer or cause to be withdrawn or transferred all monies in the administrative account of the Plan or any portions of such monies, as in its absolute discretion it determines to be necessary or desirable to accomplish the purpose of the Plan.


