Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the I.B.E.W. Local 191 Health and Welfare Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents, summaries and related information for a more complete description of the Plan’s provisions.

A. General

The Plan was established in March 1954 to provide health and welfare benefits to eligible employees and their dependents pursuant to collective bargaining between Local 191 of the International Brotherhood of Electrical Workers (the “Union”) and the Cascade Chapter of the National Electrical Contractors Association of employers signatory to a collective bargaining agreement or special agreement requiring contributions to the Trust. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the Internal Revenue Code (the “Code”).

B. Administration

The Plan is administrated by a Board of Trustees (the “Board”). The Board established a trust (the “Trust”) to receive contributions and maintain assets of the Plan for provision of benefits, and designated a third-party administrator to maintain participant records and carry out a majority of tasks associated with day-to-day Plan administration. The Board appointed investment managers to provide professional investment management services for the Trust and delegated to the investment managers responsibility for managing investments subject to the Plan’s Investment Policy and Board approval. The Board has authority to determine benefits that are provided by the Plan and the conditions under which they are provided, and to change benefit programs at its discretion.

C. Eligibility and Funding

Employees of employers who are signatory to a collective bargaining agreement with the Union are eligible for the Plan. Under special agreements subject to approval of the Board, employers may cover non-bargaining unit employees. Participating employers make contributions on behalf of covered employees for hours worked in covered employment during the year in accordance with applicable collective bargaining or special agreements.

Hours reported by contributing employers are credited to a participant’s dollar bank. To establish initial eligibility for benefits, a participant must accumulate contributions in his or her dollar bank sufficient to pay for two months of coverage under the medical plan chosen. A participant remains qualified and eligible so long as his or her dollar bank maintains an amount sufficient to provide coverage for at least one month. If a dollar bank does not have an amount sufficient to pay for a month of coverage, no deduction is made and no coverage is provided. A participant with insufficient funds in his or her dollar bank may be able to continue coverage pursuant to the Plan’s COBRA self-pay provisions.

The Trust provides subsidized retiree medical, prescription drug, dental and vision benefits to eligible retirees. A participant must be covered under the Plan preceding retirement and meet certain age and service requirements as defined in the Plan to be eligible for retiree benefits. Retirees self-pay a share of the cost of benefits.

D. Benefits

The Plan provides participants and their eligible dependents with medical, prescription drug, dental, vision, time loss, maternity, life, accidental death and dismemberment, hearing aid, member assistance and personal care account benefits.

E. Personal Care Accounts

Employers contribute \$0.50 per hour to a personal care account ("PCA") maintained for each participant under the Plan. Effective July 1, 2019, the Trust provides a \$0.25 per hour match to the PCA. Benefits are available for use once the account has reached \$250. PCA funds are used to pay eligible out-of-pocket medical or dental expenses that are not covered under the Plan or any other benefit plan, but cannot be used to pay any expense deductible by the participant under the Code. A PCA account balance at the end of a Plan year carries over to the subsequent Plan year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Risks and Uncertainties

Plan investments are subject to risk factors including interest rate, market, credit, liquidity and industry risks that could have a material effect on the ultimate realizable value of investments. Due to the level of risk associated with investments, it is at least reasonably possible that changes in values of investments will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Cash consists of deposits in bank checking accounts held by an institution the Board believes is credit worthy. Deposits may at times exceed the federally insured limit of \$250,000 per bank.

The estimates for claims incurred but not reported, lag months and postretirement benefit obligations are based on certain assumptions pertaining to interest rates, health care trend inflation and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

D. Investment Valuation and Income Recognition

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are

observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds and the money market fund held by the Plan are registered with the Securities and Exchange Commission, required to publish a daily net asset value, and transact at that price. Mutual funds and the money market fund are deemed to be actively traded.

B – 5 business days prior to the last calendar day of the month (and as of each Special Mid-Month Redemption Date) as defined in the Confidential Private Offering Memorandum and subject to an additional expense.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Board may terminate the Plan at any time. In the event of termination, the Board will allocate all assets remaining in the Trust in a manner consistent with ERISA and the provisions of the Plan. No assets remaining in the Trust after payment of Plan obligations will be distributed to or recoverable by an employer or the Union.

NOTE 5 - INCOME TAXES

The Plan received tax-exempt status from the federal government under Code Section 501(c)(9). The Board believes the Plan is designed and operated in compliance with applicable regulations. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - BENEFIT PAYMENTS

Participants and their dependents may choose to receive medical benefits from the Plan's self-funded medical plans administered by Regence Blue Shield or an insured HMO plan from Kaiser that includes prescription drug benefits. Prescription drug benefits administered by Regence in the self-funded medical plans are provided by Sav-Rx Prescription. Participants may choose between the Trust's self-funded dental plan or an alternative plan through Willamette Dental. Vision benefits are self-funded and administered by Vision Service Plan. Life and accidental death and dismemberment benefits are insured by The Union Labor Life Insurance Company. Hearing and time loss benefits are self-funded. Member assistance benefits are administered by First Choice Health.

NOTE 7 - OBLIGATIONS FOR CURRENT BENEFITS

A. Claims Incurred but Not Reported

Plan obligations for claims incurred but not reported as of the end of the Plan year are estimated based on prior claims experience and claims reported after the end of the year which pertain to claims incurred prior to such date.

B. Dollar Bank

The Plan is required to provide benefits to participants if they have accumulated, in current or prior years, credit amounts in excess of the amount required for current coverage. Effective with November 2022 hours worked, the maximum amount accumulated by a participant increased to from \$15,000 to \$16,000. Credits earned in excess of the dollar bank limit are forfeited. The estimated hour bank liability was approximately \$17,300,000 and \$15,600,000 at June 30, 2024 and 2023 respectively.

C. Accumulated Eligibility - Lag Months

In order to properly match the eligibility earned for hours worked in the last months of the fiscal year to the estimated benefit costs of eligibility to be incurred by the Plan in the subsequent year, a liability is recognized that is based on the monthly cost of coverage for active members. The estimated lag month liability was approximately \$6,300,000 and \$5,300,000 at June 30, 2024 and 2023, respectively.

NOTE 8 - POSTRETIREMENT BENEFIT OBLIGATIONS

The postretirement benefit obligation represents the actuarial present value of projected claims and expenses under terms of the Plan for employees' service rendered to the financial statement date, reduced by the actuarial present value of employer contributions expected to be received on behalf of active participants in future years and retiree self-pays. Postretirement benefits include future benefits expected to be paid to or for (1) current retirees and their beneficiaries and covered dependents and (2) active participants and vested terminees who are fully eligible for benefits and (3) participants who are not yet fully eligible for benefits. The postretirement benefit obligation represents the amount that is to be funded by contributions from participating employers and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money through discounts for interest and the probability of payment by means of decrements such as those for death, disability, withdrawal or retirement between the valuation date and the expected date of payment.

The costs of post-retirement benefits are shared by the Plan's participating employers and retirees. In addition to deductibles and copayments, retirees on average paid 5% of the estimated cost of post-retirement benefits provided by the Plan in 2024 and 2023.

The following significant assumptions were used in the valuations at June 30, 2024 (2023):

Discount Rate:	5.3% (4.9%)
Mortality:	Pri-2012 amount-weighted mortality tables projected forward using scale MP-2021 on a generational basis, with employee rates before benefit commencement, and Retiree and Contingent Survivor rates (as applicable) after benefit commencement. This represents the most current mortality experience published by the Society of Actuaries Retirement Plans Experience Committee (RPEC).
Retirement:	40% of eligible participants are assumed to elect retiree medical coverage.
Election of Coverage:	Based on July 1, 2023 rates among members, 14% are assumed to elect coverage under Kaiser, 78% under Regence PPO 80/50, and 8% under Regence PPO 90/60.
Medical Inflation Rate:	6.6% in the first year, and an ultimate rate of 3.7%.

Increasing the discount rate from 4.9% to 5.3% decreased the postretirement benefit obligations by approximately \$780,000.

The weighted-average health care cost-trend rate assumption has a significant effect on the postretirement benefit obligation. If assumed rates increased by one percentage point above these assumptions, it would increase the obligation as of June 30, 2024 and 2023 by \$1,963,000 and \$1,992,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.
