## INDEPENDENT AUDITOR'S REPORT

Idyllwild Arts Foundation DC Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Idyllwild Arts Foundation DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of March 5, 2024 and June 30, 2023, and the related statement of changes in net assets available for plan benefits for the period from July 1, 2023 to March 5, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 5, 2024 and June 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Merger**

As discussed in Note 8 to the financial statements, the Plan Sponsor elected to merge the Plan into a multi-employer Plan (MEP) operated by CALISBOA et al., an independent school group retirement plan administered by Transamerica effective March 1, 2024. All plan assets were transferred to the MEP on March 5, 2024. Our opinion has not been modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, line 4a – Schedule of Delinquent Participant Contributions, as of March 5, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 1 – PLAN DESCRIPTION

The following description of the Idyllwild Arts Foundation DC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined-contribution plan established by Idyllwild Arts Foundation (the “Plan Sponsor” or “Employer”) under the provisions of Section 403(b) of the Internal Revenue Code (IRC). The Plan was established September 1, 1986, and was amended and restated effective July 1, 2021. TIAA-CREF serves as the custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility

To be considered eligible, employees of the Plan Sponsor must have reached 18 years of age, and must hold a full-time, part time and have worked over 1,000 hours, non-seasonal or temporary, executive, administrative, operational or faculty employment position.

#### Contributions

Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan, subject to certain IRC limitations.

The total participant elective deferral contributions made to the Plan cannot exceed the limit imposed by the Internal Revenue Service (IRS). In addition, participants may make rollover contributions to the Plan from other qualified defined-benefit or defined-contribution plans. For eligible employees, the Plan Sponsor will contribute 100% of the participant’s deferrals up to 4% of the participant’s eligible compensation. For the period from July 1, 2023 to March 5, 2024, the Plan made Employer contributions of \$177,444.

#### Vesting

Participants are vested immediately in their contributions and Plan Sponsor contributions plus actual earnings thereon.

#### Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, loans, and rollovers from qualified plans of the participant’s previous employers, and allocations of the Plan’s earnings and administrative expenses. Each participant’s account is credited with the participant’s contribution and the Plan Sponsor’s matching contribution. Plan earnings are allocated based on participant account balances, as defined.

### **NOTE 1 – PLAN DESCRIPTION (Continued)**

#### Investments

Participants direct the investment of their contributions and the Plan Sponsor's contributions into various investment options offered by the Plan. Investment elections may be changed online or through telephone access with the custodian at any time.

#### Notes from Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their eligible accumulation less outstanding loans for the same plan and total non-distributable defaults for all plans, whichever is less, with a minimum of \$1,000. The notes are secured by the balance in the participant's account. As of March 5, 2024 and June 30, 2023, notes bear interest rates ranging from 8.00% to 8.75% with maturity dates through March 2025. Principal and interest are paid ratably through payroll deductions. Note terms are specified for each note, but cannot exceed a term of five years, unless the note is used to purchase a principal residence. A participant may have three notes outstanding at any time. For notes from participants that are not considered Plan assets, see Note 9.

#### Benefit Payments

Upon termination with the Plan Sponsor, a participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account, installment payments, hardship, or annuity. In the event of death or total and permanent disability, a participant or the participant's beneficiary is entitled to the total value of the participant's account.

#### Financial Hardship Distributions

Hardship withdrawals are also permitted if certain criteria are met. The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

#### Administrative Expenses

Certain expenses associated with the administration of the Plan, including custodian fees, audit fees, and the cost of communication with participants are paid by the Plan Sponsor.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Except for certain contracts held by TIAA-CREF described in Note 5, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investment contracts are reported at contract value on the statements of net assets available for plan benefits. Contract value is the relevant measure for that portion of the net assets available for plan benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain management fees and operating expenses charged to the Plan for investments in pooled separate accounts and registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### Notes from Participants

Notes from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. As of March 5, 2024 and June 30, 2023, there were no delinquent notes from participants. No allowance for credit losses has been recorded as of March 5, 2024 and June 30, 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of monitoring the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable are charged directly to the participant's account and are included in administrative expenses.

### **NOTE 3 – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN**

The Plan’s management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA-CREF, the custodian of the Plan, has certified the completeness and accuracy of all investments and notes from participants reflected on the accompanying statements of net assets available for plan benefits as of March 5, 2024 and June 30, 2023; the related investment activity and interest income on notes from participants reflected in the statement of changes in net assets available for plan benefits for the period from July 1, 2023 to March 5, 2024.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used as of March 5, 2024 and June 30, 2023.

*Registered investment companies:*

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:*

Valued at the NAV of shares/units held by the Plan at year end. The NAV practical expedient is based on the fair value of the underlying assets owned by the pooled separate account, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a pooled separate account is calculated based on a compilation of primary observable market information. The pooled separate account has a daily redemption frequency, no redemption period or restrictions and has no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan held units of a stable value fund that has investments in investment contracts and also has a fixed annuity investment contract with an insurance company, TIAA-CREF (TIAA Traditional Annuity). Contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

The portfolio is valued daily and the investment contract, including synthetic investment contracts and their underlying securities, are valued at contract value. These investments provide benefit responsive withdrawals and investment exchanges at contract value; however, withdrawals or investment exchanges prompted by a Plan Sponsor-initiated event may be paid at the contract’s market value, which may be less than contract value, or may be subject to a contract charge or penalty. The contract’s rate of return is typically reset on a quarterly basis. For this fund, there are no unfunded commitments, unit shares can be redeemed daily, and a redemption notice period may be enforced by TIAA at its discretion.

Investments in the stable value fund accrue interest at the applicable monthly crediting rate, which rate will be set based upon a formula but may be adjusted from time to time. The actual market value of the underlying assets may, at times, be greater than or less than the book value of the stable value fund. Any differences between the market value and book value will be taken into consideration when setting future crediting rates.

Certain events limit the ability of the Plan to transact at contract value with TIAA: (1) termination of the Plan; (2) a material adverse change to the provisions of the Plan; (3) the Sponsor elects to withdraw from a wrapper contract in order to switch to a different investment provider; (4) or if the terms of a successor plan do not meet the wrapper contract issuer’s underwriting criteria for issuance of a clone wrapper contract. The Plan Administrator believes the occurrence of such events that would also limit the Plan’s ability to transact at contract value with the Plan’s participants is not probable.

### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA-CREF. TIAA-CREF is the custodian and, therefore, these transactions qualify as party-in-interest transactions permitted by the DOL Rules and Regulations. The Plan Sponsor and Plan Administrator are also a party-in-interest with respect to the Plan. Notes from participants and the related interest income of \$2,916 are considered related party transactions.

### **NOTE 7 – INTERNAL REVENUE SERVICE STATUS**

The Plan is intended to comply with the applicable requirements of Section 403(b) of the IRC, as amended. A tax determination letter program is not yet available for IRC Section 403(b) plans through the IRS. The Plan Administrator believes the Plan is currently designed and operated in compliance with applicable requirements of the IRC and, as such, is exempt from federal income taxes. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan's management will make any changes deemed necessary to ensure the Plan maintains its tax-exempt status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that, as of March 5, 2024 and June 30, 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 8 – PLAN MERGER**

On September 15, 2023, the Plan Sponsor, with approval of the Audit Committee, voted to merge the Plan to a multi-employer Plan operated by CALISBOA et al., an independent school group retirement plan administered by Transamerica. As of March 5, 2024, total assets transferred to the new plan amounted to \$6,550,151 in cash and \$10,744,111 of assets legally transferred as they were unable to be liquidated per the investment types for a total of \$17,324,262, which included outstanding participant loans of \$109,930. The merger does not impact participant benefits as the benefit provisions were incorporated in the CALISBOA plan.

### **NOTE 9 – PLAN LOANS**

Prior to July 1, 2020, participants were permitted to borrow a portion of their Plan account as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 50% of their eligible accumulation less outstanding loans for the same plan and total non-distributable defaults for all plans. Participants borrow from their own accumulation and pay themselves back through payroll deductions. The loans bear interest at rates that range from 4.00% to 4.45%. Principal and interest is paid monthly or quarterly directly to the custodian.

The Plan Administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions. The balances as of March 5, 2024 and June 30, 2023 were \$0 and \$52,116, respectively. Under the borrowing terms, 110% of the requested loan amount serves as collateral to these loans. For the years ended March 5, 2024 and June 30, 2023, \$0 and \$57,327 of Plan assets serve as collateral to these loans, respectively. Interest paid by participants on such loans during the Plan year ended March 5, 2024 was \$1,483.

In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. Foreclosure in the participant's account balance in an annuity will not occur until a distributable event such as retirement, termination or death occurs. There were \$0 and \$2,092 loans in default as of March 5, 2024 and June 30, 2023, respectively. Such amounts would include the principal and accumulated interest.

### **NOTE 10 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Two non-benefit-responsive insurance annuity contracts, one fully benefit-responsive insurance annuity contract, and one registered investment company held over 40% of the Plan's investments at June 30, 2023. As such, this is considered to be a concentration of credit risk.

### **NOTE 10 – RISKS AND UNCERTAINTIES (Continued)**

Generally accepted accounting principles require the financial statements to present the fair value of investments. The TIAA Traditional Annuity contract has been presented at contract value, which approximates fair value, as reported to the Plan by TIAA. This determination is based on TIAA's credit rating and yield during 2024 and 2023 being comparable to similar alternative investments and the interest rate which resets annually being comparable to a ten-year treasury bond. In subsequent periods, if market conditions change, such as the insurance company credit rating or interest rate environment, the difference between contract value and fair value could become significant causing the financial statements to become materially misstated.

### **NOTE 11 – PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate participant contributions from its general assets and remit them to the Plan as soon as administratively feasible.

During the Plan year ended June 30, 2021, the Plan Sponsor inadvertently failed to remit certain participant contributions totaling \$16,683 within the required timeframe as stated by the DOL. The Plan Sponsor has elected to pay lost earnings and excise tax payments on the late deferrals outside of the DOL's Voluntary Fiduciary Correction Program in 2024 for the 2021 plan year-end.

### **NOTE 12 – SUBSEQUENT EVENTS**

The Plan Administrator has evaluated all activity through April 15, 2025, the date the financial statements were available to be issued.


