Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dean Vistnes MD Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dean Vistnes MD Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023, and for the period ended October 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Dean Vistnes MD Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Dean Vistnes MD Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Dean Vistnes MD Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

As further discussed in Note 1, the Plan was merged into SkinSpirit Essential 401(k) Plan effective August 1, 2024. Our opinion is not modified with respect to this matter.

Dean Vistnes MD Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Dean Vistnes MD Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was a defined contribution plan adopted on October 1, 2005, and subsequently restated effective January 1, 2016, covering substantially all employees of Dean Vistnes MD Inc., and participating employers, Dean Vistnes MD Texas and Dean Vistnes MD New York, PC (collectively, the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective August 1, 2024, the Plan was merged with the SkinSpirit Essential 401(k) Plan and all participant accounts within the Plan transferred on August 7, 2024. Residual assets were merged with SkinSpirit Essential 401(k) Plan through October 2024.

Eligibility – Employees of the Company were eligible to participate in the Plan following two months of service with the Company and attaining 18 years of age. Eligible employees were entered into the Plan on the first day of the month following meeting eligibility requirements.

Contributions

Participant contributions – Each year, participants could contribute up to 100% of pretax eligible compensation, as defined in the Plan. Participants could also elect to make Roth contributions utilizing after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan had an auto-enrollment feature whereby the Company automatically deducted 3% on behalf of employees who had met the eligibility requirements, unless the participant declined or elected an alternate deferral amount. The Plan also had an annual escalation of 1% each plan year up to 5% for employees who were auto-enrolled, effective January 1, 2024.

Employer safe harbor match – The Plan provided for a basic safe harbor matching contribution equal to 100% of the first 3% of compensation, plus 50% of compensation over 3% but not in excess of 5%. The safe harbor matching contribution amounted to \$891,160 for the period ended October 31, 2024.

Employer match and profit sharing contributions – The Company could elect to make a discretionary matching and profit sharing contribution. There were no employer matching or profit sharing contributions during the Plan period ended October 31, 2024.

Contributions were subject to regulatory limits.

Participant accounts – Each participant's account was credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings. Participant accounts were charged with participant distributions and an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting – Participants were vested immediately in their contributions plus actual earnings thereon. Employer safe harbor matching contributions, as well as earnings thereon, were 100% vested immediately. Participants vested in the Company’s matching and profit sharing contributions based on the following schedule:

Payment of benefits – Upon termination of service, death, disability, or retirement, a participant could elect to receive a lump-sum distribution equal to all or a portion of the participant's vested interest in his or her account. In the case of severance of employment, the vested account balance could be distributed as soon as administratively feasible, as defined in the Plan document. Terminated employees with account balances of less than \$5,000 were automatically distributed by the Company.

Notes receivable from participants – Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant’s account. All loans had to be repaid within a period of five years unless the loan was used to purchase a principal residence, in which case, the loan could be repaid within a reasonable period of time not to exceed fifteen years. Under the terms of the Plan Agreement, Plan loans would bear interest at 1% above the prime rate. Principal and interest were paid ratably through payroll deductions. As of December 31, 2023, the rates of interest on outstanding loans ranged from 4.25% to 9.25%, with various maturities through November 2028. As of October 31, 2024, all outstanding loans were transferred to the SkinSpirit Essential 401(k) Plan.

Forfeitures – Forfeitures were the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures were retained in the Plan, could be used before year end, and were used to reduce future employer contributions. As of October 31, 2024, there were no forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP). Under this method of accounting, contributions and investment income are recorded when earned, and expenses are recorded when incurred.

Use of estimates – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation – The Plan’s investments are reported at fair value. The Plan’s trustee, Fidelity Personal Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants’ accounts and administrative Plan fees. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through February 19, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at October 31, 2024 and 2023.

Collective trusts – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. Unit purchases and redemptions are transacted at the NAV of the CTs which is determined at the close of each business day.

Registered investment companies and interest-bearing cash – Shares of registered investment companies and interest-bearing cash (money market funds) are valued based on the quoted market prices that are available on an active market. These are priced daily.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on November 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Plan investments are held by Fidelity Personal Trust Company, the trustee of the Plan; therefore, such transactions with this entity qualify as exempt party-in-interest transactions.

Note 7 – Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Personal Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, except for interest-bearing cash.
- Net appreciation in fair value of investments and dividends reflected on the accompanying statement of changes in net assets available for the period ended October 31, 2024.
