## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed an audit of the accompanying financial statements of WES Health System 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of WES Health System 403(b) Plan (the "Plan")'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In my opinion, based on my audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of WES Health System 403(b) Plan (the "Plan") and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audit. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about WES Health System 403(b) Plan (the "Plan")'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

### NOTE A – DESCRIPTION OF THE PLAN

The following description of the WES Health System 403(b) Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which is available from the Plan sponsor.

#### Organization

WES Corporation, operating as WES Health System (the "Company"), was organized on May 19, 2000. WES Health Centers, Inc., doing business as Dr. Warren E. Smith Health Centers ("WES Health" or "WES"), was organized under the Nonprofit Corporation Law of the Commonwealth of Pennsylvania. WES Health provides behavioral health, intellectual disability, and substance abuse services to the residents of Philadelphia, Pennsylvania. During fiscal year 2002, WES Health was reorganized and became a wholly owned subsidiary of the Company. The Company is also the parent company of the following wholly owned subsidiaries:

WES Horizons—A not-for-profit entity that was organized to administer children's programs (formerly administered under WES Health).

WES Ventures—A for-profit entity engaged in commercial health activities for members of managed-care organizations and private insurers.

WES Management Services—A for-profit entity that services all of the aforementioned entities with management expertise and oversight.

WES Community Health Services—A not-for-profit entity that was organized to administer health and human services programs for Illinois residents.

Lindley Apartments GP, LLC—A for-profit limited liability company that is the general partner for Lindley Apartments, LP, a limited partnership formed to develop, construct, maintain and operate a 48-unit, low-income housing tax credit project known as Lindley Court; and

Pinnacle Enterprises, LLC—A for-profit limited liability company formed to develop real estate for the Company and is the developer for the Lindley Court project.

WES Corporation, WES Health, WES Horizons, and WES Community Health Services participate in the Plan. All other entities participate in a separate, Company-sponsored 401(k) plan.

#### General

The Plan, a defined contribution 403(b) savings plan sponsored by the Company, was established on August 1, 2004, and restated effective September 7, 2017, covering all eligible employees who are 18 years or older and have completed either one year or 1,000 hours of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

### NOTE A - DESCRIPTION OF THE PLAN *(continued)*

#### Contributions

Participants may contribute a portion of their annual eligible compensation as a pre-tax deferral, up to the maximum allowed by the Internal Revenue Code ("IRC"), as defined in the Plan. The Plan also allows participants to make after-tax Roth contributions subject to certain limitations determined by the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants aged 50 or older, who are contributing to the Plan, are allowed to make catch-up contributions, as defined in the Plan.

The Company provides a discretionary match to participants of the Plan. Participants are eligible to receive the discretionary match if they have actively contributed to the Plan during the Plan year, are an employee as of June 30 and have completed either one year or 1,000 hours of service during the Plan year.

The Plan offers 29 mutual funds and one investment contract for participants to direct their investment of all contributions, which may be changed at any time.

#### Participant accounts

Each participant's account is credited with their contributions, the Company's matching contributions, and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

A participant's deferred contributions plus actual earnings thereon are 100% vested immediately.

Participants are vested in matching contributions plus actual earnings thereon based on the following schedule:

Less than 1 year	0%
At least 1 year, but less than 2	25%
At least 2 years, but less than 3	50%
At least 3 years, but less than 4	75%
4 years or more	100%

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The maximum term of a note for general purpose may not exceed five years, however, if the loan is used for the purchase of a primary residence, the maximum term may not exceed 30 years.

### NOTE A - DESCRIPTION OF THE PLAN *(continued)*

#### Payment of benefits

Upon separation from service with the Company or its wholly-owned subsidiaries because of death, disability, retirement or termination, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum payment or a direct rollover. Participants may also choose to receive instalments or defer receiving payments until age 70<sup>1</sup>/<sub>2</sub>. A participant whose vested account balance is \$5,000 or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution equal to their vested account balance.

#### Hardship distributions

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service ("IRS") and a participant must exhaust all available loan options and available distributions prior to making the request.

#### Rollover

A participant can rollover part or all of an eligible distribution received from an eligible retirement plan into the Plan. Rollover contributions are subject to the Plan's terms and will be fully vested and nonforfeitable.

#### Forfeited accounts

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated if previously distributed amounts were repaid. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. At June 30, 2024, forfeited nonvested accounts totaled \$1,923. As of June 30, 2024, there was nothing used to reduce the Company's contribution.

#### Basis of accounting

The accompanying financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment contracts are required to be reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

#### Investment valuation and income recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

### NOTE D - FAIR VALUE MEASUREMENT

U.S. GAAP defines fair value and established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs based on the Plan's assessment of the assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value which is included in the fair value hierarchy. There have been no changes in the methodology used at June 30, 2024.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE E - GUARANTEED INVESTMENT CONTRACT

The Plan invests in a fully benefit-responsive guaranteed investment contract issued by Principal Life Insurance Company (the "issuer") totaling \$194,829 for the year ended June 30, 2024. The issuer maintains the contributions in a general account. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses.

The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The methodology for calculating the interest crediting rate is defined by the contract under the term, "Composite Crediting Rate." Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The annuity contract is a single group annuity contract with a fixed interest rate. It is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The interest rates for the contract were 9.5 % for the year ended June 30, 2024.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include: (1) amendments to the Plan's documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or the deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. In addition, there is no provision in the contract which provides the issuer with the ability to terminate the contract with the Plan and settle at an amount different from the contract value.

### NOTE F - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the recordkeeper and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Thane C. Martin, CPA, The Financial Consulting Firm, Inc., is considered a related party with party-in-interest transactions as the Plan's external auditor.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue-sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan's operations.

### NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### NOTE H - TAX STATUS

The Plan is a volume submitter plan established under the Principal Financial Group 403(b) Basic Plan. The Plan was designed in accordance with the applicable requirements of the IRC. Principal Financial Group received an advisory letter from the IRS, dated March 31, 2017, indicating that the Plan is acceptable under Section 403(b) of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification under Section 403(b). The Plan administrator believes that the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan is qualified and the related custodial accounts are tax exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has not recognized interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods currently in progress.

### NOTE I – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE J - SUBSEQUENT EVENTS
