### ***Opinion on the 2024 Financial Statements***

We have audited the financial statements of Top Notch Distributors, Inc. Group Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of June 30, 2024, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended June 30, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of Top Notch Distributors, Inc. Group Medical Plan as of June 30, 2024, and the changes in its net assets available for benefits and plan benefit obligations for the year ended June 30, 2024 in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion on the 2024 Financial Statements***

#### (1) Description of Plan

The following description of the Top Notch Distributors, Inc. Group Medical Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a health and welfare benefit plan that provides benefits to employees of Top Notch Distributors, Inc. (the Plan Sponsor and affiliated companies Excab, Inc. and Advant, LLC (collectively, the Companies). The Plan also provides benefit to former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985(COBRA) provisions. In order to be eligible for medical benefits, the employee must be a full-time employee who works at least 30 hours a week and employed for 90 days. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Effective August 1, 2020, the Plan is a member of Veris Benefits Consortium, LLC, which operates a health insurance consortium under which the members negotiate and establish employee welfare benefit plans for their employees. Some expenses of the Plan are paid through the Veris Benefits Consortium, LLC Trust.

##### ***Benefits***

The Plan provides health (medical, hospital, surgical, major medical) and prescription drug benefits to all employees of the Companies who meet the service requirements of the Plan and to their covered dependents. Retirees of the Companies are eligible to continue medical insurance coverage after retirement. The Plan also provides continuation of certain benefits upon termination of employment through COBRA as defined in the plan document.

All benefits are self-insured and these claims are processed through Highmark.

##### ***Stop Loss Coverage***

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims in excess over specific dollar amount, as well as its aggregate exposure for all claims).

##### ***Contributions***

In addition to deductibles and copayments, participants contribute specified amounts based on the applicable monthly premiums for their respective benefit elections. The Companies and the participants share the premiums for the self-funded medical insurance through payroll deductions in accordance with the provisions of the Plan. Participants pay the full cost of COBRA. The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting and Use of Estimates*

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; claims incurred but not reported; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

##### *Payment of Benefits*

Premiums paid by the trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor.

##### *Stop Loss*

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Companies was \$90,000 per covered person for the Plan year end June 30, 2024. In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in stop loss insurance premium expense in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$599,515 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

#### (2) Summary of Significant Accounting Policies, Continued

##### *Benefit Obligations*

Plan obligations at June 30 for claims incurred by active participants, but not reported at that date, are estimated by the Plan's actuary in accordance with accepted actuarial principals based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments.

##### *Reclassifications*

Certain items in the accompanying 2023 financial statements have been reclassified to conform to the current year presentation.

##### *Subsequent Events*

The Plan has evaluated subsequent events through April 8, 2025, the date the financial statements were available to be issued.

#### (3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### (3) Fair Value Measurements, Continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments are held by a bank-administered trust fund. All investments in the Plan are non-participant directed. Investments consist of interest-bearing cash which are considered a level 1 investment in accordance with ASC 820. There have been no changes in the methodologies used at June 30, 2024 and 2023. There were no transfers between levels during the plan years ended June 30, 2024 and 2023.

#### (4) Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, brokers and record-keepers. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan and are excluded from these financial statements.

#### (5) Tax Status

The Plan is funded through the Veris Benefits Consortium, LLC Trust. The Veris Benefits Consortium, LLC, Trust is included on the U.S. Income Tax Return for an S Corporation Form 1120S of the third-party administrator for the Plan. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (6) Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to active employees, contributions required of participants and to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### (7) Related-Party Transactions

The Plan's interest-bearing cash account is held by UMB Bank, the custodian of the Plan. The Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions under ERISA.

#### (8) Risk and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
