### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Chicago Family Health Center, Inc. Employees Savings Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Chicago Family Health Center, Inc. Employees Savings Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2023 and 2022, and for the year ended June 30, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Opinion**

## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description of Plan**

The following description of Chicago Family Health Center, Inc. Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General:**

The Plan is a defined-contribution plan covering eligible employees of Chicago Family Health Center, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Plan participation:**

All employees of the Company except leased employees, nonresident aliens, or collectively bargained employees are eligible to participate in the Plan. Entry dates for employees are on the first day of each quarter after completing six consecutive months of employment with at least one hour of service.

#### **Contributions:**

Participants may contribute up to 100% of eligible compensation to the Plan. Contributions are limited in accordance with Internal Revenue Service (IRS) regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans.

In addition, the Company is required to make safe harbor matching contributions of 100% of the first 3% of compensation deferred by the participant, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

The Plan provides for non-elective profit-sharing discretionary contributions, as determined by the Company. No non-elective profit-sharing discretionary contributions were made during the year ended June 30, 2023.

**1. Description of Plan (continued)**

**Participant accounts:**

The Plan maintains a separate account for each participant. Participants self-direct their contributions and their share of the Company's contribution among the investment options offered by the Plan. Employees can manage their individual accounts online. Earnings and net appreciation or depreciation of the Plan assets are allocated to each participant's account based on actual earnings of participant-directed investments.

**Vesting:**

Participants are always 100% vested in their employee deferral contributions, rollover contributions, safe harbor matching contributions and earnings thereon. Participants are also fully vested if their employment with the Company terminates after normal retirement age (65) or for reasons due to death or permanent disability.

Participants vest in non-elective employer profit-sharing contributions and earnings thereon in accordance with the following table:

Years of service	Vested portion
Less than 1	0%
At least 1 but less than 2	20%
At least 2 but less than 3	40%
At least 3 but less than 4	60%
At least 4 but less than 5	80%
5 or more	100%

**Participant loans:**

Participants may borrow up to the lesser of \$50,000 or 50% of the vested interest in the Plan and the loan shall not be less than \$1,000. All loans are required to be repaid within five years of the date of the loan, unless the loan is for the purchase of a primary residence, in which case, the loan may be up to 15 years. Only one outstanding loan is allowable at any time for each participant. The loans are secured by the balance in the participants' accounts and bear interest at Prime (8.25% and 4.75% as of June 30, 2023 and 2022, respectively) at the time of issuance. Interest rates on outstanding loans ranged from 3.25% to 8.00% at June 30, 2023. Principal and interest are paid ratably through payroll deductions.

**1. Description of Plan (continued)**

**Payment of benefits:**

A participant becomes entitled to benefits under the Plan upon reaching normal retirement age (as defined by the Plan), death, permanent disability or resignation from the Company, to be paid in a manner specified in the Plan. Upon death, disability or reaching normal retirement age, a participant's account balance becomes fully vested. Upon resignation, participants are entitled to receive the vested portion of their account balance.

The Plan also allows in-service withdrawals from a participant's elective deferral account balance for hardship withdrawals or from all vested account balances upon attaining age 59 1/2.

**Forfeitures:**

Employer matching amounts forfeited by participants are accumulated into a forfeiture account. Forfeitures are used to reduce future company contributions. During the year ended June 30, 2023, \$374 of forfeitures were used to offset employer matching contributions. At June 30, 2023 and 2022, there were no balances in forfeited accounts.

**2. Summary of significant accounting policies**

**Basis of accounting:**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

**Investment valuation and income recognition:**

The Plan's investments are stated at fair value except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**2. Summary of significant accounting policies (continued)**

**Notes receivable from participants:**

As described in Note 1, the Plan allows participants to borrow against their vested account balance and the loans are secured by the participants' account balances. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are repaid ratably through regular payroll deductions and loan defaults are treated as distributions. The Plan is required to review the collectibility of the outstanding loan balances and record an allowance for loans determined to be uncollectible. As of June 30, 2023 and 2022, no allowance for uncollectible loans was necessary.

**Payment of benefits:**

Benefits are recorded when paid.

**Administrative expenses:**

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Company.

**Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of the end of the Plan year and the reported amounts of changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates.

**Subsequent events:**

The Plan Administrator has reviewed and evaluated subsequent events through April 14, 2025, the date the financial statements were available to be issued.

**3. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**4. Information prepared and certified by Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **5. Fair value measurements**

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the Plan’s valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Investment contract**

The Plan has a fully benefit-responsive group annuity contract with CMFG Life Insurance Company (the Insurance Company), which is called the CUNA Mutual Guaranteed Account. The Insurance Company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan’s ability to transact at contract value with the Insurance Company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy and (6) early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The Insurance Company may not terminate the contract at any amount less than the contract value.

**6. Investment contract (continued)**

The Insurance Company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the Insurance Company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year. The average yield was 1.46% for the year ended June 30, 2023.

**7. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**8. Tax status**

The Plan, a volume-submitter prototype plan, obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). Although the Plan has been amended since receipt of the determination letter, the Plan Administrator is not aware of any activity or transactions that may adversely affect the qualified status of the Plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the Code.
