## Independent Auditor's Report

To the Plan Administrator of  
Communities for People, Inc. Profit Sharing Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF PLAN

The following description of Communities for People, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a non-contributory profit sharing plan covering eligible employees of Communities for People, Inc. (the Organization) (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor's Board of Directors is responsible for the oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor's Board of Directors.

#### b. Eligibility

Employees become eligible to receive an allocation of the discretionary profit sharing contribution upon reaching the age of twenty-one years, rendering 1,000 hours of service on their anniversary year in order to gain a year of service, and must also be employed on the last day of the fiscal year. Non-resident aliens, individuals on the Plan Sponsor's payroll solely as a function of a management contract between the Plan Sponsor and an unrelated agency, and employees hired under the Jobs for Youth Program are excluded from participation in the Plan.

#### c. Contributions

The Organization may make discretionary profit sharing contributions. The discretionary profit sharing contributions are made by the Organization on behalf of the participants. Contributions are allocated in the same ratio as each participant's compensation bears to the total compensation of all participants. The Organization elected to make a \$300,000 discretionary profit sharing contribution for the year ended June 30, 2024.

The Plan does not allow for employee contributions such as participant elective deferrals or rollover contributions. Participants direct their account into various investment options offered by the Plan.

#### d. Participant Accounts

Each participant's account is credited with the Organization's discretionary profit sharing contributions and an allocation of plan earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

The vesting period is based on the participants' years of service. Participants are vested in the discretionary profit sharing contributions plus actual earnings thereon based on the schedule below.

Vesting is immediate upon the eligible employee's death, total and permanent disability, or normal retirement age of sixty-five, with no option for early retirement.

#### f. Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, partial payments, or periodic installments over a period not to exceed the life expectancy of the participant or beneficiary. The Plan does not allow for hardship withdrawals. The Plan includes an involuntary cash-out provision for those accounts of former employees with a balance of \$5,000 or less. The Plan also allows for in-service withdrawals upon attainment of age 59½. Effective December 31, 2023, the involuntary cash-out distribution amount was increased from \$5,000 to \$7,000 per the SECURE 2.0 Act.

#### g. Forfeited Accounts

Forfeitures represent non-vested discretionary profit-sharing contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures may first be used to pay any administrative expenses or reduce future discretionary profit sharing contributions. If forfeitures are not used for administrative expenses or future discretionary profit-sharing contributions, forfeitures may be allocated to participants of the Plan. Upon incurring a one-year break in service for any reason other than retirement, death or disability, all amounts held in a participant's employer contribution account which are not vested shall be reallocated to the accounts of the other participants in the same manner as the employer contribution. If such participant is re-employed prior to incurring five consecutive one-year breaks in service, the amounts which were forfeited shall be restored to the participant's employer contribution account. The Plan had \$68,825 and \$61,125 of unallocated forfeitures as of June 30, 2024 and 2023, and used \$4,352 of forfeitures to reduce administrative expenses during the year ended June 30, 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and qualified institution. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual funds includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Contributions

Discretionary profit sharing contributions are recorded when such contributions are authorized by the Plan Sponsor.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of benefit payments, recordkeeping and investment advisory services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of mutual funds.

#### Subsequent Events

Subsequent events have been evaluated through April 7, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified to the completeness and accuracy of all mutual funds reported in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of June 30, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year June 30, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

There has been no change in the methodology used at June 30, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, fees paid to the Plan's qualified institution and investment advisor are considered party-in-interest transactions. During 2024, the Plan paid recordkeeping, advisory and administrative service fees of \$18,251.

### 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
