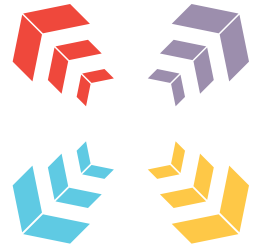

## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Management

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RB Royal Industries, Inc. Employees Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RB Royal Industries, Inc. Employees Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

**NOTE A – DESCRIPTION OF PLAN**

RB Royal Industries, Inc. Employees Profit Sharing Plan (the Plan) was established on June 29, 1964. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a qualified contribution plan under Section 401 of the Internal Revenue Code (IRC) covering all eligible participating employees of RB Royal Industries, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the IRC of 1954. It is exempt from federal income tax.

**Eligibility**

Each eligible employee can participate in the Plan after six months of service and attaining age twenty-one. To receive employer matching or profit sharing contributions, employees must complete one year of service with 1,000 hours.

**Employee Contributions**

Participant's contributions (deferrals) in any taxable year, may not exceed the lower of a dollar limit set by law (\$23,000 and \$22,500 for 2024 and 2023, respectively) or 100% of eligible compensation. Participants who are 50 years or older before the end of the calendar year are eligible to make catch-up contributions. Newly hired employees are auto enrolled and automatically defer 5% of the participants earnings, unless they elect otherwise. Further, for participants enrolled under the automatic enrollment feature, the deferral percentage increases 1% each September 1<sup>st</sup>, up to a maximum increase of 3%. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one common/collective trust fund and twenty-two registered investment company funds as investment options for the participants. Participants may elect to have any portion, or all, of their contributions designated as Roth 401(k) contributions. Contributions are subject to certain limitations.

**Company Contributions**

Discretionary matching contribution – The Company may make matching contributions in an amount determined by the Company. For the years ended June 30, 2024 and 2023, the Company made matching contributions equal to 75% of the employee's deferrals, limited to 5% of the employee's eligible compensation.

Profit sharing contribution – The Company may make annual discretionary profit sharing contributions in an amount to be determined by the Company. The employee must complete at least 1,000 hours of service during the plan year and be employed on the last day of the plan year end. No profit sharing contribution was made for the years ended June 30, 2024 and 2023.

**Company Contributions – Continued**

Qualified matching and non-elective contributions – The Plan permits the Company to contribute a discretionary amount for a plan year which the Company will designate as qualified non-elective contributions. The Advisory Committee will allocate these contributions to the participants who are eligible for an allocation based upon the participant’s share of the total compensation paid during that plan year to all participants eligible for the allocation.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, any withdrawals or distributions and an allocation of (a) the Company’s contribution; and (b) plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Certain costs and expenses are paid directly by participants for loans and distributions related to their account. Plan administrative expenses are paid by the Company.

**Vesting**

Participants are immediately vested in their contributions. Company matching and profit sharing contributions vest based on the following schedule:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless it is for the purchase of the participant’s principal residence, in which the repayment period cannot exceed ten years. The loans are secured by the balance in the participant’s separate account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through periodic payroll deductions. In the event of default, death, disability, or termination of employment, the principal and accrued interest are immediately due.

**Payments of Benefits**

The form of benefit payments depends on the participant’s vested account balance. If the account balance is less than \$5,000 but more than \$1,000, it will be automatically rolled into an IRA account for the participant. Terminated employees with vested account balances of less than \$1,000 are required to take a lump-sum distribution. If the account balance exceeds \$5,000, the participant can elect to defer distribution from the Plan or to receive either a lump-sum distribution, installment payments over a specified period of time not to exceed the participant’s life expectancy or the joint life expectancy of the participant and the participant’s designated beneficiary, or a part lump-sum distribution and part installments.

**Forfeitures**

When terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used by the plan sponsor to reduce administrative expenses. Company contributions for the years ended June 30, 2024 and 2023 were reduced by \$28,281 and \$66,821, respectively, from forfeited nonvested accounts. During the years ended June 30, 2024 and 2023, forfeited nonvested accounts totaled \$35,841 and \$37,023, respectively. The Plan can accumulate these forfeitures, and the value of these forfeitures as of June 30, 2024 and 2023 were \$17,074 and \$8,911, respectively.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions from net assets during the reported period. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Allowance for doubtful accounts is zero as of June 30, 2024 and 2023.

**Investment Valuation and Income Recognition**

Investments are reported at fair value using methodologies described in Note D - Fair Value Measurements. The change in the difference between fair value and the cost of investments is reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. The realized gain (loss) on sale of investments is the difference between the proceeds received and the cost of investments sold. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Participants may elect to contribute to the Managed Income Portfolio, a common trust fund of the Fidelity Group Trust for the Plan.

**Risks and Uncertainties**

The Plan invests in various investment securities. These securities are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain values of investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the accompanying financial statements.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under the accounting standards are described as follows:

- Level 1      Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
  
- Level 2      Inputs other than quoted prices within Level 1 that are observable for asset or liability, either directly or indirectly, such as:
  - a. Quoted prices for similar assets or liabilities in active markets
  - b. Quoted prices for identical or similar assets or liabilities in inactive markets
  - c. Inputs other than quoted prices that are observable for the asset or liability
  - d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs that are unobservable inputs for the asset or liability.

**NOTE D – FAIR VALUE MEASUREMENT**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Common Collective Trust Funds: The Plan’s common collective trust funds are valued at the NAV of units in the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. In the event that the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contribution or terminate the Plan at any time subject to the provisions of ERISA.

**NOTE H – TAX STATUS**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualified under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. All years not closed by the statute of limitations remain open for examination by tax jurisdictions.

**NOTE I – CONCENTRATIONS**

The Plan holds certain investments that represent 10% or more of the Plan's assets available for benefits. As of June 30, 2024, the Plan held one investment totaling \$3,200,158 that was greater than 10% of the Plan's net assets available for benefits. As of June 30, 2023, the Plan held one investment totaling \$3,843,112 that was greater than 10% of the Plan's net assets available for benefits.

**NOTE J – RISK AND UNCERTAINTIES**

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2019, which contained the largest package of retirement system reform in over a decade. Many of the provisions of the SECURE Act are effective on January 1, 2020, and will require significant changes to plan administration and recordkeeping.

The Families First Coronavirus Response Act (FFCRA) and the Coronavirus Aid, Relief and Economic Security (CARES) Act were enacted in March 2020 in response to the coronavirus outbreak, which among other things contain numerous tax, funding and other provisions that affect employee benefit plans. CARES Acts amendments were added to the Plan in April 2023 and were effective January 1, 2020.

In December 2022, the Consolidated Appropriation Act of 2023 was signed into law. It includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into other retirement systems, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. There are several required changes that are effective for plan year beginning on or after January 1, 2024 and optional changes for sponsors to consider that are available upon enactment. The Company is in the process of implementing these and amendments to plan documents are unknown as of the date on which the financial statements were available to be issued.

**NOTE K – SUBSEQUENT EVENTS**

In February 2025, a legal judgment against the Company, the Plan Sponsor, was signed awarding a total of \$19,000 to employees who were employed during a designated timeframe. The judgment provides for the distribution of this amount in equal shares to eligible employees. As of the date of issuance of the financial statements, the number of eligible respondents has not been determined.

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through April 10, 2025, the date on which the financial statements were available to be issued.
