Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Budney Overhaul & Repair, Ltd. Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

(1) **Description of Plan**

The following description of the Budney Overhaul & Repair, Ltd. Employee Retirement Plan (Plan) only provides general information. Participants should refer to the Plan agreement for a complete description of the provisions. Contributions to provide benefits under the Plan are made by Budney Overhaul & Repair, Ltd. ("Plan Sponsor" and "Company") and Plan participants.

Empower (Trustee) as the certifying agent administers and invests the assets of the Plan and the income therefrom for the benefit of the Plan's participants.

General

The Plan is a defined contribution plan which covers all employees who have 12 months of service and are age 21. The Plan was established on January 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 50% but not less than 1% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute or rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary contribution each year. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Generally, eligibility for employer contributions requires that employees must complete one year of service (defined as a continuous 12-month period during which the employee worked 1,000 hours).

During the year ended December 31, 2024, the Company made matching contributions of 50% of participant's contributions up to a maximum of 5% of their compensation. There were no discretionary contributions made by the Company.

Participants' Accounts

Each participant's account is credited with the participant's contribution and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan (continued)

Vesting

Participants are vested immediately in their contributions plus amounts earned thereon. Vesting in the Company's contributions is immediate at less than two years; 20% at two years; 40% at three years; 60% at four years; 80% at five years; and 100% at six or more years of service.

Notes Receivable from Participants

Participants may borrow from their individual vested accounts under the Plan. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Trustee. There were outstanding loans of approximately \$37,300 as of December 31, 2024.

Investment Options

Upon enrollment in the Plan, a participant may direct employer and employee contributions to various money market and mutual funds offered by the Plan. These funds include a variety of investment options with various objectives and degrees of financial risk.

Payment of Benefits

If employment is terminated, participants with a vested account balance greater than \$5,000 have the following choices: (a) withdraw all or part of vested accounts in a single sum provided participant has met the requirements for withdrawals; or (b) leave all or part of the vested accounts with the Plan and defer receipt of benefits.

If the vested account balance is \$1,000 or less, participants will receive a single-sum lump payment at termination of employment.

A participant may make withdrawals from salary reduction contributions or vested employer contributions at age 59 1/2 or later. The participant must specify on all withdrawals the interest and investment alternatives from which the withdrawal is to be made.

Salary reduction contributions and vested employer contribution withdrawals may be made due to a financial hardship. A hardship is generally defined as an immediate and heavy financial need.

If a participant dies before beginning to receive annuity payments, the beneficiary is entitled to the total value of the account.

Forfeited Accounts

There were forfeitures of approximately \$5,300 and \$1,300 during 2024 and 2023, respectively. Any future forfeitures will be used to reduce future employer contributions.

Administrative Costs

The Plan records certain costs for recordkeeping and administration. The Plan Sponsor also directly pays certain administrative expenses.

(2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

- The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting.
- Investments are stated at fair value, based on quoted market prices.
- Investment income is recorded as earned and certain participant investment fees are netted against investment income
- Investment transactions are accounted for on the trade date.
- Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in money market, mutual funds and fixed income securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Subsequent Events

Subsequent events have been evaluated through March 31, 2025 which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued using net asset value (NAV) reported by the fund. Money market funds invest in short-term securities that present minimal credit risk to provide liquidity and preserve capital.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Party-In-Interest and Related Party Transactions

Certain Plan investments are shares of mutual funds managed by various fund companies. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

The Plan sponsor pays directly any other fees related to the plan's operations.

(5) Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(8) Income Tax Status

The IRS has determined and informed the Company by a favorable opinion letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
