## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Cathedral Square Corporation (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of Cathedral Square Corporation's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

### (1) DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan of Cathedral Square Corporation (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all eligible employees of Cathedral Square Corporation (the “Company”) with no minimum age requirement. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as periodically set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the calendar year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified plans.
- (c) Employer Contributions – The Company makes a matching contribution for each employee who enters into a salary reduction agreement and meets the employer contribution eligibility requirement. The matching contribution during 2024 and 2023 equaled 100% of the first 2% deferred by participants.

The Company also makes a non-matching contribution for each eligible employee, without regard to the employee’s participation in the Plan. The non-match contribution during 2024 and 2023 equaled 3% of eligible compensation for each eligible employee.

Employees are eligible for employer contributions if they are 18 years of age or older and have completed at least one year of service (1,000 hours).

- (d) Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution and allocation of (a) the Company’s additional non-matching contribution, and (b) Plan earnings. Allocations are based on the participant’s eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant determines the investment strategy of their account as provided by the Plan.
- (e) Vesting – Participants are immediately vested in all contributions.
- (f) Payment of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s account, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account.

If the terminating employee’s non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance as soon as administratively practical.

A participant may withdraw rollover contributions at any time. The Plan also allows hardship distributions under Federal rules.

- (g) Plan Loans – Loans issued by Mutual of America Life Insurance Company are considered plan loans, in the respect that the loans are issued directly by Mutual of America Life Insurance Company to participants and secured by the participant's account balance. These loans qualify as non-ERISA and are excluded from the net assets available for benefits. Total plan assets securing the loans as of September 30, 2024 and 2023 were \$90,170 and \$48,811, respectively. The interest rate on plan loans outstanding at September 30, 2024 and 2023 was 5.85%.

### (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Administrative Expenses – In general, all Plan expenses except certain recordkeeping fees are paid for by the Company.
- (e) Benefit Payments – Benefits are recorded when paid.
- (f) Subsequent Events – The Plan has evaluated subsequent events through April 18, 2025, which is the date the financial statements were available to be issued.

### (3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

### (4) TAX STATUS

The Plan has not obtained a determination letter. The Plan is required to operate in conformity with applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### (5) WITHDRAWING PARTICIPANTS

All participants who have withdrawn from the Plan and requested their benefits have been paid as of September 30, 2024.

### (6) RELATED PARTY TRANSACTIONS

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

### (7) INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company and The Variable Annuity Life Insurance Company, the custodians of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, the schedule of assets held for investment purposes as of September 30, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended September 30, 2024 and 2023.

### (8) FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices at year end.

*Pooled separate accounts:* Valued at the closing price reported on the active market on which the underlying securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
