Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of Community Action Partnership of Lancaster County (Plan Sponsor) Group Health Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan provides benefits to full-time employees working at least 30 hours per week for medical, dental, and vision coverage, and at least 20 hours per week for disability, accidental death and dismemberment, and life insurance coverage. Coverage for eligible employees is immediately available for all disability, life, and accidental death and dismemberment benefits. Medical benefits are available to eligible employees who have completed 30 days of service. Effective December 1, 2023, dental and vision benefits are available to eligible employees who have completed 30 days of services. Prior to December 1, 2023, dental and vision benefits were available to eligible employees who had completed six months of service. Benefits are also provided to dependents of these individuals who elect coverage on their behalf.

Plan assets are held in the Community Action Partnership of Lancaster County Health Benefit Trust which are to provide health care benefits under one or more plans established by the Plan Sponsor. The Plan is a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish employee welfare benefit plans for their employees. Some expenses of the Plan are paid through the Veris Benefits Consortium Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits (medical and prescription drug), dental, vision, short-term disability, long-term disability, accidental death and dismemberment, and life insurance benefits to substantially all employees of the Plan Sponsor who meet the service requirements of the Plan and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the basic life insurance benefits, basic accidental death and dismemberment benefits, disability benefits, dental benefits, and vision benefits. The Plan Sponsor purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company from the general assets of the Plan Sponsor.

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits (medical and prescription drugs) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's trust or the general assets of the Plan Sponsor. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Other Benefits

The Plan has a healthcare and dependent care flexible spending account (FSA) that is funded solely through participant contributions. The FSA allows eligible participants to be reimbursed tax free for qualified medical and dependent care expenses subject to a specified ceiling. Amounts remaining at the end of the year cannot be carried over to the next year. These amounts are maintained in the Plan and netted against flexible spending account expenses.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Benefits for basic life insurance, accidental death and dismemberment, and disability are fully funded by the Plan Sponsor. Participants and the Plan Sponsor each pay a portion of the premiums for medical, dental, and vision benefits based on the current group rate premiums. The Plan Sponsor makes contributions based on the maximum rate per participant as defined by the stop loss contract. If actual claims are less than the amount funded, the surplus is netted against future employer contributions. The surplus netted against future employer contributions for the years ended June 30, 2024 and 2023 were \$375,000 and \$474,408.

Participants pay the full cost of all healthcare and dependent care FSA benefits. FSA contributions are elected annually by the employee in advance and are limited to \$3,200 and \$3,050 for 2024 and 2023, except for dependent care which has a limit of \$5,000 for 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis of accounting.

Other Income

The Plan changed third-party claims processors effective January 1, 2024. The new third-party claims processor provided implementation credits to the Plan. These credits are included in other income on the statement of changes in net assets available for benefits for the year ended June 30, 2024.

Payment of Benefits

Premiums paid by either the Plan Sponsor or the trust are recorded as insurance premiums in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. Amounts payable to claims administrators totaled \$54,855 and \$30,878 on June 30, 2024, and 2023, respectively.

Stop Loss

Premiums for stop loss insurance are included in insurance premiums in the accompanying statements of changes in net assets available for benefits. Refunds due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Stop loss refunds

totaling \$550,644 and \$508,580 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, respectively.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan.

Subsequent Events

Management evaluated subsequent events through February 20, 2025, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations for the years ended June 30, 2024 and 2023, for claims incurred but not reported are estimated by the Plan Sponsor based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Interest-bearing cash – Valued at cost and classified within Level 1 of the valuation hierarchy.

5. ADMINISTRATIVE EXPENSES

The Plan pays expenses related to administrative fees paid to the Plan's third-party claims processors, actuary, and broker. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Plan Sponsor on behalf of the Plan.

6. TAX STATUS

A trust was established under the Plan to hold the Plan's assets. The trust applied for an EIN under the Internal Revenue Code effective February 26, 2016. From time to time, the interest earned on the Plan's interest-bearing cash may be subject to income taxes. There were no material federal or state income taxes owed during the years ended June 30, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, the right to modify the contributions required of participants, the right to discontinue its contributions, and the right to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan has several arrangements with service providers as described in Notes 1 and 5. During the years ended June 30, 2024 and 2023, the Plan's investments were managed by UMB Bank, the custodian of the Plan. These transactions are party in interest transactions under ERISA.

9. RISKS AND UNCERTAINTIES

The Plan maintains cash balances at financial institutions. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan's deposits may exceed insured limits.

The Plan Sponsor's estimate of benefit obligations is subject to certain assumptions that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
