Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Splunk Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 2, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to December 2, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 2, 2024 and December 31, 2023, and for the period January 1, 2024 to December 2, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Splunk Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. General

The Plan was established on January 1, 2005 by Splunk, Inc. (the “Company”) to provide retirement benefits to eligible employees. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

As a result of the acquisition of the Company in March 2024, the Plan was merged into another retirement plan effective December 2, 2024.

B. Administration and Expenses

Fidelity Management Trust Company (“Fidelity”) serves as trustee and record keeper. Investment related expenses are charged directly by the investment funds and are thereby factored into each investment fund as a reduction of investment return. Participant loan administration and withdrawal fees are charged directly to participants. The Plan may receive revenue share credits to be used to offset Plan expenses or credited to participant accounts to reduce expenses. Other costs incurred for administering the Plan were paid by the Company in 2024.

C. Eligibility

The Plan specifically excludes employees covered by a collective bargaining agreement, interns, and leased employees. Non-excludable employees must have attained age 18 to enter the Plan. There is no service requirement and eligible employees may enter the Plan on their date of hire.

D. Contributions

Participants may elect to have the Company contribute up to 90% of their eligible pre-tax and/or Roth after-tax compensation to the Plan subject to applicable Code limits. Participants who elect to have the Company contribute a portion of their pre-tax compensation to the Plan agree to accept an equivalent reduction in taxable compensation.

Eligible employees who have not made an affirmative election to defer compensation to the Plan, including an election not to defer are automatically enrolled in the Plan at a pre-tax contribution rate of 6% of eligible compensation.

Participants are also allowed to make voluntary, non-deductible, after-tax contributions and rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant directions and the Plan’s provisions.

The Plan allows the Company to make discretionary matching and non-elective contributions. The Company matches 50% of a participant’s deferrals up to a maximum of 6% of eligible compensation.

E. Vesting

Participants are immediately 100% vested in their accounts attributable to participant elective contributions, rollovers, voluntary after-tax contributions, Company non-elective and matching contributions. All participant accounts are 100% vested at December 2, 2024.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, Plan earnings or losses and expenses. Participants direct the investment of their accounts among a diversified menu of funds provided under the Plan. The accounts of participants who do not make investment elections are allocated under provisions of Fidelity Model Portfolio Recordkeeping Services ("MPRS"), a service administered by Fidelity, a third-party investment company that uses Plan investment options to construct target retirement date investment portfolios suitable for participants who are projected to reach retirement age at specified dates in the future.

G. Payment of Benefits

Participants are eligible for benefits upon retirement, disability, or termination of service. Normal retirement age under the Plan is age 65. Benefits are payable in a lump sum or installments. Hardship distributions are permitted under limited circumstances as provided under the Plan. Benefits are recorded when paid.

H. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account, bears a reasonable rate of interest at a fixed rate determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. All loans must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - PLAN MERGER

In March 2024, another company acquired the Company. As a result of the acquisition, the 401(k) Committee of the Splunk Inc. Retirement Plan oversaw the merger of the Plan into the acquiring company's retirement plan. The Plan was fully merged into the acquiring company's retirement plan effective December 2, 2024.

NOTE 4 - TAX STATUS

The Company adopted a Fidelity pre-approved plan that received an advisory letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 2, 2024 and December 31, 2023, and net appreciation of investments, interest and dividends for the period January 1, 2024 to December 2, 2024, was obtained, or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

NOTE 6 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the daily closing price reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts consist primarily of mutual funds, exchange-traded funds, and money market accounts that are valued on the basis of readily determinable market prices. The following table sets forth Plan investments measured at fair value based on the inputs used to value them at December 31, 2023:

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments offered under the Plan are issued by the trustee or affiliates of the trustee. Purchases and sales of these investments and payment by the Plan of expenses related to Plan operations and investment activity to Plan service providers are party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through April 9, 2025, the date on which the financial statements were available to be issued. There are no subsequent events that require recognition or additional disclosure in these financial statements.
