NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Fresno Valves & Castings, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. The primary purpose of the Plan is to provide employees of Fresno Valves & Castings, Inc. (the Company), the opportunity to accumulate funds for their retirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan. The Trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Company's Board of Directors. The Plan was restated for the final Cycle 3 regulations effective October 1, 2021.

Eligibility

The Plan is a defined contribution plan covering all employees of the Company who have completed at least one year of service, have attained the age of 21, and are not covered by a collective bargaining agreement. A year of service is defined as any plan year in which the employee has worked 1,000 hours.

Administration

The Plan is administered by the Company. All administrative expenses are paid on behalf of the Plan by the Company.

Participant accounts

Each participant's account is increased or decreased with the participant's contributions, employer matching contributions, and allocations of (a) employer discretionary profit sharing contributions, (b) plan investment net gains and losses, and (c) forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the vested amount of the participant's account.

Participant contributions

Participants may contribute to the Plan a percentage of their annual wages not to exceed a specific dollar amount determined annually by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer contributions

The Company may make a contribution, annually, at the discretion of the Board of Directors, which, if made, is allocated in proportion to participants' eligible compensation. Eligible compensation includes overtime, bonuses and commissions. For each of the years ended September 30, 2024 and 2023, the Company accrued profit sharing contributions of \$600,000 to the Plan.

Employer matching contributions are 25% of the employee's contribution and are limited to the first 6% of employee compensation contributed to the Plan by the participants. Such matching contributions were \$132,900 and \$128,115 for the years ended September 30, 2024 and 2023, respectively.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on an employee's years of continuous service. Discretionary contributions by the Company and employer matching contributions vest on a pro rata basis over six years of credited service. In the event of death, disability or retirement, a participant's interest in employer contributions becomes fully vested.

Forfeitures

Forfeitures (participants' allocated interest in plan assets which are not vested because employment is terminated before the vesting period is complete) are allocated to participants in proportion to each participant's compensation for the plan year to total compensation for all participants for that year.

Payment of benefits

Upon termination of service, the participant may elect to receive benefits equal to the vested value of his or her account in one lump-sum payment, periodic installments or a combination of these methods of payment. Participants may elect to roll over their vested benefits to individual retirement accounts or to other qualified plans.

Termination

Although termination of the Plan is not presently contemplated, the Company does have the right to terminate the Plan at any time. In the event of termination, participants become 100% vested in the aggregate value of their respective accounts.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for additional discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The average yield earned by the Plan's stable value fund investment choice is equal to the average yield earned by the Plan adjusted to reflect the actual interest rate credited to plan participants. The effective annual rate of interest is established prior to January 1st and July 1st for the corresponding six-month period. The stable value fund investment choice is not considered a guaranteed interest contract and there is no stated minimum or maximum interest rate. Contract charges may reduce this return.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability. The Plan distributed the 2024 excess contributions to the applicable participants prior to December 15, 2024. The Plan distributed the 2023 excess contributions to the applicable participants prior to December 15, 2023.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent events

Plan management has evaluated subsequent events through March 11, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">· quoted prices for similar assets or liabilities in active markets;· quoted prices for identical or similar assets or liabilities in inactive markets;· inputs other than quoted prices that are observable for the asset or liability;· inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term or the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. In accordance with ASU 2015-07, the stable value fund, measured at net asset value (NAV), is not included in the fair value hierarchy. There have been no changes in methodologies used at September 30, 2024 and 2023.

Mutual Funds: The fair value of the mutual funds held by the Plan at year-end is based on the closing price reported on the active market where the individual mutual funds are traded.

Stable Value Fund: The stable value fund is composed of fully benefit-responsive investment contracts reported at net asset value. The stable value fund is classified as a cash equivalent and primarily backed by the general account of Transamerica Life Insurance Company or Transamerica Financial Life Insurance Company. The NAV is used as a practical expedient to estimate fair value and is calculated or valued using publicly available quotes on the underlying investments.

NOTE 5 – TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – ALLOCATION OF ASSETS

Net assets available in the amount of \$8,004,587 and \$7,793,848 for the years ended September 30, 2024 and 2023, respectively, have been allocated to the accounts of employees who have separated service with the employer. Non-vested amounts to be forfeited in future years total \$73,154 and \$46,904 of net assets available for benefits at September 30, 2024 and 2023, respectively.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – RELATED PARTY TRANSACTIONS

While acting as custodian, Transamerica provided record keeping and investment services to the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for the services to Transamerica amounted to \$14,338 and \$11,460 for the years ended September 30, 2024 and 2023, respectively.

Investment management services and third-party administrative services are paid for by the Company. Certain fees received by Transamerica or its affiliates and expenses charged by the mutual funds may be netted against investment income earned by the Plan. Broker commissions paid by Transamerica Life Insurance Company related to the Plan totaled \$76,851 and \$74,544 for the years ended September 30, 2024 and 2023, respectively.

Administrative functions are jointly performed by employees of the Company and the third-party administrator, Nexus Administrators. No employee receives compensation from the Plan. The independent auditor's fees are paid directly by the Company.
