Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Tax Deferred Annuity Plan for Employees of Palladia, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

1. Description of Plan

The following description of the Tax Deferred Annuity Plan for Employees of Palladia, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan covering all eligible employees of Palladia, Inc. (the Employer), as defined in the Plan document. The Plan was established effective as of November 1, 1980. Each eligible employee enters the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Employer. Mutual of America Life Insurance Company (Mutual of America) serves as the custodian of the Plan.

On December 4, 2014, Palladia, Inc. entered into a membership transaction agreement with Services for the UnderServed, Inc. (SUS), a New York not-for-profit corporation. Under the terms of the agreement, SUS became the sole member of Palladia, Inc. and each of the operating entities. In effect, SUS took over the control of management of the Plan.

Effective January 1, 2017, no new participants are accepted by the Plan. Effective the same date, the Employer elected to become a participating employer in the Services for the UnderServed 403(b) Plan, which is also a defined contribution plan subject to the provisions of ERISA.

Contributions

Effective January 1, 2017, no salary reduction contributions are accepted by the Plan. Participants may still contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). There were no rollovers during the year ended June 30, 2024.

Investment Options

All of the Plan's investment options are fully participant-directed. Participants direct the investment of their account balances into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with allocations of net Plan earnings and losses. Participant accounts are charged for withdrawals and an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Loans

Participants may borrow from Mutual of America and use their Plan account balance (invested in the pooled separate accounts or guaranteed interest contract) as collateral. The loans are not shown in the Plan's financial statements of net assets available for benefits, as the loans are not made from Plan assets and are, therefore, not considered assets of the Plan. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of half of their vested account balance or \$50,000.

Notes to Financial Statements

The loan bears interest at a rate commensurate with local prevailing rates at the time funds are borrowed, as determined by Mutual of America. Loan terms range from one to five years; however, terms may exceed five years, but not to exceed ten years, for the purchase of a primary residence. The collateral must be equal to or exceed 120% of the loan, and payments on the loan are made outside of the Plan.

As of June 30, 2024 and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$7,606 and \$10,678, respectively. As such, \$9,127 and \$12,813 as of June 30, 2024 and 2023, respectively, of account values serve as collateral for the related loans.

Vesting

Participants are fully vested in their contributions plus actual earnings immediately.

Payment of Benefits

On termination of service due to death, disability, retirement, or severance from employment, or upon hardship, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. The method in which a participant's account is distributed depends on their marital status and elections made by the participant and their spouse. If a participant is married on the date their benefits begin, the participant will automatically receive a joint 66²/₃% survivor annuity, unless the participant and their spouse elect another form of payment. A married participant may also select a 75% survivor annuity. If a participant is not married on the date their benefits begin, the participant will automatically receive a life annuity.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan (except for the fully benefit-responsive investment contract) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

The fully benefit-responsive investment contract is reported at contract value. See Note 6 for a discussion on the fully benefit-responsive investment contract.

Notes to Financial Statements

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

Administrative Expenses

The Employer pays substantially all administrative expenses of the Plan, except account administration expenses, which are paid by the participants. Expenses that are paid by the Employer are excluded from these financial statements. Management fees and operating expenses charged to the Plan for its investments are deducted from the investment returns of such investments.

Payment of Benefits

Benefits are recorded when paid.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of June 30, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 or 2023.

Pooled Separate Accounts - Pooled separate accounts are valued at their accumulation unit value (AUV) as a practical expedient to measuring fair value. The AUV is determined daily based on the net asset value of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments. The underlying funds of the pooled separate accounts are generally invested in registered investment companies whose investment strategies are to seek capital appreciation through investment in common and preferred stocks and debt securities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments in pooled separate accounts, which are valued at AUV, have not been classified in the fair value hierarchy, in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis during the years ended June 30, 2024 and 2023.

6. Fully Benefit-Responsive Guaranteed Interest Contract

In 2008, the Plan entered into a benefit-responsive guaranteed interest contract with Mutual of America. Mutual of America maintains the contributions in a general account. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) and (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed interest contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the events of Plan termination, participants would remain 100% vested in their accounts.

8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71 and the draft Listing of Required Modifications issued April 4, 2009. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). Although the Plan has never received an opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Related Party and Party-in-Interest Transactions

Transactions with Mutual of America qualify as exempt party-in-interest transactions.

10. Subsequent Events

Plan management has evaluated events through April 18, 2025, the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
