Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Primitives by Kathy Profit Sharing 401(k) Plan**, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as well as from an agent on behalf of the qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION of PLAN

The following description of the **Primitives by Kathy Profit Sharing 401(k) Plan** (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time eligible employees of Primitives by Kathy (the Company). Employees are eligible to make elective deferrals and receive employer match and profit-sharing contributions after attaining age 18 and completing 6 months of service. Participants may enter the Plan on the first day of each quarter following the date on which the general eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In collaboration with investment advisors, the Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was impacted by regulatory changes related to the Setting Every Community Up for Retirement Enhancement Act (SECURE) Act and the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The Plan Sponsor intends to amend the Plan to formally incorporate these provisions by the Plan year ended September 30, 2025.

Contributions

Each year, participants may contribute up to 100 percent of their annual compensation, as defined in the Plan Document. This contribution is in the form of pre-tax or Roth contribution (salary deferral). Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from qualified plans and Individual Retirement Accounts (IRAs) (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan default investment option, unless they affirmatively elect a different deferral rate. The deferral rate is set at 3% of eligible pre-tax compensation for automatically enrolled participants and automatically increases 1% on an annual basis April 1, until the participant reaches a 10% maximum.

The Company has elected to make a matching contribution to all qualifying participants in order to qualify as a safe harbor plan. The amount of match is equal to 100% of the first 3% of Plan year compensation and 50% of the next 2% of Plan year compensation deferred upon. The matching contribution is invested as directed by the participant. During the years ended September 30, 2024 and 2023, employer safe-harbor matching contributions were \$195,668 and \$214,609, respectively.

The Company may make a profit-sharing contribution that will be an amount allocated to qualifying participants eligible to share in this contribution. Discretionary contributions are allocated to eligible participants based on the integrated calculation which utilizes Plan eligible compensation. For the Plan years ended September 30, 2024 and 2023, the Company made no profit sharing contributions.

The Company may also make a qualified non-elective contribution that will be an amount allocated to all active non-highly compensated participants on the last day of the Plan year. Qualified non-elective contributions are allocated to eligible participants based on the percentage of the participants annual pay divided by the total annual pay of all participants eligible to receive the qualified non-elective contribution. For the Plan years ended September 30, 2024 and 2023, the Company made no qualified non-elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

A record-keeping account is set up in each participant's name to show the value of his or her retirement benefit. Each participant's account is credited with the participant's contributions, the Company's matching contributions, discretionary profit-sharing contributions (if any), qualified non-elective contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting

Participants are vested immediately in their contributions, the employer matching contribution, and the employer qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of the account is based on the following table:

A participant becomes fully vested regardless of the vesting schedule upon attainment of normal retirement age, upon disability, upon death, or upon termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a reasonable rate of return. Principal and interest is paid ratably through payroll deductions. Participants are limited to one outstanding note at a given time.

Payment of Benefits

Normal retirement date means the earliest first day of the month on or after the date the participant reaches age 65. A participant shall be entitled to receive the balance held in his or her account as a lump-sum upon termination of employment, death, disability, or attainment of normal retirement age. The lump-sum amount is equal to the value of the participant's vested interest in his or her account. The portion of the participant's account to which they are not vested is a forfeiture and allocated as a reduction of operational and administrative expenses or employer contributions. Upon retirement or termination, if the participant's account balance is \$5,000 or less, the balance will automatically be distributed in a single lump sum. If the participant's vested account balance is more than \$5,000, the participant may choose from the following forms of distributions: annuity options, single sum payments, periodic fixed payments, or specified annual dollar amounts.

Payment of Benefits (Continued)

Hardship withdrawals are allowed from employee elective deferrals, matching contributions, and vested discretionary contributions, plus earnings thereon in the event of financial hardship at the discretion of the Plan Administrator.

One in-service withdrawal during a twelve-month period is available on participant's elective deferrals and vested employer contributions after the participant has attained age 59½.

Forfeited Accounts

There were no forfeited non-vested accounts at September 30, 2024 and 2023. These accounts are used to pay reasonable Plan expenses first, then used to reduce future employer matching or future profit-sharing contributions and any remaining forfeiture account balance can be allocated to participant accounts. There were no forfeitures used to reduce employer matching contributions or pay Plan expenses during the years ended September 30, 2024 and 2023.

NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP). Current US GAAP standards are contained in the Accounting Standards Codification (ASC) as set forth by the Financial Accounting Standards Board (FASB).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from estimated amounts. Significant estimates used in the preparation of these financial statements relate to the valuation of investments and changes therein.

Investment Valuation and Income Recognition

Investments are reported at fair value as determined and certified to by the Plan's custodians. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator, in collaboration with the Plan's investment advisor, determines the valuation policies utilizing information provided by the custodians and their related parties. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income and capital gains are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded for purposes of Form 5500 reporting. However, for purposes of the financial statements, for active participants who have not incurred a distributable event (employment termination, death, or disability), but have delinquent loans, the participant loan remains outstanding until a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from the Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Expenses

Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The remaining administrative costs are allocated to Plan participants. In addition, fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset and liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023:

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Unit value calculated based on the observable net asset value of the underlying investments. The portfolio features diversified investment offerings intended to balance investment risk with the need for investment growth to provide for participant retirement, death, and disability benefits. Investments are redeemable in accordance with application of participant directives and Plan benefit provisions.

Common Collective Stable Value Trust: Valued based on the current market value of the shares of the underlying investments held by the Plan at year end.

As a participant in the common collective stable value Trust, the Plan is subject to restrictions regarding transfer and withdrawal of assets including potential deferral of withdrawal requests by up to twelve months.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Level 3 Gains and Losses

NOTE 5 - RELATED PARTY TRANSACTIONS and PARTY-in-INTEREST TRANSACTIONS

Certain plan investments are in pooled separate accounts and common collective trust funds managed by Principal Life Insurance Company and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, the custodians for the Plan assets. These transactions are allowable party-in-interest transactions. At September 30, 2024 and 2023, the fair value of these investments managed by the custodians totaled \$1,604,514 and \$1,482,135, respectively. Administrative expenses paid to Principal Life Insurance Company for the years ended September 30, 2024 and 2023, totaled \$4,040 and \$2,190, respectively. In addition, the investment advisor received indirect compensation via revenue sharing from investments held by the Plan, which is included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits.

As previously discussed, the Plan may issue notes receivable to participants that are secured by participant account balances. The value of the notes receivable outstanding were \$43,888 and \$20,638 as of September 30, 2024 and 2023, respectively. Interest income from participant loans was \$2,956 and \$1,710 for the years ended September 30, 2024 and 2023, respectively. All of these transactions qualify as party-in-interest transactions and are not prohibited transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

All of these party-in-interest transactions are exempt from the prohibited rules of ERISA.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's discretionary contributions and would receive a distribution equal to their account balance.

NOTE 7 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Plan which received an opinion letter on June 30, 2020, in which the IRS stated that the Non-Standardized Pre-Approved Plan, as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that as of September 30, 2024 and 2023, there were no uncertain tax positions requiring recognition or disclosure.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS and UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through March 19, 2025, which represents the date the financial statements were available to be issued.
