

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Pension Benefits**

An employee's retirement benefit normally becomes vested after completing five years of service. The amount of such benefit depends primarily on the length of service and the highest level of compensation during certain years of employment. In addition to normal retirement benefits at age 65, the Plan also provides, under certain conditions, for early retirement, spouses' benefits, death, disability, and termination benefits. The participants required benefit payment commencement date is the latter of April 1 following the calendar year in which the participant attains the age of 72 years or the first day of the month after the participant terminates employment and retires. Effective February 1, 2023 the Plan was amended in order to add language clarifying the Plan's existing cash-out language; incorporate a temporary lump-sum window provision for certain participants during the two month period beginning March 1, 2023 to April 30, 2023; increase the Plan's required commencement date in accordance with the SECURE 2.0 Act of 2022 and add language permitting the Plan to transfer benefit liabilities to an annuity provider at any time.

**Plan Administration**

The Plan is administered by a Board of Trustees. The Board of Trustees, in turn, has appointed a Plan administrator who oversees the day-to-day operation of the Plan.

**Plan Termination**

In October 2023, the Board of Directors approved to amend and terminate the Plan effective December 31, 2023. As part of the plan for liquidation, the Plan was amended to allow for a lump sum distribution or purchase of an annuity. In February 2024 notices of intent to terminate and notice to interested parties were mailed to participants. A request for an IRS determination letter has been submitted and so were required PBGC filings.

The Plan entered into group annuity contracts with Banner Life Insurance Company and William Penn Life Insurance Company of New York. The contracts provide for the purchase of annuities for separated participants for those participants electing this form of distribution option. During the year ended December 31, 2023, an amount of \$69,718,176 (net of \$2,015,000 adjustment included in other receivables) is included as Purchase of Annuities in the Statement of Changes in Net Assets Available for Benefits. The 2023 Statement of Net Assets Available for Benefits does not include as plan assets those assets paid to the insurance companies for payment of retiree vested benefits. These contracts have a liability assumption date and benefit commencement date of October 1, 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and others as necessary. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document.

**NOTE 3 ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to services rendered by the employees prior to March 15, 2002 (see Note 1). Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated employees or their beneficiaries; (b) beneficiaries of employees who have died; and (c) present employees or their beneficiaries. Benefits payable under all circumstances – retirement, death, disability and termination of employment – are included, to the extent they are deemed attributable to employee service rendered prior to March 15, 2002.

The Segal Group, Inc., an actuarial firm, estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal or retirement) between the valuation date and the expected date of payment. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuations been performed as of December 31, 2023, there would be no material differences.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

*Marketable corporate bonds and notes:* Corporate bonds are valued based on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

*Money market funds:* Valued at cost, which approximates fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Preferred stocks:* Valued at the closing price reported on the active market on which the individual securities are traded. The preferred stocks are deemed to be actively traded.

*Other investments:* Other investments consist primarily of municipal issues and foreign currency pending trades which are generally valued similar to marketable corporate bonds and notes.
