Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Missouri Prime Beef Packers, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation as of October 31, 2024 (liquidated), and the related statement of changes in net assets in liquidation for ten months then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the ten months ended October 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Terminating Plan

As discussed in Note 5 to the financial statements, the Company's ownership approved a plan liquidation on February 26, 2024, and the Company determined, therefore, that liquidation is imminent. As a result, the Plan changed its basis of accounting on February 26, 2024, from accrual basis of accounting to a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue for one year after the date that the financial statements are available to be issued. Management has determined that the Plan was fully liquidated during the audited period and, as such, the going concern evaluation is not applicable.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

As the Plan was fully liquidated during the audited period, a going concern assessment was not applicable.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

For the Period Ended October 31, 2024 and Year Ended December 31, 2023

Note 1: Description of the Plan

The following description of the Missouri Prime Beef Packers, LLC 401(k) Plan (the Plan), provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established January 1, 2021, covering employees of Missouri Prime Beef Packers, LLC (the Company). Employees are eligible to begin deferring contributions on the first day of the calendar month after attaining age 18 and completion of 60 days of service. Employees are eligible for company matching contributions by meeting the same requirements. Employees must have 1,000 of service in the Plan year and be employed on the last day of the Plan year to receive a profit sharing contribution, unless termination is due to retirement, death or disability. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participating employees may elect to contribute a percentage up to the maximum allowed by law of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis. Participants are eligible to make after tax (Roth) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a fixed income fund, and one money market fund to Plan participants.

Employer Contributions

The Company may make a safe harbor matching contribution equal to a uniform percentage of the employee's salary deferral. The Company will match 100% of the first 3% of participants contributions and 50% of the next 2% of participants contributions for the presented Plan years.

At the end of the Plan year, the Company, at the discretion of the Company's management, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has elected not to provide a profit sharing contribution for the 2024 and 2023 Plan years. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings. Employer matching contributions are allocated to the participant based on a percentage of the participants' salary deferral contributions. Discretionary profit sharing contributions are allocated based on a participant's respective share of eligible compensation to the total eligible compensation. Income is allocated daily based on each participant's share of the account. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their employee contributions and the safe harbor match plus actual earnings thereon. That portion of the participant's account attributable to non-elective contributions at a rate of 20% per year starting with the second year of service. A participant is fully vested after the completion of six years of credited service. The Plan elected to become a safe harbor plan. Safe Harbor matching contributions are immediately 100% vested. Notwithstanding the above, a participant becomes 100% vested in his/her account upon attaining age 65 during the Plan year, death or disability.

Participant Loans

The Plan does not permit participants to borrow against their accounts.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum amount or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. Under the current Plan, distributions for terminated participants will be made as soon as administratively feasible. Participant consent is required if the balance exceeds \$5,000. For automatic distributions of participant account balances greater than \$1,000 up to \$5,000, the accounts are rolled directly to individual retirement accounts. The Plan also allows for in-service and hardship distributions subject to Plan provisions.

Forfeitures

Forfeitures represent the non-vested portion of participant account balances upon termination. Forfeitures of Company matching funds are used to pay administrative expenses and reduce employer contributions to the Plan for the following plan year. Amounts forfeited during the periods ended October 31, 2024 and December 31, 2023 were \$0 and \$0, respectively. Adjustments of \$1,470 were made during the ten months of 2024, which were transferred to the forfeiture account. In 2024, \$2,667 of the adjustments in the forfeiture account were used to reduce the employer expenses and employer contributions. The forfeiture account balance at October 31, 2024 and December 31, 2023 was \$0 and \$1,170, respectively.

Note 2: Summary of Accounting Policies

Basis of Accounting

The 2024 and 2023 financial statements of the Plan have been reported using the liquidation basis of accounting in accordance with accounting principals generally accepted in the United States of America. The liquidation basis of accounting is required when the plan sponsor has determined the Plan will not continue and liquidation of the Plan is imminent. Additional information located in Note 5.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of October 31, 2024 and December 31, 2023, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expense are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by Voya Retirement Insurance and Annuity Company (the Custodian) as of the Plan's year end. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

Note 3: Fair Value Measurements (Continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at October 31, 2024 and December 31, 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Account

The fair value of the Plan's pooled accounts are valued daily at their net asset values (NAV). This account offers options from multiple providers that are managed in one account. Fixed accounts held by the Custodian are also valued at NAV daily pricing and are held in the insurance company's general account.

Insurance General Account

The fair value of the Plan's insurance general account are determined by the daily crediting of interest subject to a minimum rate in the contract. Investment transfers to and from the account, and withdrawals to pay participant benefits are made at contract value.

Note 4: Related Parties and Parties in Interest

The Company absorbs a portion of the Plan's administrative fees, the cost of audit fees related to the Plan and the cost of fidelity bonds. As the Plan does not reimburse the Plan Sponsor for the costs of such services, they are not included in these financial statements.

Voya performs the duties of third-party administrator and recordkeeper. Investment related fees are paid to the recordkeeper by the investment Custodian.

Administrative functions are performed by officers or employees of the Plan Sponsor. Additional party-in-interest transactions include the advisor fees paid to Marsh McLennan Agency. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

On February 26, 2024, Central Packing Supply LLC, 100% owner of the Company announced its intention to close MO Prime Beef Packers, LLC and terminate the 401(k) Plan. All employees were terminated 60 days after the announcement. Effective May 15, 2024 the Plan was terminated in accordance with the provisions of the Plan document. As a result of the termination, all participants became fully vested in their account balances. The Plan's assets were liquidated and distributed to participants or their beneficiaries in accordance with the Plan's provisions and applicable regulations. At October 31, 2024, all distributions of participant accounts had been completed. There were no other assets awaiting disposal.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 1, 2021 for VOYA, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8: Reconciliation of Financial Statements to Form 5500

The statements of net assets in liquidation and the statements of changes in net assets in liquidation reconcile to Schedule H of Form 5500 for the periods ended October 31, 2024 and December 31, 2023.

Note 9: Information Prepared and Certified by the Custodian (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held at October 31, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the period and year then ended was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

Note 10: Subsequent Event

The Plan Administrator has evaluated subsequent events through April 14, 2025, the date on which the financial statements were available to be issued.
