INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Easter Seals of San Antonio 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Easter Seals of San Antonio 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended August 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section—

NOTE A - DESCRIPTION OF PLAN

The following brief description of the Easter Seals of San Antonio 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for complete information regarding the Plan’s definitions, benefits, eligibility and other matters.

General

The Plan is a defined contribution plan that covers all employees of Easter Seals Rehabilitation Center, Inc. (the Company) that are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustee and custodian of the Plan is John Hancock Insurance Company (the “Trustee”).

Eligibility

Employees of the Company are eligible to participate in the plan when hired.

Contributions

Employee

Each year, participants may contribute to the Plan an amount up to 100% of their annual compensation as pre-tax or Roth after-tax contributions. However, each participant’s annual contribution shall not exceed the maximum amount allowed for deferral as set forth by the Internal Revenue Code (the “IRC”), which was \$23,000, \$22,500 and \$20,500 for calendar years 2024, 2023 and 2022, respectively. In addition, participants over age 50 were allowed to contribute an additional \$7,500, \$7,500 and \$6,500 for calendar years 2024, 2023 and 2022, respectively. The amount of a participant’s annual compensation that may be taken into account for purposes of determining the Company’s matching contribution for any purpose under the Plan shall not exceed an amount prescribed annually by the IRC. Participants may also rollover amounts from other qualified defined benefit or defined contribution plans.

Employer

The Company may contribute a discretionary amount per Plan year at the option of the Company’s board of directors. This contribution is not subject to vesting restrictions. No employer contributions were made during the years ended August 31, 2024 and 2023.

If during any Plan year, it is determined that a participant’s contribution exceeded the maximum allowable amounts as defined by IRC, the contribution is refunded and the matching contribution is applied against future Company contributions.

Vesting

Participants are immediately vested in their contributions (including rollovers) plus actual earnings thereon as well as any discretionary contributions provided by the employer.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations

are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment into the Plan, a participant may direct their contributions to purchase any of the investment options offered by the Trustee of the Plan. Participants may change the allocation of their existing funds and future contributions at any time.

Note Receivables from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms shall be no more than five years except that if proceeds of a loan are used to acquire a dwelling to be used as a Participant's principal residence, the Administrator may permit a longer repayment period. The Administrator will determine the interest rate a loan shall bear in accordance with all applicable legal requirements. The interest rate shall remain fixed throughout the duration of the loan.

Payment of Benefits

Participants whose employment terminates for any reason (except death or disability) are generally entitled to receive the vested portion of their account in the form of a lump sum distribution payable in cash. Upon termination, the participant may request a distribution be made or for their balance to be rolled into another plan as soon as is administratively feasible. Any balance under \$5,000 is automatically paid out. Hardship withdrawals are permitted if the participant meets the eligibility requirements of the Plan.

Expenses

Expenses relating to the purchase or sale of investments are included in the cost or deducted from the proceeds, respectively. Direct charges and expenses, including administrative and investment manager fees attributable to specific investment funds, may be charged against that investment fund and are allocated to participant accounts based on the total participant balance relative to the total fund of the entire plan. Other administrative expenses such as Trustee transaction fees are allocated directly to the participant account who is responsible for the transaction. Expenses, such as covering the cost of the Plan's financial audit, that are paid by the Company are excluded from these financial statements.

Forfeitures

Participants are fully vested in all contributions, employee and employer, as such, forfeitures are minimal. In the unlikely event forfeitures occur, they will be used to reduce future Employer's discretionary contributions to the Plan.

Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan is being operated in compliance with the applicable requirements of the IRC and is in compliance as of the financial statement date.

Accounting principles generally accepted in the United States of America (“GAAP”) require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of August 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan monitors significant events occurring after August 31, 2024 and prior to the issuance of the financial statements to determine the impacts, if any, of events on the financial statements to be issued. The Plan has evaluated subsequent events through April 4, 2025, the date which the financial statements are issued, and has determined there are no subsequent events that would impact the financial statements.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with GAAP.

Valuation of Investments

The Plan’s investments are stated at fair value. Shares of mutual funds are valued at quoted market prices as of the last trading day of the Plan year. Reinvested income, accrued interest and dividends are reflected as additions to the cost basis of the investments. Investment transactions are recorded on a trade-date basis. Interest income is recorded when earned and dividend income is recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized gains or losses on investments sold during the year and the unrealized appreciation (depreciation) on those investments held at the end of the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE B - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with GAAP, as applied to defined contribution employee benefit plans, requires the Plan’s management to make estimates and assumptions that affect the amounts reported in these financial statements and accompanying notes. Actual results could differ from those estimates.

Future Accounting Pronouncements

The Plan is currently evaluating the implications of the Secure 2.0 Act and its effects on the Plan. Current implementation is being designed as necessary for applicable components of the Secure 2.0 Act.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan subject to the provisions of ERISA.

NOTE D - RELATED PARTIES AND PARTIES – IN – INTEREST

The Trustee of the Plan is a party-in-interest as defined by ERISA. The Trustee invests certain Plan assets in common/collective trust funds, mutual funds and money market funds managed by the Trustee or its affiliates, and such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. Amounts paid to the Trustee of the Plan, registered investment advisors and other service providers for the year ended August 31, 2024 was \$48,421. These transactions are party-in-interest transactions under ERISA.

NOTE E – INFORMATION CERTIFIED AND PROVIDED BY JOHN HANCOCK INSURANCE COMPANY

The following is a summary of the Plan’s asset information as of August 31, 2024 and 2023, and for the year ended August 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, that was prepared or derived from information certified and provided by John Hancock Insurance Company, the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets:

John Hancock Insurance Company also certified as to the completeness and accuracy of \$1,011,637 of net appreciation in fair value of investments and \$5,167 of interest income related to the note receivables from participants for the year ended August 31, 2024.

NOTE F - FAIR VALUE MEASUREMENTS

In accordance with GAAP, the Plan's assets and liabilities, which are carried at fair value, are classified in one of the following three categories:

Level 1 – Quoted prices in active markets for identical investments.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 – Unobservable inputs that are not corroborated by market data.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for instruments measured at fair value.

Mutual Funds

These investments are valued at quoted market prices as of the last trading day of the Plan year and are classified within Level 1 of the fair value hierarchy. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets or liabilities measured at fair value on a nonrecurring basis as of August 31, 2024 or 2023, and there were no changes in the valuation methodologies between these periods.

The following tables present the fair value of investments, measured on a recurring basis, as of August 31, 2024 and 2023, respectively, by the fair value hierarchy described above. The Plan had no investments classified as Level 2 or 3 at August 31, 2024 or 2023, respectively.
