INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Eldridge Media Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Eldridge Media Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets in liquidation available for benefits as of August 30, 2024 and December 31, 2023, and the related statement of changes in net assets in liquidation available for benefits for the period ended August 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of August 30, 2024 and December 31, 2023 and for the period ended August 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As discussed in Note 1 to the financial statements, on August 30, 2024, substantially all of the Plan's assets were transferred into another Plan, as a result of a Plan merger, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements in accordance with accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter. We also draw your attention to Note 2, which describes the basis of accounting.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The supplemental schedule, The Schedule of Delinquent Participant Contributions for the period ended August 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Eldridge Media Group 401(k) Plan (the “Plan”) provides only general information. The Plan was formerly known as MRC 401(k) Plan but changed its name to Valence Media 401(k) Plan effective in 2022. Effective January 1, 2024, the Plan changed its name to StarVista Live, LLC 401(k) Plan, and then effective March 15, 2024, the Plan changed its name again to Eldridge Media Group 401(k) Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan with a 401(k) provision covering all employees of Eldridge Media Group (the “Company” and “Employer”). Employees become eligible to participate upon hire, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Plan Termination/Merger. On August 30, 2024, substantially all Plan’s assets were merged into another Plan. Residual amounts were distributed to participants and paid to vendors through August 30, 2024.

Contributions. Participants may elect to defer up to 100% of eligible annual pre-tax compensation subject to maximum amounts established by the Internal Revenue Code (the “Code”). Additionally, participants may also contribute after-tax (“Roth”) contributions. Participant contribution elections may be changed upon notice to the Plan’s administrator (“Plan Administrator”). Employees are automatically enrolled as a participant with a deferral of 3% of pretax annual compensation upon becoming eligible, unless the employee affirmatively elects otherwise.

The Company may make discretionary Employer matching contributions based on a percentage declared for the period by the Board of Directors. Discretionary Employer matching contributions were 50% of each 1% of employee deferrals for a maximum Employer match of 3% of employee deferrals that was fully covered by forfeitures for the period ended August 30, 2024. Additional amounts may be contributed at the option of the Company’s board of directors as profit-sharing contributions. Discretionary Employer profit-sharing contributions, if applicable, are allocated as of the last day of the Plan year. There were no discretionary Employer profit-sharing contributions elected for the period ended August 30, 2024.

Participants’ Accounts. Each participant’s account is credited with the participant’s contribution and allocation of the Employer contributions, Plan earnings, and expenses. Allocations are based on participant earnings or account balances, as defined in the Plan.

Investment Options. Employees may direct their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to Plan provisions.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts plus actual earnings thereon is based on years of credited service. All active participants hired on or after February 15, 2021, fully vest after one year of service. All active participants hired on or before February 15, 2021, vest immediately. All terminated participants without an hour of service on or after February 15, 2022, become 33% vested after one year of service, increasing by 33% for each additional year of service until year 3 when the participant is 100% vested. However, if an active participant dies or becomes disabled prior to attaining the normal retirement age, the participant’s account becomes 100% vested.

Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 and up to 50% of their vested account balance, provided that such loan does not exceed \$50,000. The loans are secured by the balance in the participant’s account and bear interest at the local prevailing rates, fixed at the time of issuance, as determined periodically by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Forfeited Accounts. Forfeited balances of terminated participants' non-vested accounts are used to reduce Plan administrative expenses or future Employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeited nonvested accounts totaled \$0 and \$295,309 as of August 30, 2024 and December 31, 2023, respectively. Forfeitures totaling \$48,287 for the period ended August 30, 2024 were used to offset Plan's administrative expenses and Employer contributions. In 2024, the remaining forfeiture balance of \$287,185 was transferred out to the other Plan(s) due to Plan termination see Note 1.

Party-In-Interest Transactions. Substantially all expenses pertaining to the operation of the Plan are paid by the Company. Additionally, various administrative, legal, and accounting services are performed by Company personnel on behalf of the Plan for which no charges are made to the Plan, and for which the Company does not intend to obtain reimbursement. Investment expenses are charged against the Plan's investment income. Certain Plan investments are shares of mutual funds managed by a related party to Fidelity Management Trust Company, the "Trustee" of the Plan, and therefore these transactions qualify as party-in-interest transactions.

Payment of Benefits. Benefit payments are generally made in a lump-sum upon termination or as defined in the Plan agreement. Early voluntary withdrawals are paid based on financial hardship with approval of the Plan Administrator.

Recent Legislation. In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The Internal Revenue Service ("IRS") has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements are presented on the liquidation basis of accounting.

Estimates and Assumptions. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Concluded)

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits. Benefits are recorded when paid.

Concentration of Credit Risk. Substantially all the Plan's assets were held by the Trustee which is qualified institution pursuant to ERISA.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements that were prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Trustee that such information is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets in liquidation available for benefits as of August 30, 2024 and December 31, 2023.
- Investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets in liquidation available for benefits for the period ended August 30, 2024.
- Note 4: All investment balances.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FAIR VALUE MEASUREMENTS (Concluded)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of August 30, 2024 and December 31, 2023.

Mutual Funds and Money Market Accounts. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

NOTE 5 – TAX STATUS

The Plan uses a prototype plan document sponsored by the Trustee. The Trustee received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and was operated in compliance with the applicable requirements of the Code.

NOTE 6 – DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company remitted participant deferrals and loan repayments totaling \$2,690 to the Trustee later than required by the Department of Labor ("DOL") Regulation 2510.3-102 during the period ended August 30, 2024 ("Late Remittances"). The DOL considers Late Remittances to be prohibited transactions. The Company corrected the 2024 late remittances in 2024. Participant accounts were credited with the amount of investment income which would have been earned had the participant deferrals and loan repayments been remitted on a timely basis. The related excise taxes were also remitted.

NOTE 7 – SUBSEQUENT EVENTS

Management has evaluated all known subsequent events from August 30, 2024 through February 20, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that were not disclosed in the notes to the financial statements.
