Notes to the Financial Statements For the Year Ended September 30, 2024 and 2023

Note 1 – Plan Description and Related Information

The following description of the Sunshine Mills Group 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution 401(k) plan with a profit sharing feature – ERISA section 404(c) plan covering the employees of Sunshine Mills, Inc. (the “Company”) and four affiliated employers, Sunshine Mills of Virginia, Inc., Sunshine Pet Treats, Inc., World Pet Care, LLC, and Red Collar, who have one year of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendment - Following the close of business on October 16, 2023, the Company acquired a manufacturing plant located in Joplin, MO from Red Collar Pet Foods, Inc., with the location and their employees merging with and into the Company on October 17, 2023. Following the acquisition, the Plan was amended to provide credit, for vesting and eligibility purposes, for all employees of the Joplin, MO location as of October 17, 2023. In regards to the employees’ retirement account balances with Red Collar Pet Foods, they have three options; 1) rollover balances to the Sunshine Mills Profit Sharing Plan, 2) rollover balances to an IRA, or 3) receive a disbursement subject to taxes and penalties per IRS regulations. As part of this acquisition, \$16,448 was recognized in the Statement of Changes in Net Assets Available for Benefits as “transfers from another trust.” In addition, the Plan recognized \$4,214 in notes receivable from participants, which were related to loans to participants in the Trust transferred in.

Plan Administration - Sunshine Mills, Inc. is the plan administrator. The plan administrator has the full power to decide what the plan provisions mean; to answer all questions about the Plan, including those about eligibility and benefits; and to supervise the administration of the Plan.

Eligibility and Contributions - All employees become eligible to participate in the Plan after completing at least 1,000 hours of service during either the first 12 months of employment or any plan year beginning after the employee’s hire date and upon reaching age 18 or older. Employees can enroll in the Plan on the January 1, April 1, July 1 or October 1 entry dates following the completion of the service requirement.

Participants may voluntarily contribute up to 50% of their compensation to the Plan, subject to annual limitations under the Internal Revenue Code. These elective contributions are made under Section 401(k) of the Internal Revenue Code which allows a deferral of income taxes on the amounts contributed to the Plan. Participants are permitted to deposit into the plan rollover proceeds from qualified plans. Under the Plan, the Company may make a discretionary matching and profit sharing contribution at the discretion of the Board of Directors. The Company made profit-sharing contributions of \$2,396,151 in the plan year ended September 30, 2024.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account is based on continuous years of service as outlined below:

Participant Accounts - A separate account is established and maintained for each participant. Each participant's account is credited with the participant's deferral contributions, the Company's matching contribution, the Company's discretionary profit sharing contributions that are allocated based on the ratio of each participant's eligible compensation to the total eligible compensation for all participants entitled to an allocation, and plan earnings that are allocated to the individual accounts in the same ratio that the value of each account, as of the last valuation date, bears to the total value of all accounts as of the same date. The Plan currently offers various mutual funds and a common and collective trust as investment options. All participant accounts are self-directed.

Notes Receivable from Participants – Notes receivable from participants reported on the Statements of Net Assets Available for Benefits are related to notes receivable from participants transferred to the Plan through the Company's acquisition of Red Collar Pet Foods, Inc. Per Plan provisions, the Plan does not allow new participant loans.

Payment of Benefits - The Plan provides for distributions to participants upon retirement, death, disability, or termination of employment. A participant will automatically receive a lump-sum amount equal to the value of his or her vested account if the account value is \$1,000 or less. If the vested balance is greater than \$1,000, but not more than \$7,000, the participant can elect to receive a lump sum distribution or roll it over to an eligible retirement plan. If the vested balance is greater than \$1,000, but not more than \$7,000, and the participant does not elect to receive the distribution or roll it over to an eligible retirement plan, the plan administrator will automatically roll over the distribution to an individual retirement account established by an IRA provider selected by the Company. If the vested account balance exceeds \$7,000, the participant can elect to receive a lump sum distribution or installment payments over a specified period of time.

Forfeited Accounts - Forfeited amounts are used to either offset plan administrative expenses or to reduce employer contributions under the Plan. For September 30, 2024, \$122,731 was allocated to reduce employer contributions and \$0 to pay plan expenses. Forfeited non-vested accounts totaled \$122,731 and \$67,647 at September 30, 2024 and 2023, respectively.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 2 – Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisors, trustee, and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants on a timely basis in accordance with regulations.

Payments of Benefits – Benefit payments are recorded when paid.

Note 3 – Information Certified by Reliance Trust, Trustee

Certain information related to investments in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation or depreciation in fair value of investments, interest and dividends for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust (the trustee of the Plan) as of and for the year ended September 30, 2024.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on September 30, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts – Valued at the NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

The Plan administrator believes that the Plan is designed, and is currently operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

For the year ended September 30, 2024 and 2023, there were no reconciling items between the financial statements and the Form 5500.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 9 - Subsequent Events

All subsequent events were evaluated by management through April 4, 2025, the date the financial statements were available to be issued.
