The Plan's assets were distributed in accordance with the election of each individual participant and all distributions were completed by the end of November 2019.

1. Description of the Plan

The following description of the Chariot Transit Inc., 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which provides retirement benefits for all full time employees of Chariot Transit Inc. (the "Company"), effective November 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan Sponsor is the Company. The Plan has given Reliance Trust Company (the "Trustee"), the authority to hold the assets of the Plan and to invest, control and disburse all assets of the Plan in accordance with the Plan agreement.

The Plan was created effective November 1, 2018 and included employees of Chariot Transit Inc. The Company ceased operations in February 2019 and the Plan was terminated effective April 2019. All Plan assets were distributed by the end of November 2019. See further discussion regarding Plan termination in Note 8.

The following provisions of the Plan agreement were in place prior to termination.

Participation

All employees with the exception of union employees, and certain nonresident aliens, of the Company are eligible to participate in the Plan on their date of hire, unless they decline to participate.

Contributions

Each year, participants may defer a percentage of their compensation, as defined by the Plan agreement, on a pre-tax basis from 1% up to 90% of the participant's compensation and should not exceed certain limits established under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) and Roth contributions.

The Company may make a matching contribution equal to a uniform percentage of an employee's elective deferrals. The Company will determine the amount of the discretionary matching percentage each year. The Company elected not to make any matching contributions in the 2018 Plan year. The Company elected a fixed uniform rate for matching contributions. The Company made a matching contributions equal to 50% of the participant's elective deferrals with a matching limit of 5% of a participant's compensation. The Company may make additional discretionary nonelective contributions to the Plan, which is allocated to eligible participant accounts. The Company elected to not make any additional discretionary contributions for the period ended November 30, 2019 and December 31, 2018.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and the participant's share of Plan earnings and charged with an allocation of Plan losses and administrative expenses. Allocation of Plan earnings are based on the participant's proportionate share of total compensation of all participants eligible to share. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's matching and profit sharing contribution portion of their accounts is based on years of service in accordance with the following schedule:

Since the Plan has terminated, all participants are fully vested in their participant accounts and the Trustee has distributed the assets in the Plan to participants in proportion to the respective account balance.

Forfeited Accounts

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are first used to pay administrative expenses and then to reduce employer contributions. During the period from January 1, 2019 through November 30, 2019 and November 1, 2018 through December 31, 2018 2019 and 2018, respectively, \$2,057 and \$-0-, of forfeitures were used to pay employer contributions.

Payment of Benefits

Upon termination of employment, death, retirement or total disability, distributions are generally made in the form of a single lump-sum payment, installments or partial withdrawals. If the participant's vested account balance does not exceed \$5,000, then the vested balance may only be distributed in a single lump-sum payment. In addition, the Plan includes a provision for participants to request an in-service distribution under certain hardship circumstances or after attaining age 59 ½, as defined by the Plan agreement. The minimum amount a participant can receive as an in-service distribution is \$500. Additionally, the Plan includes a provision for participants who are a qualified member of the reserves to be eligible to request a qualified reservist distribution, as defined by the Plan agreement. A qualified reservist distribution is an exception to Plan restrictions on withdrawal of elective deferrals.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's vested account. Interest rates are based on the Prime Rate plus 1%. Loan terms may extend past five years only in the event the loan proceeds are used to purchase or construct the participant's principal residence. Principal and interest is paid ratably through payroll deductions. If a participant terminates employment with the Company, the participant must contact the Administrator for repayment options. There were no loans outstanding at November 30, 2019 and December 31, 2018.

2. Summary of Significant Accounting Policies

Basis of Accounting

Since the Plan was terminated in 2019 and liquidation was imminent, the Plan has changed its basis of accounting from an ongoing plan basis used in presenting the 2018 financial statements to the liquidation basis used in presenting the 2019 financial statements.

The financial statements of the Plan are prepared on the accrual basis of accounting and in accordance with principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2019. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events

The Plan has evaluated subsequent events through April 26, 2021, the date the financial statements were available to be issued. Management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

4. Fair Value Measurements

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - The Plan's investments include an investment in the Putnam Stable Value Retirement Trust (the "Fund"), a collective trust fund. The Fund's key objectives are to seek preservation of principal and achieve high current income through a diversified portfolio. A stable value fund is valued at the NAV of units of a collective trust. The NAV is calculated by the Fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. The NAV represents the Plan's fair value since this is the amount which the Plan transacts with Fund and is used as a practical expedient to estimate fair value.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The tables below set forth the Plan's investments by level within the fair value hierarchy at December 31, 2018. There were no investments in the Plan as of November 30, 2019. There have been no significant transfers into or out of Levels 1, 2, or 3.

5. Party in Interest Transactions

Fees incurred by the Plan for the investments management services are included in net appreciation (depreciation) in fair value of mutual funds transactions and qualify as party-in-interest transactions. Notes receivables from participants and fees paid by the Plan also qualify as party-in-interest transactions.

6. Tax Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Services ("IRS") effective July 16, 2014 that the Plan, as designed, was in compliance with the applicable requirements of the IRC. The Plan has not individually sought its own determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

8. Plan Termination

The Chariot Transit Inc. 401(k) Plan was terminated effective April 30, 2019 as a result of the Company ceasing operations in February 1, 2019. Immediately following the Plan's termination, Plan participants became fully vested.

The Plan's assets were distributed in accordance with the election of each individual participant, including, but not limited to (if eligible), a qualifying rollover into an Individual Retirement Account ("IRA") of the participant's choice, or a cash distribution to the participant. If a participant failed to make an affirmative distribution election, such participant's assets were distributed automatically to an IRA with Millennium Trust in November 2019. The Plan's assets were distributed in their entirety by the end of November 2019.
