INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Automation Components, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Automation Components, Inc. 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the ten-month period ended October 31, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the ten-month period ended October 31, 2024 and as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter - Plan Merger

As described in Note 1 to the financial statements, the plan sponsor was acquired by Dwyer Instruments, LLC in December 2023. In May 2024, the plan was merged into the DwyerOmega Safe Harbor 401(k) Plan. All net assets of the plan were transferred to the DwyerOmega Safe Harbor 401(k) Plan during the ten-month period ended October 31, 2024.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Automation Components, Inc. 401(k) Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Plan merger - The plan sponsor was acquired by Dwyer Instruments, LLC in December 2023. In May 2024, the plan was merged into the DwyerOmega Safe Harbor 401(k) Plan. All net assets of the plan were transferred to the DwyerOmega Safe Harbor 401(k) Plan during the ten-month period ended October 31, 2024.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to October 31, 2024 through March 31, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - Automation Components, Inc. was the plan sponsor, employer and the plan administrator. First Business Bank was the trustee, investment advisor and investment agent of the plan assets that maintained plan and participant records and had custody of plan assets and the third party administrator that performed various compliance tests as tax counsel. First Business Bank engaged Charles Schwab Trust Bank as a sub-custodian for the plan to hold and safeguard the plan's investment assets and engaged EPIC Plan Retirement as the plan's record keeper.

Investments - The plan sponsor determined the investments available to plan participants. The participants allocated their contributions and transferred existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in the fair value of investments bought, sold and held during the year/period are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - The plan invested in mutual funds that were valued at the daily quoted market prices as reported by the fund. The mutual funds that were held by the plan were registered with the U.S. Securities and Exchange Commission, were required to publish their daily net asset value ("NAV"), and were deemed to be actively traded.

Common/collective trust - The plan invested in the Federated Investors Trust Company Capital Preservation Fund. The fund is a direct filing entity valued at NAV based on the underlying unit value of the common/collective trust. The NAV was used as a practical expedient to estimate fair value. The NAV was generally based on the fair value of the underlying unit value as reported by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the common/collective trust would sell the investment for an amount different than the reported NAV.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on January 1, 1997 as a defined contribution profit sharing plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Eligible employees could participate in the plan and could make elective deferral contributions once they had reached the age of twenty and had completed 166 hours of service during their first two months of employment. If the hours of service requirement was not met during the first two months of employment, employees would have been eligible to make elective deferral contributions after one year of service. Employees could begin making elective deferral contributions on the first day of the calendar quarter immediately following the meeting of the eligibility requirements. Employees were eligible to receive employer discretionary matching and employer additional discretionary contributions after they completed one year of service with at least 1,000 hours of service during the year. Upon meeting the eligibility requirements, employees could begin participating in discretionary employer matching and employer additional discretionary contributions on the January 1 or July 1 immediately following meeting the eligibility requirements.

Contributions - Contributions were recorded in the year in which eligible compensation was paid. Contributions to the plan could be made in the following ways:

- a. Participants could contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). Roth elective deferral contributions were also allowed under the plan. Contributions to the plan ceased effective April 1, 2024.
- b. Rollover contributions were accepted by the plan from other qualified plans.

- c. The employer made discretionary matching contributions equal to 50% of the first 6% of compensation contributed to the plan as elective deferral contributions in 2024 and 2023. Employer matching contributions were made following the end of each quarter and participants were required to be employed on the last day of the quarter to receive a matching contribution. These requirements were waived upon death, disability or attainment of normal retirement age.
- d. The employer could also make additional discretionary contributions. No additional employer discretionary contributions were made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), were allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account was credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants were allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participants were always 100% vested in their elective deferral and rollover contributions and related earnings. Participants became 25% vested in their employer contributions and related earnings upon completion of two years of service. The participant's vesting then increased at the rate of 25% per year thereafter. Upon death, disability or qualified retirement, participants became 100% vested.

Payment of benefits - Benefits were recorded when paid. Benefit payments could have commenced upon termination of employment, death, disability or normal retirement age. Distributions were made in the form of a single lump sum. In addition, hardship withdrawals were permitted under certain circumstances and in-service withdrawals could have commenced upon attaining the age of 59½.

Administrative expenses - Certain administrative fees of the plan were paid by the plan sponsor. Certain other administrative fees were paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses included participant directed charges for distribution and loan fees and nonparticipant directed charges for service and administrative and investment management fees. Nonparticipant directed fees were allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts could have been used to reduce employer contributions, pay plan fees, or be reallocated to eligible participants. No forfeitures were used during 2024. There were \$5,000 of forfeitures used in 2023. There were no unapplied forfeitures as of October 31, 2024. Unapplied forfeitures were \$2,000 as of December 31, 2023, which were transferred to the DwyerOmega Safe Harbor 401(k) Plan during the ten-month period October 31, 2024.

Notes receivable from participants - Participants could take out loans against their account and were allowed to have one loan outstanding at any time. The minimum loan amount was \$1,000 and total outstanding loans could not exceed the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term generally could not exceed 5 years unless used for the purchase of a principal residence. The notes receivable from participants were valued at their unpaid principal balances plus any accrued but unpaid interest, which approximated fair value. The loan balances on July 10, 2024 were transferred to the DwyerOmega Safe Harbor 401(k) Plan.

3. PARTY-IN-INTEREST TRANSACTIONS

First Business Bank performed administrative services for the plan. First Business Bank acted as trustee of the plan and, therefore, these transactions qualified as party-in-interest transactions. First Business Bank received indirect compensation from mutual fund service providers for services they provided to the funds. The compensation received by First Business Bank was used to offset amounts that would otherwise be owed by the plan to First Business Bank. Direct fees paid to First Business Bank were \$18,000 in 2024 and \$69,000 in 2023.

Notes receivable from participants' transactions also qualified as party-in-interest transactions.

All of the above party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

4. INCOME TAX STATUS

The plan adopted a First Business Bank Pre-Approved Profit Sharing Plan. The pre-approved plan received a favorable opinion letter on June 7, 2021, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and First Business Bank believe that the plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of October 31, 2024 and December 31, 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. INFORMATION CERTIFIED BY THE TRUSTEE

Management has obtained certifications from First Business Bank, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held for the plan and the fair values of such as of October 31, 2024 and December 31, 2023;
- b. Notes receivable from participants as of October 31, 2024 and December 31, 2023 and interest income on notes receivable from participants during the ten-month period ended October 31, 2024 and during the year ended December 31, 2024;
- c. Dividends and interest income and net appreciation (depreciation) in fair values of investments for the period ended October 31, 2024 and for the year ended December 31, 2023;
- d. Purchases and sales of investments during the period ended October 31, 2024 and the year ended December 31, 2023; and
- e. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during the period ended October 31, 2024 and the year ended December 31, 2023.
