As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Safe-Harbor 401(k) Profit Sharing Plan for Employees of Human Services Association (the Plan) is provided for general information purposes only. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, as defined under Section 401(k) of the Internal Revenue Code (IRC). The Plan's purpose is to provide a cash or deferred benefit arrangement for participants and their beneficiaries. The Plan was established on July 1, 1998.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of Human Services Association (the Organization) are eligible to participate in the Plan upon completion of 1 year of service and attainment of age 21. A year of service is defined as 1,000 hours worked.

Employees are eligible to participate in employer contributions if they have met these same age and service requirements.

Participant Contributions

Participants may contribute any amount up to 100% of eligible compensation each pay period provided they do not contribute more than the maximum allowed by the IRC. A participant who is age 50 or older before the end of the plan year can contribute an additional catch-up contribution to the Plan up to limits as allowed by the IRC. Additionally, participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Effective July 1, 2022, the auto-enrollment feature was increased from 1% to 3% of eligible compensation.

Employer Contributions

The Organization's safe-harbor matching contribution to the Plan on behalf of each participant for each plan year is equal to 100% of the amount of that participant's salary deduction contributions for the plan year up to 6% of eligible compensation.

Participant Accounts

Each participant's account is credited (charged) with (a) the participant's contributions and allocations, (b) the Organization's safe-harbor matching contributions, (c) investment earnings or losses, (d) administrative expenses and (e) rollover contributions. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Investment Programs

Participants can direct the investment of their accounts (including the Organization's safe-harbor matching contributions) among any of the available funds daily. The available funds as of June 30, 2024 are listed in the supplemental schedule of assets (held at end of year). The available funds are regularly reviewed by the Organization and are subject to change at any time.

Vesting

Participants are immediately 100% vested in their contributions and the Organization's safe-harbor matching contributions, plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, separation of employment, or retirement, a participant may elect to receive either a lump-sum distribution, partial payment or installments. Participants may also elect to rollover the balance to another qualified benefit plan. While employed by the Organization, participants may request in-service or hardship withdrawals as defined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by any current outstanding loan balance. Loan terms range from one to five years, or up to ten years if the purpose of the loan is to acquire a primary residence. The loans are secured by the balance in the participant's account and bear a fixed interest rate based on the current prime rate. Principal and interest are paid ratably through bi-weekly payroll deductions. The loan will be deemed a distribution if the participant fails to repay the loan per the provisions of the original loan agreement.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments in various mutual funds and pooled separate accounts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The interest accumulation account is stated at contract value, see disclosures in Note 5.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Organization and excluded from these financial statements. Administrative expenses paid by the Plan in accordance with the Plan document are recorded as deductions in the statements of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses had been recorded as of June 30, 2024 and 2023. If a participant separates from service or ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the remaining loan balance will be treated as a taxable distribution after a cure period as defined by the Plan's loan policy. Plan loans in default are offset against vested balances upon separation from service that triggers a distribution.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE AND CUSTODIAN (UNAUDITED)

Mutual of America Life Insurance Company (Mutual of America), the custodian, held the Plan assets as of and for the year ended June 30, 2023 and for the period July 1, 2023 through September 30, 2023. Ascensus Trust Company, the trustee, held the Plan assets as of June 30, 2024 and for the period from October 1, 2023 through June 30, 2024.

NOTE 4 FAIR VALUE MEASUREMENT

The Plan follows Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*. ASC Topic 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENT (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Pooled Separate Accounts: Valued by the insurance company at the separate account's net asset value (NAV) based on the aggregate unit value of shares held by the Plan. The NAV, as published daily by the custodian, is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. The underlying securities in pooled separate accounts are typically actively traded fixed income and equity mutual funds that are valued at the daily closing price of the security.

Money Market Mutual Funds: Money market mutual funds aim to maintain a level NAV of \$1 per share. Any excess earnings generated through interest on the portfolio holdings are distributed to the investors as dividend payments.

Mutual Funds: Valued at the daily closing price as reported by the fund. These securities are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INTEREST ACCUMULATION ACCOUNT

The Plan had an interest accumulation account with Mutual of America. The interest accumulation account was credited with interest at a contract rate set by Mutual of America in accordance with the Plan's annuity contract. Mutual of America reserved the right to change the interest rate at its discretion. The interest accumulation account is reported at amortized cost or contract value.

The credited interest rate was 0.25% for the period July 1, 2022 through December 31, 2022 and 1.60% for the period January 1, 2023 through September 30, 2023. Interest is compounded daily to produce the stated effective annual yield.

The interest accumulation account is part of Mutual of America's general account assets which are primarily invested in cash and investment grade fixed-income securities. As of June 30, 2023, the contract value of the Plan's interest accumulation account was \$1,141,931.

NOTE 6 INCOME TAX STATUS

The Plan has adopted a non-standardized defined contribution pre-approved plan document sponsored by Ascensus Trust Company. The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated November 30, 2020 that the Plan is designed in accordance with the applicable section of the IRC. Although the Plan has been amended, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments in the interest accumulation account and pooled separate accounts were part of the Plan's group annuity contract with Mutual of America. Mutual of America is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions that are exempt under ERISA.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

The Plan allows for transactions with certain parties-in-interest who may perform services or have fiduciary responsibilities to the Plan. The trustee and custodian performed certain necessary recordkeeping duties and functions for the Plan. Fees paid by the Plan for these services amounted to \$4,275 and \$3,571 for the years ended June 30, 2024 and 2023, respectively. The Plan issues loans to participants which are secured by the vested balances in the participants' accounts. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities, in general, are normally exposed to various risks such as interest rate, credit risks, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 NEW LAWS AND REGULATIONS

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0) became law. The new law includes provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 changed the retirement plan rules for long-term, part-time employees. For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods for plans years beginning after December 31, 2024.

NOTE 11 RECLASSIFICATIONS

Certain amounts in the prior year's financial statements have been reclassified to conform to the current year's presentation. These reclassifications had no effect on net assets available for benefits or changes in net assets available for benefits.
