Dear Compliance Team,

I am writing to request that an RCL (Reasonable Cause Letter) be submitted on behalf of Central Brace and Limb for Plan #004753. Although this plan was terminated in June 2021, not all plan assets were distributed by year-end. Some distributions extended into January 2022, necessitating the filing of a final Form 5500 for the 2022 plan year.

Unfortunately, that filing has not yet been submitted to the IRS. I want to emphasize that this delay was through no fault of Central Brace and Limb. I contacted ADP in June 2021 and was assured that all funds would be distributed within 30 days. However, a portion of the funds were not processed within that timeframe.

We kindly ask that ADP submit a Reasonable Cause Letter on our behalf to help avoid any delinquent filing penalties associated with the late submission of the 2022 final 5500 form.

Please let me know if you need any additional information or documentation to proceed with this request. I appreciate your attention to this matter.
