Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Schnipke Engraving 401(k) Profit Sharing Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 12, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period ended July 12, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 12, 2024 and December 31, 2023 and for the period ended July 12, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Schnipke Engraving 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Plan Termination and Liquidation Basis of Accounting

As discussed in Note 7 to the financial statements, the Plan Administrator approved the termination of the Schnipke Engraving 401(k) Profit Sharing Plan on July 10, 2024, following the acquisition of the Plan Sponsor and all plan assets were transferred out of the Plan as of July 12, 2024. As a result, in accordance with accounting principles generally accepted in the United States of America, the Plan used the liquidation basis of accounting in preparing the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

1. DESCRIPTION OF PLAN:

The following description of the Schnipke Engraving 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for the sole purpose of providing retirement benefits to all employees of Schnipke Engraving Company, Inc. (the Company) who have completed at least six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Trustees is responsible for oversight of the Plan.

Plan termination

During 2024, the Company was acquired, and Plan participants became participants of the acquirer's retirement plan. All Plan assets were transferred out effective July 12, 2024. See Note 7 for additional information.

Contributions

Each year, participants may contribute up to 100% of eligible compensation as defined in the Plan, on a pre-tax basis or as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes Safe Harbor matching contributions up to a maximum of 4% of employee wages by matching 100% of the first 3% percent of employee contributions plus 50% of employee contributions over 3% up to 5%. The Safe Harbor matching contribution is invested as directed by the participants. Additional discretionary profit-sharing amounts may be contributed at the option of the Board of Directors of the Company and are also invested as directed by the participants. Participants may share in the additional discretionary profit-sharing amounts provided they have completed a minimum of 1,000 hours of service during the year and are actively employed on the last day of the plan year. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their contributions, Safe Harbor matching contributions, and any earnings (losses) thereon. After two years of service, participants become 20% vested in the Company's discretionary profit-sharing contributions plus earnings (losses) and vest an additional 20% per year until fully vested after six years of service. As a result of the Plan termination, all participants became fully vested in their accounts.

Notes receivable from participants

Participants may borrow from their fund accounts an amount not to exceed \$50,000 or 50% of their vested account balance, whichever is less. Only one outstanding note receivable is permitted at any time and the note receivable prepayment schedule can be no longer than 60 months or 15 years if used for the purchase of a principal residence or for less than \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which is commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

In the event of retirement, attainment of age 59 ½, death, termination, total and permanent disability, or other severance of employment, participants are entitled to receive an amount equal to the value of the vested interest in their accounts. Payment of benefits may be taken in a lump sum distribution, in installments or as an annuity. In the event of hardship, as defined in the plan agreement, participants may take a distribution from their accounts in an amount necessary to satisfy the financial need, subject to certain tax withholdings.

If a participant's balance is less than \$5,000 and a distribution election is not made at time of termination, the full value of the account will be distributed in a single lump-sum, either directly to the participant if the balance does not exceed \$1,000, or to an individual retirement account if the balance is between \$1,000 and \$5,000 within a reasonable period of time.

Forfeited accounts

Forfeited amounts attributable to the Company's discretionary profit-sharing contributions will be applied to reduce the Safe Harbor matching contributions, reduce discretionary profit-sharing contributions or pay plan expenses. At July 12, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$1, respectively. During 2024, \$0 in forfeitures were used to reduce Company contributions and fees.

2. SUMMARY OF ACCOUNTING POLICIES:

Basis of accounting

In accordance with the plan termination (see Note1), the 2024 financial statements have been prepared on the liquidation basis of accounting and the 2023 financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted (GAAP) in the United States of America.

Use of estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded on the basis of the terms of the Plan agreement.

Payment of benefits

Benefits are recorded upon distribution.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants or other participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEES:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, f have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of July 12, 2024 (in liquidation) and December 31, 2023; the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the period ended July 12, 2024 (in liquidation).

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 12, 2024 and December 31, 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: The pooled separate account is held in investment contracts with the trustee and is invested according to the stated objectives of the account. The principal is not guaranteed. The pooled separate account is valued at the net asset value, which is based on the market value of its underlying investments. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Common/collective trust funds: Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

* - The pooled separate account is a direct-filing entity.

** - The Plan holds a common/collective trust fund which is not a direct-filing entities. The fair value of this fund was \$0 and \$86,294, as of July 12, 2024 and December 31, 2023, respectively. The common/collective trust fund is comprised of bonds, which primarily seeks to outperform the Bloomberg US Aggregate Bond Index over full market cycles. The fund invests in government, corporate, mortgage-backed and asset-backed securities all with maturities of more than one year.

5. GUARANTEED INVESTMENT CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA:

In 2018, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower Annuity) totaling \$0 and \$2,679,967 as of July 12, 2024 and December 31, 2023, respectively. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. As disclosed in Note 7, the Plan terminated effective July 12, 2024. However, all plan assets were distributed and no situations were noted in which the Plan did not transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer. No such events occurred prior to Plan termination.

6. RELATED PARTY TRANSACTIONS:

Certain Plan investments are funds managed by Empower Annuity Insurance Company of America or its affiliates, the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

7. PLAN TERMINATION:

On July 10, 2024, Plan management of Schnipke Engraving Company, Inc., the Plan's sponsor, elected to terminate the Plan effective July 12, 2024 following acquisition of the Company. All unvested accounts became fully vested as of July 12, 2024. The Plan adopted the liquidation basis of accounting in 2024. Under the liquidation basis of accounting, assets are recorded at the amount expected to be collected and liabilities are recorded at amounts expected to be paid during the course of liquidation. All plan assets were distributed and the Plan ceased to exist as of July 12, 2024.

8. TAX STATUS:

The Company adopted a non-standardized pre-approved plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. NONEXEMPT TRANSACTIONS:

During 2024, certain employee deferrals totaling \$12,154 were not remitted to the Plan on a timely basis in accordance with Department of Labor guidelines. These transactions constitute nonexempt transactions. The Company is taking necessary correction action for all affected participants.
