Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Aviation Maintenance Group, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note A – Description of the Plan

The following brief description of the Aviation Maintenance Group, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides general information only. Participants should refer to the underlying Plan documents for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2004 by Aviation Maintenance Group, Inc. (the “Company”). The Plan is a defined-contribution plan covering all employees of the Company who are at least 18 years of age except employees covered by a collective bargaining agreement, a nonresident alien or an employee who became an employee as a result of certain acquisitions, mergers or similar transactions involving a change in employer of the employees of a trade or business.

The Plan is subject to the provisions of the Department of Labor’s Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company and Paychex, Inc. (“Paychex”), a third-party administrator for the Plan. The assets of the Plan are held and invested by Mid Atlantic Trust Company as the trustee for the investments at December 31, 2021 and 2020 and for the year ended December 31, 2021.

Contributions

Participants may contribute up to 92% of their eligible gross pay, up to the maximum amounts as specified in the Internal Revenue Code (“IRC”). Participants who have attained the age of 50 before the end of the plan year are eligible for catch-up contributions up to the maximum amounts specified in the IRC. Participants can elect to make Roth contributions. Contributions can be stopped as of any payroll period. The participants can make changes or stop deferrals through the Paychex Online Retirement Services website. Rollover contributions, including Roth contributions, representing qualified plan distributions are permitted.

The Company makes matching contributions of 15% of a participant’s elective deferral of up to 10% for each payroll period. Total employer matching contributions were \$10,030 for the year ended December 31, 2021. The Company may make profit sharing contributions for eligible participants. Profit sharing contributions are discretionary and calculated pro rata in the ratio that each eligible participant’s annual compensation for the plan year bears to the total compensation of all eligible participants for the plan year. Participants are eligible if they complete at least 500 hours of service during the plan year and are employed on the last day of the plan year. There were no discretionary contributions made for the year ended December 31, 2021.

Contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of the Company’s contribution, Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants vest in the Company’s matching contributions and any discretionary profit-sharing contributions according to the following schedule:

<u>Years of Vested Services</u>	<u>Vesting Percentage</u>
Less than one year	0%
At least one year	25%
At least two years	50%
At least three years	75%
At least four years	100%

Forfeitures

Upon termination of employment, the non-vested portion of the participant’s account balance is forfeited. Any forfeitures occurring during a Plan year can be used to pay administrative expenses of the Plan, reduce employer matching contributions or reallocated to qualifying participants’ individual accounts on a pro-rata basis.

At December 31, 2021 and 2020, forfeited nonvested accounts totaled \$2,063 and \$57, respectively, and were reallocated to qualifying participants’ individual accounts on a pro-rata basis.

Payment of Benefits

Upon termination of service, a participant receives a lump sum distribution which may be made as soon as administratively feasible following termination of employment if the account balance is \$5,000 or less. If the account balance is over \$5,000, participant consent is required for a distribution of the vested portion of their individual account in the form of a lump sum payment, partial payments, installment payments or annuity contracts. Early withdrawals of participant contributions are permitted, but limited to certain types of immediate and heavy financial need, in accordance with Code regulations.

Plan Termination

Upon the full termination of the Plan, the employer will direct payment of all outstanding administrative costs and taxes. The remaining assets will be distributed to participants in a manner consistent with their vested account balances. In the event of a full (or partial) Plan termination, the full value of each participant’s account shall become fully vested and non-forfeitable on the date of termination and shall subsequently be distributed to the participants.

Notes Receivable from Participants

Plan participants are permitted to borrow up to 95% of one-half their vested account balance subject to a minimum of \$1,000 and maximum of \$50,000. A participant may have more than one loan outstanding at any one time. The \$50,000 max loan balance permitted is reduced by the highest outstanding loan balance during the one-year period ending on the day before the date another approved loan becomes effective. All loans bear interest at the prime rate of the date the loan is requested plus 1%. Loans are repaid through regular payroll deductions over 54 pay periods starting 30 days after the loan is issued, unless the loan is for the purchase of a primary residence in which case the repayment period can extend past 54 pay periods. No allowance for credit losses have been recorded as of December 31, 2021 and 2020.

Note B – Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S.GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note C for discussion of fair value measurements.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 9, 2025, the date the financial statements were available to be issued.

Note C – Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Money market fund: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note D – Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2021 and 2020, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company (the trustee of the Plan).

Note E – Income Taxes

The Company has adopted a non-standardized prototype Plan sponsored by the Trustee. The prototype Plan has received an opinion letter dated April 10, 2014 from the Internal Revenue Service (“IRS”) as to the prototype Plan's qualified status. The IRS has determined and informed the Company by a letter dated April 10, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S.GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2017.

Note F – Party-In-Interest Transactions

The Plan allows notes receivable from participants, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note G – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note H – Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
