### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Amarr Company Savings Incentive and Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 17, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through March 17, 2023, and the related notes to the financial statements.

**Note 1. Description of Plan**

The following description of the Amarr Company Savings Incentive and Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Amarr Company and its subsidiaries (the “Company”), who have completed 60 days of service and are age 18 or older. The Company’s Advisory Committee controls and manages the operation and administration of the Plan. T. Rowe Price Trust Company (“T. Rowe Price”) serves as the trustee of the Plan (the “trustee”). The Plan is subject to the provisions of the

***Plan Status***

On December 13, 2022, management resolved to terminate the Plan effective March 17, 2023. The plan termination occurred on March 17, 2023 and all assets were transferred to the Assa Abloy Inc. Retirement Savings Plan.

***Contributions***

Each year, participants could contribute up to 30% of their pre-tax annual compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. Eligible employees were automatically enrolled in the Plan at a deferral rate of 3% of base compensation, until changed by the employee. The Company made matching contributions of 50% of the first 3% of compensation that a participant contributed to the Plan. Additional discretionary amounts could be contributed at the option of the Company’s Advisory Committee. No discretionary contributions were made during 2023. Contributions were subject to certain limitations.

***Investment Options***

Participants directed the investment of their accounts into various investment options offered by the Plan. Prior to termination, the Plan offered various mutual funds and a stable value collective trust fund as options for participants. Participants could change their investment options at any time.

***Participant Accounts***

Each participant’s account was credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

***Vesting***

Participants were immediately vested in their contributions and the Company’s safe harbor contributions plus actual earnings thereon. Vesting in the Company matching contribution portion of their accounts plus actual earnings thereon was based on years of service. A participant was 100 percent vested after four years of credited service.

***Notes Receivable from Participants***

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms ranged from one to five years, unless the note qualified as a home loan, in which case it could be payable within ten years. The loans were secured by the balance in the participant's account and bore interest at the prime lending rate plus 1.00%. Principal and interest were paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant could elect to receive an amount equal to the value of the participant's account in a lump-sum amount. Amounts contributed on a before-tax basis could only be withdrawn upon demonstration of financial hardship, disability, or after the participants reached age 59½.

***Excess Contributions***

Contributions received from participants were net of payments to certain active participants to return to them excess contributions as required to satisfy the relevant nondiscrimination provisions of the Plan.

***Forfeitures***

At March 17, 2023 and December 31 2022, forfeited non-vested accounts totaled \$0 and \$89,895, respectively. During the period from January 1, 2023 through March 17, 2023, \$21,500 of forfeitures were used to reduce Company match contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through January 6, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. There were no assets required to be classified at a level on the fair value hierarchy as of March 17, 2023.

There have been no changes in the methodologies used at March 17, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Stable Value Collective Trust Fund***

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value ("NAV") provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

**Note 5. Exempt Party-in-Interest Transactions**

Certain Plan investments are mutual funds and a common collective trust fund managed by T. Rowe Price, the trustee of the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to T. Rowe Price by the Plan for investment management services amounted to \$6,315 for the period from January 1, 2023 through March 17, 2023. Administrative expenses include fees paid for services rendered by parties-in-interest at customary and reasonable rates for such services.

**Note 6. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the volume submitter profit sharing plan with CODA that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated August 2, 2017 that the volume submitter profit sharing plan with CODA plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**
