Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Smart Sand, Inc. 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Smart Sand, Inc. 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Smart Sand, Inc. 401k Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of assets held as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 — PLAN INFORMATION

General

The Smart Sand, Inc. Retirement Plan (“Plan”) and is a defined contribution plan sponsored by Smart Sand, Inc. (“Sponsor”). The following description of the Plan’s provisions is for informational purposes only and does not bind the Plan. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility and Participant Contributions

The Plan covers substantially all United States employees of Smart Sand, Inc. and its participating subsidiaries. Employees over 21 years of age are eligible for participation beginning on the first of the month coinciding with or following 90 days of the employee’s original hire date. Employee contributions to the Plan are made through employee payroll deductions, including catch-up contributions. Eligible employees may elect to defer eligible compensation on a pre-tax basis, an after-tax (Roth) basis or a combination of both. Employees age 50 and over are allowed a catch-up contribution on a pre-tax basis, an after-tax (Roth) basis or a combination of both, beginning in the year they turn age 50. For all employees, the Internal Revenue Code (“IRC”) limited participant contributions to a maximum of \$23,000 in 2024. For those age 50 and over, the IRC limited participant contributions to a maximum of \$30,500 in 2024. Participants may roll over all or a portion of amounts from other qualified plans into this Plan. Effective August 1, 2023 all newly eligible employees are auto-enrolled into the Plan at a 3% pre-tax deduction. Any employee who wishes not to contribute must opt out of the Plan. Effective, January 1, 2024 any eligible employee without an affirmative election in the Plan will be auto-enrolled at a 3% pre-tax deduction and have an automatic 1% yearly increase until the employee reaches a 5% contribution. It is the employee’s responsibility to monitor and change their contribution percentage.

Sponsor Contributions, Investment Options and Vesting

The Sponsor makes matching contributions equal to 100% of employee elective deferrals up to 3% and 50% of employee elective deferrals which are over 3% but not over 5%. The Sponsor may make discretionary contributions. There were no discretionary contributions made during 2024.

Employees are always 100% vested in their total account balance including employee and Sponsor contributions and all earnings and as such, there are no forfeitures associated with this plan.

Benefit Payments

Upon termination, a participant with an account balance of \$1,000 or less will receive a single lump-sum cash distribution equal to the value of his or her account. Participants with an account balance that exceeds \$1,000 but does not exceed \$5,000 will have their balance rolled over to an individual retirement account unless they elect to receive a distribution in cash. Participants with account balances in excess of \$5,000 may elect to receive a lump-sum distribution, monthly annuity options, a series of monthly, quarterly, or annual installment option over a period of whole years, roll over their account balances to an eligible retirement plan, or leave their account balances in the Plan.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their account up to a maximum that is equal to the lesser of 50% of their vested balance or \$50,000. Only one loan per one-year period will be granted and employees are limited to one loan outstanding. Loan terms are a maximum of five years. The loans are secured by the balance in the participant's account. The interest rate for a loan is based on rates available for similar loans from commercial lending institutions and is determined at the time the loan is approved. Principal and interest is paid through payroll deductions, following the participant's semi-monthly or weekly payroll cycle. Loans may be repaid before they are due. If the participant does not make a payment within 90 days of the due date, the loan balances will be deemed distributed and become taxable income to the participant.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Sponsor may reduce or suspend employer matching safe harbor contributions upon satisfaction of certain requirements, including a 30-day advanced notice to all eligible employees.

NOTE 2 — SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with generally accepted accounting principles in the United States ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The net appreciation of investments on the statement of changes in net assets available for benefits includes the realized and unrealized gains and losses on investments that were both purchased and sold during the period as well as unrealized appreciation or depreciation of the investments held at year end.

Notes Receivable from Participants

Participant loans are included in notes receivable from participants on the statements of net assets available for benefits and are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Substantially all of the administrative expenses, including recordkeeping, trustee and other fees, incurred in connection with the Plan are paid by the Plan through an allocation to participant accounts. Expenses paid by the Sponsor are excluded from these financial statements.

NOTE 3 — CERTIFIED INVESTMENTS

Principal Life Insurance Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 — FAIR VALUE MEASUREMENTS

The Plan discloses its assets that are measured at fair value in the statements of net assets available for benefits by level within the fair value hierarchy as defined by U.S. GAAP:

- Level 1: Inputs are unadjusted quoted prices in active markets or identical assets or liabilities that the Plan has the ability to access at the measurement date;
- Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active or other inputs corroborated by observable market data for substantially the full term of the assets or liabilities; and
- Level 3: Unobservable inputs that reflect the Plan’s assumptions that market participants would use in pricing assets or liabilities based on the best information available.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Pooled Separate Accounts - These funds invest in a variety of mutual funds, stocks and fixed income securities depending on the goals of the fund. The NAV of the pooled separate accounts are not publicly quoted but the readily determinable fair value (“RDFV”) is made available to investors. The NAV is the basis for current transactions and the pooled separate account can be redeemed at NAV as of the measurement date and therefor represents a readily determinable market value. The fair value of the underlying mutual funds, stocks and fixed income securities

may be based on third-party pricing vendors utilizing observable market information or quoted prices for similar assets in active or nonactive markets.

- Common-collective Trust - This is a stable value collective investment trust (“CIT”) for which the NAV is based on information provided by Principal. The NAV of the CIT is not publicly quoted but the RDFV is made available to investors.

The following tables set forth, by level within the fair value hierarchy, a summary of the Plan’s investments that were measured at fair value as of December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023. The Plan had no level 2 or level 3 assets at December 31, 2024 or 2023. NOTE 5 — INCOME TAXES

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 — PARTY IN INTEREST TRANSACTIONS

All Plan investments are managed by an affiliate of the qualified institution and, therefore, all of the transactions which include such investments qualify as party in interest transactions. Notes receivable from participants are also party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 — RISKS AND UNCERTAINTIES

The Plan holds investment securities, which, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with such investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 8 — SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through April 15th, 2025 the date the financial statements were available to be issued.
