The plan has insurance contracts with Vision Service Plan, Delta Dental of Colorado, ComPsych, Unum Life Insurance Company of America, Legal Access Consulting, LLC and Reliance Standard Life Insurance Company to pay certain life, accidental death and dismemberment, dental, vision, legal, long-term disability, accident, critical illness and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$9,893,636.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2021, the premiums paid under such "experience-rated" contracts were \$5,704,584 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$5,270,344.
