Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements

We have performed an audit of the financial statements of the Amscan Inc. Profit Sharing & Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 1, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2021 through December 1, 2021, and the related notes to the financial statements (2021 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 1, 2021 and for the period January 1, 2021 through December 1, 2021, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2021 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2021 Financial Statements section

- the amounts and disclosures in the accompanying 2021 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2021 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2021 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2021 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2021 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2021 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2021 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2021 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Auditor's Report on the 2020 Financial Statements

The 2020 financial statements of the Amscan Inc. Profit Sharing & Savings Plan were audited by predecessor auditors. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the predecessor auditor not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. Their report dated October 15, 2021, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and supplemental schedule, and (b) the form and content of the information included in the financial statements and supplemental schedule other than that derived from the certified information, were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - PLAN DESCRIPTION

The following description of the Amscan Inc. Profit Sharing & Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Amscan Inc. (the Employer, Plan Sponsor, or the Company) and Trisar, Inc., its sister company, who have at least six months of service and are age 18 or older. Temporary employees and seasonal employees are eligible to participate once they reach age 18 and have completed 1,000 hours of service. Leased employees, employees covered by a collective bargaining agreement self-employed individuals and certain residents of Puerto Rico and employees performing services in Puerto Rico are excluded from participation. Amscan Inc. is the "Plan Sponsor" for employees for Amscan Inc and Trisar, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 1, 2021, the Plan merged into the Party City Holdings Inc. 401(k) Plan.

Contributions: Prior to the merger, each year participants from Amscan Inc. or Trisar, Inc were permitted to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, up to the maximum allowed under the Internal Revenue Code (\$19,500 in 2021 or \$26,000 for participants who will attain at least age 50 by the end of the year). Participants were also permitted to roll-over amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matched 50% of participants' contributions to the Plan, up to 6% of base compensation.

The profit-sharing contributions under the Plan consisted of nonelective contributions equal to 2% of a participant's eligible compensation for the quarter; eligible associates only need to be employed by the end of each quarter to receive profit sharing for that quarter. During the period January 1 through December 1, 2021, the total profit-sharing contribution was \$984,400 and contributed into the Plan in 2021.

Vesting: Participants are immediately vested in all contributions and earnings thereon.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's match, and allocations of the Company's discretionary contributions and Plan earnings/losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investment Options: All investment programs are fully participant directed. Participants may direct the investment of their contributions, and the Company's matching and discretionary contributions, in 1% increments into any of the Plan's available investment options.

Plan Termination: Although the Company has not expressed any intent to do so, it has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, the assets will be distributed to the participants in amounts equal to the fair value of the accounts.

Payment of Benefits: Upon retirement, permanent disability, or death, 100% of the value of the participant's account is paid to the participant, or the participant's beneficiary, in either a lump sum, an annuity (for certain legacy accounts), or in installment payments.

NOTE 1 - PLAN DESCRIPTION (Continued)

Participant Loans: In accordance with ERISA regulations, participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum of 50% of their account balance, not to exceed \$50,000. Loans bear interest at an effective annual percentage rate which is equal to the prime rate in effect on the first day of the quarter plus 1%. Terms range from one to five years but may be increased if the loan is used for the purchase of a primary residence. The loans are measured at their unpaid principal balances plus any accrued, but unpaid, interest. Loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting.

Excess Contribution Payable: Current year contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability payable to participants with a corresponding reduction to contributions. The Plan distributed the December 31, 2020 excess contributions to the applicable participants in 2021.

Investment Valuation and Income Recognition: Except for the Guaranteed Income Fund, the Plan's assets were invested in various pooled separate accounts with Prudential Retirement Insurance and Annuity Company (the Trustee). The fair value of participation units owned by the Plan in the pooled separate accounts is based on redemption values at each valuation date, which were derived from the underlying investments' quoted market prices, which is also the basis for current transactions. There are no restrictions on withdrawal related to any of these funds. See Note 3 for further discussion of "Fair Value Measurements."

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Investments can be redeemed daily. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

As of December 31, 2020 and during the period January 1, 2021 through December 1, 2021, the Plan held the Guaranteed Income Fund (the Fund). The Fund is an insurance company issued general account backed evergreen group annuity product, in which a fair value adjustment would not apply at the time of discontinuance. The Plan owns a promise to pay interest at crediting rates which are announced in advance and are guaranteed for a specific period of time. The Fund is deemed to be a fully benefit-responsive investment contract (FBRIC) and therefore contract value is the relevant measurement. The contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The Fund declares interest rates in advance for six-month periods. In determining the rate of interest to be guaranteed for the upcoming six-month period, the Trustee considers the projected investment earnings, the current interest environment, its investment expense, and a profit and risk component for the six-month period. The Fund does not have maturity dates or penalties for early withdrawals.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the Code) or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The merger of the Plan into the Party City Holdings Inc. 401(k) Plan had no impact on the contract's ability to transact at contract value during the plan year.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Administrative Expenses: All administrative expenses of the Plan are paid by the Company except for certain fees that are attributable to a participant's account, which may be deducted from that participant's account.

Payment of Benefits: Benefits are recorded when paid.

NOTE 3 - FAIR VALUE MEASUREMENTS

When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. The Plan follows a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

There are three levels of input that may be used to measure fair value:

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Pooled Separate Accounts: The Plan's valuation methodology used to measure the fair values of the pooled separate accounts are based on the unit values of the accounts, which were derived from the underlying investments' quoted market prices.

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2020, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2021 through December 1, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, FSB Company (the trustee of the Plan).

NOTE 5 - INCOME TAX STATUS

The underlying prototype plan has received an opinion letter from the IRS, dated April 29, 2014, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). The Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended from the original prototype document, the plan administrator believes that the Plan is currently being operated in accordance with the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 1, 2021 and December 31, 2020, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2018.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risks, market risks and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan held units of pooled separate accounts as well as a guaranteed income fund managed by Prudential Retirement Insurance and Annuity Company, a service provider of the Plan as of December 31, 2020 and during 2021. Transactions within these investments, as well as expenses paid directly and indirectly by the Plan and notes receivable from participants are considered party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

NOTE 8 - SUBSEQUENT EVENTS

The Company has evaluated subsequent events for recognition and disclosure through April 25, 2025, the date which the financial statements were available to be issued.
