We have performed audits of the financial statements of Damar Services, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of Damar Services, Inc. 401(k) Retirement (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Damar Services, Inc. (Organization) for the benefit of its employees who are not part-time, temporary or seasonal employees. The eligibility minimum age requirement for all contributions is age 18 and the eligibility service requirement, to make elective deferrals, is six months of service with 1,000 hours worked. The eligibility for Organization contributions is one year of service with 1,000 hours worked. The entry date for all contributions is quarterly. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). American United Life Insurance Company (AUL) is the custodian of the Plan and members of the Organization's management serve as the Plan trustees.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to the maximum allowed by law. Employee Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Organization matching and profit-sharing contributions are discretionary as determined by the Organization's Board of Directors. Profit-sharing contributions are allocated based on the proportionate compensation formula to all employees. Participants are required to be actively employed on the last day of the Plan year and work at least 1,000 hours during the Plan year in order to receive an allocation of profit-sharing contributions. The Board of Directors of the Organization elected to make a discretionary profit-sharing contribution of \$620,000 for the years ended June 30, 2024 and 2023. Contributions are subject to certain limitations.

Investment Account Options

Each participant has the option of directing his contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the allocation of the Organization's contribution, Plan earnings, forfeitures of terminated participants' nonvested accounts and the participant's contribution. The Organization's profit-sharing contributions are allocated based on the participant eligible earnings. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Organization's contribution, plus earnings thereon, is based on years of credited service. A participant is fully vested after six years of credited service. The nonvested balance is forfeited upon termination of service. Forfeitures are allocated among active participants based upon compensation or used to pay administrative expenses.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled approximately \$40,300 and \$16,800, respectively. These accounts will be used by reallocating to participants in the same manner as Organization contributions added to the year-end profit-sharing contribution after any corrections for forfeitures are completed. During the years ended June 30, 2024 and 2023, forfeitures of approximately \$26,700 and \$35,000 were reallocated to participants, respectively. During the years ended June 30, 2024 and 2023, forfeitures of approximately \$34,000 and \$43,000 were used for forfeiture error corrections, respectively. Also, for the years ended June 30, 2024 and 2023, forfeitures of approximately \$17,400 and \$19,200, respectively, were used to pay Plan administrative expenses.

Payment of Benefits

Upon termination of service, an employee may elect to receive a lump-sum amount equal to the value of his account. Account balances of greater than \$5,000 can remain in the Plan. In-service withdrawals are also available under certain circumstances defined by the Plan.

Plan Termination

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

The pooled separate accounts are valued at estimated fair value as provided by One America Life Insurance Company. AUL publishes the unit price daily and there are no restrictions.

The fully benefit-responsive guaranteed investment contract is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by One America Financial Partners, Inc. The Plan has not submitted to the Internal Revenue Service (IRS) for an individual determination letter because the prototype document has received favorable opinion letter from the IRS. The Plan has been amended since the prototype received a favorable opinion; however, the Organization believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Organization believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of June 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended June 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of June 30, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended June 30, 2024. The Plan had no liabilities measured at fair value on a recurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. There are no Level 1 securities held by the Plan. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. The Level 2 investments in the Plan include the pooled separate accounts and are valued as described in Note 2. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities held by the Plan.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Organization provides certain administrative services at no cost to the Plan.

The Plan paid recordkeeping fees to AUL for the years ended June 30, 2024 and 2023 of \$25,486 and \$24,259, respectively.

Note 6. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with AUL. The AUL Stable Value Account is a fixed-dollar annuity and investment product offered by AUL, an insurance company. The AUL Stable Value Account is maintained in the AUL general account. Contributions to the AUL Stable Value Account purchase a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of AUL. The AUL Stable Value Account is recorded at contract value by AUL. Contract value, as reported to the Plan by AUL represents contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. Minimum guaranteed rate is 0%.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During the year ended June 30, 2021, contributions of \$400 were not remitted to the Plan. These contributions were deposited in April 2024. Though all remitted to the Plan, contributions of \$192 and \$34,046 were not remitted during the required time frame for the years ended June 30, 2024 and 2023.

Note 9. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the accompanying financial statements include reporting the \$26,671 forfeiture reallocation activity as of June 30, 2024 on the financial statements. This forfeiture reallocation was reflected in the investments at fair value and contract value in the accompanying statement of net assets available for benefits with a net effect on the statement of net assets available for benefits of \$0.

There was also a forfeiture adjustment, as of June 30, 2024, of \$3,775 which increased the investment balance on the statement of net assets available for benefits on the financial statements which is not included on the Form 5500. The Form 5500 is still including this balance in the benefit payments and \$615 in investment earnings, on this forfeiture adjustment, is not included on the Form 5500. The difference was not considered material by Plan management.

Note 10. Subsequent Events

Subsequent events have been evaluated through April 4, 2025, which is the date the financial statements were available to be issued.
