Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of Shorr Packaging Corp. Employees Profit Sharing & 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution plan sponsored by Hanchett Paper Company (Company) for the benefit of its employees who are not covered by a collective bargaining agreement. Employees become eligible upon attaining the age of 21 and completing 30 days of service. Effective December 1, 2023, employees become eligible upon attaining the age of 21 and completing one month of service. Entry to the Plan is allowed on the first day of the month following attainment of eligibility. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as subsequently amended.

The Plan is administered by the Company. Fidelity Management Trust Company (Fidelity) holds the Plan's assets in a trust fund. The assets are invested by Fidelity pursuant to a trust agreement between the Company and Fidelity.

Contributions

The Plan permits eligible employees through a salary deferral election to contribute up to 100% of eligible compensation, up to the Internal Revenue Service limit. Participants may change their deferral rate monthly taking effect as of the first day of the following month. Salary deferred contributions are also subject to a separate limitation that must be met in order to satisfy certain nondiscrimination tests as required under tax law and regulations. Employee rollover contributions are also permitted.

Prior to October 1, 2023, employer-matching contributions for any plan year were made at the Company's discretion. The Company elected to match 15% of the employees' deferrals up to 6% of compensation which amounted to \$457,148 for the year ended September 30, 2023. Effective October 1, 2023, employer-matching contributions are made to each eligible employee in the amount of 15% of the employees' deferrals up to 6% of compensation, as defined in the Plan. For the year ended September 30, 2024, this amounted to \$459,371.

The Company may also make a discretionary profit-sharing contribution, as determined by the Company's Board of Directors. No discretionary profit-sharing contributions were made for the years ended September 30, 2024 or 2023. Effective October 1, 2023, the Company may also make a discretionary additional matching employer contribution, as determined by the Company's Board of Directors. No additional matching contribution was made for the years ended September 30, 2024 and 2023.

Participant Investment Account Options

Participant investment account options available include various registered investment companies and a money market fund. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The plan document also includes an automatic enrollment and salary deferral feature whereby a participant is treated as electing to defer 6%, effective January 1, 2018, of eligible compensation unless the participant made an affirmative election otherwise. The default investment for automatic enrollment is an age-appropriate Vanguard Target Retirement Fund.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and in the Company's matching contribution, plus earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts plus earnings thereon, is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon retirement, death or termination, the participant or beneficiary will receive the vested balance in the participant's account in the form of a lump-sum distribution, installment payments or transfer to another plan at the participant's discretion. If the participant's vested account balance is greater than \$5,000, the participant may elect to keep that balance in the Plan.

Forfeited Accounts

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$1,814 and \$1,066, respectively. Forfeited accounts are used to reduce future employer profit-sharing contributions or applied toward administrative expenses. No amount was used to reduce employer profit-sharing contributions or re-allocated to participants during the years ended September 30, 2024 and 2023. For the years ended September 30, 2024 and 2023, \$196 and \$372, respectively, of forfeitures were used to reduce administrative expenses.

Notes Receivable From Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans ranging from 5.25% to 10.50% at September 30, 2024, is based on local prevailing rates as determined by the plan administrator.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services. Administrative expenses net of revenue sharing paid by the Plan were \$35,389 for the year ended September 30, 2024. Administrative expenses of the Plan were paid for with revenue sharing for the year ended September 30, 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a volume submitter defined contribution plan sponsored by Fidelity Management & Research Company. This volume submitter document has been filed with the appropriate agency and the Plan has obtained an opinion letter from the Internal Revenue Service dated June 30, 2020, stating the volume submitter plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and the related trust was tax exempt. The volume submitter plan has been amended since the issuance of the opinion letter. However, the plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participants notes receivable are reclassified as distributions based upon the terms of the plan document.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of September 30, 2024 and 2023.

- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended September 30, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of September 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at September 30, 2024 and 2023.

The fair value of shares of registered investment companies and the money market fund are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain funds of the plan trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Net appreciation also includes certain investment management fees.

The Plan has a revenue credit program whereby Fidelity calculates revenue credits for each quarter as determined in the service agreement with the Company. During 2024 and 2023, these revenue credits totaled \$55,875 and \$93,638, respectively. The revenue credit account had a balance of \$10,745 and \$9,412 at September 30, 2024 and 2023, respectively. This account can be used by the Company to pay Plan expenses or reallocated to participant accounts. Credits of \$55,067 and \$92,565 were reallocated to eligible participant accounts during 2024 and 2023, respectively.

Note 7. Subsequent Events

Subsequent events have been evaluated through April 17, 2025, which is the date the financial statements were available to be issued.
