### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As described in Note A to the financial statements, the Plan Sponsor elected to terminate the Plan effective March 31, 2024, and distributed all assets to participants by August 30, 2024. In accordance with GAAP, the Plan used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. #### Note A – Description of Plan

The following description of the Village Discount 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan that covers all employees of qualifying employees of Village Discount Outlet, Inc. and its related employers (the “Company”, “Employer”), the Plan Sponsor. The Plan was adopted by the Company with an effective date of October 1, 2001 and restated January 1, 2022 for the required post PPA/cycle 3 restatement. To be eligible to participate in the Plan, an employee must have attained age 21 and completed at least one year of service and can enter on 1<sup>st</sup> and 7<sup>th</sup> month of the Plan year. An employee must have worked at least 1,000 hours during such plan year to be eligible for the discretionary matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Administrator of the Plan approved a plan of liquidation effective February 19, 2024. The Plan was terminated effective March 31, 2024, and distributed all assets to participants by August 30, 2024.

##### Administration

The accounting records are maintained by the Company. The Plan’s assets are held and managed by John Hancock Life Insurance Company (U.S.A) (the “Custodian”). Contributions are held by the Custodian, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

##### Contributions

Each year, participants may contribute up to 90% of their pretax annual compensation as defined by the Plan. The maximum participant deferral for the period from January 1, 2024 to August 30, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the period from January 1, 2024 to August 30, 2024. Participants may make post-tax Roth deferral contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution equal to a uniform percentage of salary deferrals in an amount that is determined annually. Matching contributions are made to each participant’s account based on elective deferrals made during the Plan year up to a maximum of 6% of eligible compensation, not considering catch up contributions. The Company elected not to make a discretionary match or discretionary profit-sharing contribution for the period from January 1, 2024 to August 30, 2024.

##### Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Company’s matching contribution and performance sharing amounts, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses based on participant earnings or account balances, as defined in the Plan agreement.

##### Vesting

Vesting is based on years of service. Participants are immediately vested in their voluntary contributions, rollovers, and actual earnings thereon. A participant is fully vested in matching contributions upon retirement, death, or total and permanent disability, and after six years of service as follows:

The Plan was terminated effective March 31, 2024 and all participants became 100% vested as of August 30, 2024.

##### Distribution of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant or a participant's beneficiary in the event of death, may elect to receive the vested value of his or her account from the Plan. Vested account balances less than \$1,000 will be paid by a lump-sum distribution. Account balances greater than \$1,000 may be paid by lump sum of the participant's entire vested account balance or a single-sum distribution of a portion of the participant's vested account balance. Additionally, under certain circumstances of financial hardship, the participant is allowed in-service withdrawal of funds from the Plan.

##### Notes Receivable from Participants

Participant loans are not permitted by the Plan.

##### Forfeitures

Upon termination, non-vested participant account balances are forfeited and allocated to participant accounts in the same manner as employer contributions. Forfeitures could be used to reduce future employer contributions. As of August 30, 2024 and December 31, 2023, there were no forfeitures.

##### Plan Termination

Effective March 31, 2024, the Plan was terminated and all participants became 100% vested. Participants were notified in writing that no further contributions will be accepted by John Hancock Life Insurance Company after July 31, 2024. All of the Plan assets were distributed to participants by August 30, 2024.

#### Note B – Summary of Significant Accounting Policies

##### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

##### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

##### Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

##### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.  If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Fair Value Measurements (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 30, 2024 and December 31, 2023.

*Pooled separate accounts:* Valued at the net asset value (“NAV”) provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at August 30, 2024 and December 31, 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

*Guaranteed Interest Contracts:* This investment is a series of group annuity contracts backed by John Hancock's claims paying ability whereby the annuity guarantees principal and a minimum interest rate. The non-fully benefit-responsive portion of these contracts provides an opportunity for additional amounts in excess of the guaranteed rate and is reported at fair value and classified within Level 3 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured using the NAV as a practical expedient are exempt from being presented in the fair value hierarchy.

As of August 30, 2024 and December 31, 2023, and for the period from January 1, 2024 to August 30, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note D – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are pooled separate accounts managed by the Custodian. Transactions related to these investments qualify as party-in-interest transactions. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$5,000 during the period from January 1, 2024 to August 30, 2024.

#### Note E – Income Tax Status

The IRS determined and informed the Company by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

#### Note F – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### Note G – Subsequent Events

Subsequent events have been evaluated through December 16, 2024, which is the date the financial statements were available to be issued.
