Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Colorado Symphony Orchestra Money Purchase Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Colorado Symphony Orchestra Money Purchase Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023 and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Colorado Symphony Orchestra Money Purchase Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Colorado Symphony Orchestra Money Purchase Pension Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Note 1 - Description of Plan

The following brief description of the Colorado Symphony Orchestra Money Purchase Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and the musicians' Collective Bargaining Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all Colorado Symphony Association (the Association) contract musicians of Local No. 20-263 of the American Federation of Musicians (AFM). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Benefits Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance and reports to the Plan's Board of Trustees.

Eligibility

Contract musicians of the Association are eligible to participate in the Plan immediately following their employment commencement date.

Entry Date

Contract musicians of the Association may enter the Plan on the first day of each month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each plan year, the Association makes contributions to the Plan based on an amount agreed upon in a collective bargaining agreement between the Association and the AFM. For the years ended August 31, 2024 and 2023, the Association made contributions equal to the difference between four percent of gross compensation, less electronic media guarantee wages, and the amount paid into the AFM plan, as defined in the related collective bargaining agreement. Amounts are required to be made by the Association within seven days after the issuance of a contract musician's paycheck and are calculated on a per pay period basis. Contributions are subject to certain Internal Revenue Code (IRC) limitations. All amounts relating to paychecks issued in fiscal year 2024 were funded during the Plan year ending August 31, 2024. As such, the Plan's minimum funding requirements were met for the year ended August 31, 2024. Participants may only contribute amounts representing distributions from other qualified plans (rollover).

Participant Accounts

Each participant's account is credited with the Association's contributions and an allocation of Plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct the Association's contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are 100% vested in the Association's contributions and actual earnings thereon immediately upon hire.

Forfeitures

There were no forfeited accounts held by the Plan as of August 31, 2024 and 2023, or during the year ended August 31, 2024, as participant accounts are fully vested at all times.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated contract musician with a balance of less than \$1,000 will be automatically paid out by the Plan upon termination in the form of a lump sum distribution unless another form of distribution is affirmatively elected. Unless a terminated participant affirmatively elects otherwise, account balances between \$1,000 and \$5,000 will be automatically rolled over to an Individual Retirement Account in the name of the participant. Distributions may be made at the participant's election prior to termination upon attainment of age 62.

Plan Termination

The Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA; however, this is subject to AFM approval. See Note 9.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Association determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Association, as provided by the Plan document. Expenses that are paid directly by the Association are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Common collective trust fund - Valued at fair value based on the net asset value (NAV) of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at August 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Association by a letter dated March 12, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of this determination letter, the Plan was amended. However, the Company and plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and money market mutual funds managed by The Vanguard Group, Inc. Also, the Plan holds units of a common collective trust fund managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company, the trustee as defined by the Plan, is a wholly owned subsidiary of The Vanguard Group, Inc. and, therefore, transactions related to either entity qualify as exempt party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Plan Amendments

In September 2023, Colorado Symphony Association and the Denver Musician Association entered into a new local trade agreement effective from July 1, 2023 through June 30, 2025 with updated terms such as an increase in wages.

Note 9 - Subsequent Events

On October 19th, 2024, the Benefits Committee of Colorado Symphony Association voted to move the Colorado Symphony Orchestra Money Purchase Pension (MPP Plan) to Principal Financial Group. The MPP Plan will be transferring all/division employees/participants to Principal Financial Group, where the Colorado Symphony 403(b) Plan (403(b) Plan) currently resides, as the successor recordkeeper and/or trustee as of May 1, 2025. The MPP Plan will then be terminated, and participants will have the option to move their MPP Plan funds into the Principal 403(b) Plan if desired.

The Plan Sponsor has evaluated subsequent events through April 18, 2025, the date which the financial statements were available to be issued.

Note 1 - Description of Plan

The following brief description of the Colorado Symphony Orchestra Money Purchase Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and the musicians' Collective Bargaining Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all Colorado Symphony Association (the Association) contract musicians of Local No. 20-263 of the American Federation of Musicians (AFM). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Benefits Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance and reports to the Plan's Board of Trustees.

Eligibility

Contract musicians of the Association are eligible to participate in the Plan immediately following their employment commencement date.

Entry Date

Contract musicians of the Association may enter the Plan on the first day of each month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each plan year, the Association makes contributions to the Plan based on an amount agreed upon in a collective bargaining agreement between the Association and the AFM. For the years ended August 31, 2024 and 2023, the Association made contributions equal to the difference between four percent of gross compensation, less electronic media guarantee wages, and the amount paid into the AFM plan, as defined in the related collective bargaining agreement. Amounts are required to be made by the Association within seven days after the issuance of a contract musician's paycheck and are calculated on a per pay period basis. Contributions are subject to certain Internal Revenue Code (IRC) limitations. All amounts relating to paychecks issued in fiscal year 2024 were funded during the Plan year ending August 31, 2024. As such, the Plan's minimum funding requirements were met for the year ended August 31, 2024. Participants may only contribute amounts representing distributions from other qualified plans (rollover).

Participant Accounts

Each participant's account is credited with the Association's contributions and an allocation of Plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct the Association's contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are 100% vested in the Association's contributions and actual earnings thereon immediately upon hire.

Forfeitures

There were no forfeited accounts held by the Plan as of August 31, 2024 and 2023, or during the year ended August 31, 2024, as participant accounts are fully vested at all times.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated contract musician with a balance of less than \$1,000 will be automatically paid out by the Plan upon termination in the form of a lump sum distribution unless another form of distribution is affirmatively elected. Unless a terminated participant affirmatively elects otherwise, account balances between \$1,000 and \$5,000 will be automatically rolled over to an Individual Retirement Account in the name of the participant. Distributions may be made at the participant's election prior to termination upon attainment of age 62.

Plan Termination

The Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA; however, this is subject to AFM approval. See Note 9.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Association determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Association, as provided by the Plan document. Expenses that are paid directly by the Association are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Common collective trust fund - Valued at fair value based on the net asset value (NAV) of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at August 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Association by a letter dated March 12, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of this determination letter, the Plan was amended. However, the Company and plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and money market mutual funds managed by The Vanguard Group, Inc. Also, the Plan holds units of a common collective trust fund managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company, the trustee as defined by the Plan, is a wholly owned subsidiary of The Vanguard Group, Inc. and, therefore, transactions related to either entity qualify as exempt party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Plan Amendments

In September 2023, Colorado Symphony Association and the Denver Musician Association entered into a new local trade agreement effective from July 1, 2023 through June 30, 2025 with updated terms such as an increase in wages.

Note 9 - Subsequent Events

On October 19th, 2024, the Benefits Committee of Colorado Symphony Association voted to move the Colorado Symphony Orchestra Money Purchase Pension (MPP Plan) to Principal Financial Group. The MPP Plan will be transferring all/division employees/participants to Principal Financial Group, where the Colorado Symphony 403(b) Plan (403(b) Plan) currently resides, as the successor recordkeeper and/or trustee as of May 1, 2025. The MPP Plan will then be terminated, and participants will have the option to move their MPP Plan funds into the Principal 403(b) Plan if desired.

The Plan Sponsor has evaluated subsequent events through April 18, 2025, the date which the financial statements were available to be issued.

Note 1 - Description of Plan

The following brief description of the Colorado Symphony Orchestra Money Purchase Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and the musicians' Collective Bargaining Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all Colorado Symphony Association (the Association) contract musicians of Local No. 20-263 of the American Federation of Musicians (AFM). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Benefits Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance and reports to the Plan's Board of Trustees.

Eligibility

Contract musicians of the Association are eligible to participate in the Plan immediately following their employment commencement date.

Entry Date

Contract musicians of the Association may enter the Plan on the first day of each month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each plan year, the Association makes contributions to the Plan based on an amount agreed upon in a collective bargaining agreement between the Association and the AFM. For the years ended August 31, 2024 and 2023, the Association made contributions equal to the difference between four percent of gross compensation, less electronic media guarantee wages, and the amount paid into the AFM plan, as defined in the related collective bargaining agreement. Amounts are required to be made by the Association within seven days after the issuance of a contract musician's paycheck and are calculated on a per pay period basis. Contributions are subject to certain Internal Revenue Code (IRC) limitations. All amounts relating to paychecks issued in fiscal year 2024 were funded during the Plan year ending August 31, 2024. As such, the Plan's minimum funding requirements were met for the year ended August 31, 2024. Participants may only contribute amounts representing distributions from other qualified plans (rollover).

Participant Accounts

Each participant's account is credited with the Association's contributions and an allocation of Plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct the Association's contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are 100% vested in the Association's contributions and actual earnings thereon immediately upon hire.

Forfeitures

There were no forfeited accounts held by the Plan as of August 31, 2024 and 2023, or during the year ended August 31, 2024, as participant accounts are fully vested at all times.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated contract musician with a balance of less than \$1,000 will be automatically paid out by the Plan upon termination in the form of a lump sum distribution unless another form of distribution is affirmatively elected. Unless a terminated participant affirmatively elects otherwise, account balances between \$1,000 and \$5,000 will be automatically rolled over to an Individual Retirement Account in the name of the participant. Distributions may be made at the participant's election prior to termination upon attainment of age 62.

Plan Termination

The Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA; however, this is subject to AFM approval. See Note 9.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Association determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Association, as provided by the Plan document. Expenses that are paid directly by the Association are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Common collective trust fund - Valued at fair value based on the net asset value (NAV) of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at August 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Association by a letter dated March 12, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of this determination letter, the Plan was amended. However, the Company and plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and money market mutual funds managed by The Vanguard Group, Inc. Also, the Plan holds units of a common collective trust fund managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company, the trustee as defined by the Plan, is a wholly owned subsidiary of The Vanguard Group, Inc. and, therefore, transactions related to either entity qualify as exempt party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Plan Amendments

In September 2023, Colorado Symphony Association and the Denver Musician Association entered into a new local trade agreement effective from July 1, 2023 through June 30, 2025 with updated terms such as an increase in wages.

Note 9 - Subsequent Events

On October 19th, 2024, the Benefits Committee of Colorado Symphony Association voted to move the Colorado Symphony Orchestra Money Purchase Pension (MPP Plan) to Principal Financial Group. The MPP Plan will be transferring all/division employees/participants to Principal Financial Group, where the Colorado Symphony 403(b) Plan (403(b) Plan) currently resides, as the successor recordkeeper and/or trustee as of May 1, 2025. The MPP Plan will then be terminated, and participants will have the option to move their MPP Plan funds into the Principal 403(b) Plan if desired.

The Plan Sponsor has evaluated subsequent events through April 18, 2025, the date which the financial statements were available to be issued.
