**1. DESCRIPTION OF THE PLAN**

The following description of F.H. Furr Plumbing, Heating & Air Conditioning, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General -

The Plan is a defined contribution plan covering all eligible employees of F.H. Furr Plumbing, Heating & Air Conditioning, Inc. (the Plan Sponsor) who are full-time employees with at least one year of service and are at least twenty one years of age. The Plan qualifies under the Internal Revenue Code as a 401(a) plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended in June 2022 for the CARES Act.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

On December 28, 2023, F.H. Furr Plumbing, Heating & Air Conditioning, Inc. and Apex Service Partners, LLC. signed an agreement to merge the Plan into Apex Service Partners, LLC. 401(k) Plan. The Plan's assets were transferred to the Apex Service Partners, LLC. 401(k) Plan on January 2, 2024. The transfer totaled \$8,840,637 for the period ended January 2, 2024.

Contributions -

The Plan offered employee elective deferrals. There was no mandatory contribution and employees could elect not to participate. Participants could elect to reduce their compensation by a specific percentage or Dollar amount and that amount was contributed to the Plan as an elective deferral subject to annual IRS limitations. The Plan had an automatic contribution arrangement in which employees would be automatically enrolled at a 3% withholding rate, unless they opted out of participation.

The employer could, at its sole discretion, elect to make matching contributions and profit sharing contributions to the Plan. There were no employer matching contributions during the period ended January 2, 2024. Employer matching contributions totaled \$106,627 during the year ended December 31, 2023. In addition, there were no employer profit sharing contributions during the period ended January 2, 2024 and for the year ended December 31, 2023.

Participants could also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

Vesting -

Participants were fully vested in their elective deferral contributions and employee rollover contributions, plus actual earnings thereon. Vesting in employer matching contributions and profit sharing contributions was based on the following schedule:

**1. DESCRIPTION OF THE PLAN (Continued)**

Participant accounts -

Each participant's account was credited with (a) the employee's contributions, (b) investment earnings and losses and (c) the employer's contributions. Participants accounts were also charged with an allocation of administrative expenses that were paid by the Plan. Allocations of investment earnings and losses, and administrative expenses, were based on account balances, or specific participant transactions, as defined in the Plan document.

Investment elections -

Contributions to the Plan were invested according to participant instructions. The Plan Sponsor had selected a list of investment options and had provided participants with information describing these investment options. Participants could change their elected investment options/allocations at any time via written correspondence, direct phone, or internet access.

Payment of benefits -

Benefits provided by the Plan were paid from net assets available for benefits. The benefit to which a Plan participant was entitled was the benefit that could be provided by the contributions and net earnings thereon allocated to such participant's account. Benefit payments were made in the form of participant directed lump sum, installment, or annuity payments upon separation, retirement, total and permanent disability, or death, as applicable. Benefits were recorded when paid whether directly to or on behalf of a participant.

Hardship distributions to employees were permitted if certain conditions were met.

The Plan also provided for minimum required distributions per IRS regulations by April 1 of the calendar year following the later of the calendar year in which the participant reaches age 73 or the calendar year the participant retired. In addition, participants could elect in-service withdrawals of their vested account balances after reaching age 59½.

Forfeited non-vested accounts -

Forfeited balances of terminated participants' non-vested accounts could be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. No forfeiture balances were used during the period ended January 2, 2024. The Plan Sponsor used forfeitures totaling \$72,156 for the year ended December 31, 2023. The balance of forfeited non-vested accounts was zero as of January 2, 2024. The balance of forfeited non-vested accounts totaled \$12,597 as of December 31, 2023.

Notes receivable from participants -

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest was paid through payroll deductions, or by check for prepayments. The notes were secured by the balance in the participant's account and interest was charged at a rate established in a non-discriminatory manner. There were no notes receivable as of January 2, 2024. Notes receivable as of December 31, 2023, had interest rates ranging from 4.25% to 10.50% with various maturities through December 27, 2024.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting -

The financial statements were prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

Use of estimates -

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America required the Plan Administrator to make estimates and assumptions that affected certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of investments -

Investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion on fair value measurements.

The Plan's investments included pooled separate accounts, which were investment funds only available to institutional retirement plan investors. Therefore, the pooled separate accounts were not available to be purchased or sold on a public exchange. Under the pooled investment concept, the investment advisors accounted for the Plan's share of the total portfolio at net asset value (NAV), and the investment advisors were the custodians of the assets.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net (depreciation) appreciation included the Plan's losses and gains on investments bought and sold as well as held during the year.

Notes receivable from participants -

Notes receivable from participants were measured at their unpaid principal balance, plus accrued interest. Delinquent loans were treated as distributions based upon the terms of the Plan document. Delinquent loans were loans for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there was an outstanding principal balance existing after the last scheduled repayment date.

Benefit payments -

Benefits were recorded when paid.

Administrative expenses -

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and some were paid by the Plan, which were included in these financial statements. Investment-related expenses were included as a reduction in the net (depreciation) appreciation of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits. Expenses that were paid by the Plan Sponsor were excluded from these financial statements.

#### 3. INCOME TAX STATUS

The Plan was established as a qualified plan under Section 401(a) of the Internal Revenue Code (IRC). The Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (the IRS) indicated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC and was qualified and tax-exempt. The Plan adopted its most recent Plan amendment to comply with the CARES Act in June 2022. Management of the Plan, in consultation with its legal counsel, believed that the Plan continued to meet the requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and concluded that as of January 2, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

#### 4. INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, the Plan's Administrator instructed the Plan's independent auditors not to perform, and they did not perform, such auditing procedures with respect to the information certified by a qualified institution.

John Hancock Life Insurance Company (U.S.A.) (John Hancock), the qualified institution, issued Certification Statements as of and for the period ended January 2, 2024 and as of and for the year ended December 31, 2023. The Certification Statements issued by the qualified institution certified the assets held at January 2, 2024, and December 31, 2023, and the investment income in the Statements of Changes in Net Assets Available for Benefits for the period ended January 2, 2024, and for the year ended December 31, 2023.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of investment vehicles managed by John Hancock, the qualified institution. John Hancock was the custodian of the Plan's assets, and therefore, transactions with the custodian qualified as party-in-interest transactions.

#### 6. FAIR VALUE MEASUREMENT

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

**6. FAIR VALUE MEASUREMENT (Continued)**

Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodologies used and there were no transfers between levels in the fair value hierarchy during the year ended December 31, 2023. The Plan had no investments as of January 2, 2024.

*Pooled Separate Accounts* - Investments in the pooled separate accounts represent ownership of units of participation rather than ownership of specific assets. The value of a unit of participation is the total value of the separate account divided by the number of units outstanding, which is the net asset value (NAV). The estimated fair value of investments in certain entities that calculate net asset value per share can be determined using NAV as a practical expedient when the fair value is not readily determinable. The Plan administrator determined that the pooled separate accounts can be measured using NAV as a practical expedient.

The Plan's investments that were measured at NAV as a practical expedient have not been categorized in the fair value hierarchy. However, the NAV amounts presented in the tables below are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.
