1. Plan description

The following brief description of The Foresight MEP 401(k) Plan FBO ION Solar (the Plan) is provided for general information only. Participants should refer to the Plan agreement for more complete information. The Plan is an open multiple employer plan that is sponsored by Foresight Wealth Management and adopted by ION Solar (the Company).

General. The Plan became effective as of August 16, 2021. The Plan is a defined contribution plan established under the provisions of Sections 401(a), 401(k) and 501(a) of the Internal Revenue Code. Under Section 401(k), contributions to a qualified plan are not included in a participant's compensation for federal income tax purposes until distributed to the participant. Employees 18 years and older are eligible to contribute after three months of employment. Plan Management is responsible for oversight of the Plan, including investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Plan participants may make salary deferral contributions in an amount not in excess of the maximum allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company is not currently making matching contributions to the Plan.

Participant Accounts. Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses that are incurred by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are fully vested at all times for their own contributions and applicable earnings on those contributions. Although no employer contributions have been remitted to the Plan, participants will vest in future employer contributions and the applicable earnings on those contributions based upon years of service. A participant will be 100 percent vested after 7 continuous years of service.

Notes Receivable from Participants. Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50 percent of the participant's total account balance. Loans are secured by the balance in the participant's account. Repayment of the loan generally must be made through payroll deductions for up to a five-year period. The loans bear interest rates which are commensurate with local prevailing rates as determined by the Plan administrator.

1. Plan description (continued)

Payment of Benefits. Distributions and withdrawals generally are payable upon termination, financial hardship, total disability, death, or the attainment of the normal retirement age of 59 ½ years of age. The participant or designated beneficiary can receive a lump sum distribution of the value of the account including vested portions of employer contributions. An alternative payment schedule may be requested by the participant as specified in the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value based upon quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The participant loan fund is carried at cost, which approximates fair value. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2024, and December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net change of fair value of investments.

Subsequent Events

For the year ended November 30, 2024, the Company has evaluated subsequent events for the potential recognition and disclosure through April 14, 2025, the date of financial statement issuance.

3. Fair Value Measurement

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurement (continued)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024, and December 31, 2023.

Interest-bearing cash: Valued at the account balance at the end of the year.

Mutual Funds: Valued at the net asset value of shares held by the plan at year end.

4. Party-in-Interest Transactions

PCS Retirement (“PCS”) is the Plan’s third-party administrator and record keeper. PCS may receive revenue from some of the mutual fund providers to the Plan.

Certain Plan investments are in accounts and contracts administered by Fidelity Personal Trust Company, FSB, and qualify as party-in-interest transactions.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

5. Plan Termination

During 2024, the Plan’s assets were moved to another multi-employer plan. All assets were transferred by November 30, 2024. All participants were 100% vested in plan balances at the time of transfer.

6. Tax Status

The Company has adopted a non-standardized pre-proved plan document which received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the pre-approved plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain positions that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
