Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Cranbrook Educational Community Section 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements and supplemental schedule are prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Emphasis of Matter

As explained in Note 5, the modified cash basis financial statements include investments valued at approximately \$8.5 million (11 percent of net assets) at September 30, 2024 and \$8 million (12 percent of net assets) at September 30, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by the qualified institution. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of modified cash basis financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Note 1 - Plan Description

The following description of Cranbrook Educational Community Section 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain employees of Cranbrook Educational Community (Cranbrook) as of their date of hire. Student employees are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2022, the Plan was amended to allow for participants to make Roth after-tax contributions.

Contributions

The Plan provides employees the opportunity to contribute a fixed portion of their compensation as a pretax or Roth deferral subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Cranbrook may make annual discretionary contributions to the Plan, as approved by the board of trustees. The board of trustees will specify which employees, if any, will be eligible for an allocation of an employer contribution. For the year ended September 30, 2024, employer discretionary contributions totaled \$0.

Plan contributions are invested in one or more investment vehicles available to the participants with Teachers Insurance Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF).

The Plan also has investments with American Funds. These investments consist of investments for active and inactive participants and have been frozen (no new enrollments or direct investments). Participants are permitted to move funds from American Funds to TIAA-CREF.

Participant Accounts

Each participant's account is credited with the participant's contribution; a discretionary employer contribution, if any; and plan earnings and charged with an allocation of administrative expenses. Determination of the allocation methodology of these amounts is outlined in the plan document. Allocations of participant contributions are based on participants' compensation or account balances, as defined. Allocation of the discretionary employer contribution is determined by the board of trustees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions, as well as employer discretionary contributions (as applicable), and any income or loss thereon.

Benefit Payments

The value of participants' accounts is payable to participants upon retirement, death, or other termination of employment. Participants can elect to receive, or have their beneficiary receive, benefits under any of the lifetime income options set forth in the contracts between TIAA-CREF or American Funds and the participants and/or Cranbrook. Other distribution alternatives, including lump-sum distributions, are available subject to plan provisions. Certain amounts invested in the TIAA Traditional Annuity group annuity contracts may not be distributed in a lump sum (see redemption restrictions below).

Note 1 - Plan Description (Continued)

Redemption Restrictions

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participants to transfer or withdraw from the fund. Transfers from the Retirement Annuity (RA) and Transfer Payout Annuity (TPA) contracts must be paid out in 10 annual installments and from the Retirement Choice (RC) contracts in seven years. Withdrawals from the RA contract must be paid out in 10 annual installments and from the Retirement Choice contracts in seven years. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals. The TIAA Stable Value investment is immediately liquid to participants and does not have participant-level withdrawal restrictions. There are, however, equity wash provisions that prevent the immediate transfer of amounts to any competing funds available in the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by TIAA-CREF; TIAA Trust, N.A.; and American Funds or their affiliates. TIAA-CREF is a service provider of the Plan, and TIAA Trust, N.A. and American Funds are custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Termination

While it has not expressed any intent to do so, Cranbrook reserves the right at any time to amend, otherwise modify, or terminate the Plan by resolution of its board of trustees. In the event of a termination of the Plan, Cranbrook will notify all participants of the termination, and benefits would be paid out as if the participants had terminated employment.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on a modified cash basis of accounting, which is allowed by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The disclosure requirements specified in these rules and regulations differ in some respects from accounting principles generally accepted in the United States of America. Consequently, except as described in the next sentence, revenue is recorded when received rather than when earned, and expenses are recorded when paid rather than when the obligation is incurred. Additionally, these modified cash basis financial statements differ from the cash basis of accounting in that investments are recorded at fair value.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below.

Investments in registered investment companies are valued at net asset value (NAV) per share (or its equivalent) of the funds, which is valued based on the net asset values of the underlying net assets. Investments in the pooled separate account are valued at net asset value per share (or its equivalent) of the funds, which is based on the fair market value of the underlying net assets, which consist primarily of rental property subject to long-term leases, and have been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with the risks involved. The guaranteed investment account is considered non-benefit responsive and is presented at fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The TIAA Traditional Annuity is a guaranteed annuity account issued by TIAA that invests in the general assets of TIAA. TIAA considers the following contracts to be benefit responsive: Supplemental Retirement Annuity (SRA) and Group Supplemental Retirement Annuity (GSRA). The TIAA Traditional Annuity includes the following contracts, which are all considered to be non-benefit responsive: Retirement Annuity, Interest Payment (IP), and Transfer Payout Annuity. The non-benefit-responsive portion is recorded at fair value. The benefit-responsive portion is recorded at contract value. Since there are no specific securities in TIAA's general account related to these contracts and due to the contract terms, including the frequency of the interest rate reset interval, contract value is the best estimate of fair value. For all portions, contract value represents principal invested, plus interest earned, less any withdrawals.

The TIAA Stable Value in the Retirement Choice contract is a group annuity contract issued by TIAA that invests in a nonunitized separate account of TIAA. The TIAA Stable Value is considered benefit responsive and is presented at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals.

All other investments are valued based on quoted market prices. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$273,574 and \$180,291 as of September 30, 2024 and 2023, respectively.

Allocated Insurance Contracts

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

Use of Estimates

The preparation of financial statements under the modified cash basis of accounting requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

Cranbrook paid certain administrative expenses of the Plan during the year ended September 30, 2024.

Subsequent Events

The modified cash basis financial statements and related disclosures include evaluation of events up through and including April 18, 2025, which is the date the modified cash basis financial statements were available to be issued.

Note 3 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS. The Plan has not individually sought its own determination letter.

Note 4 - Certified Information

TIAA-CREF and TIAA Trust, N.A. hold the Plan's investment assets and participant notes receivable, except mutual funds with American Funds, and execute all investment transactions. TIAA has the authority to certify the investment balances and related investment activity on behalf of TIAA Trust, N.A. The investment and participant notes receivable balances, other than mutual funds held by American Funds, and related investment income and losses included in the accompanying modified cash basis financial statements and supplemental schedule of assets held at end of year - modified cash basis are based solely on information certified by TIAA-CREF, including TIAA, on behalf of TIAA Trust, N.A.

Mutual funds with American Funds totaling \$74,975 and \$55,475 at September 30, 2024 and 2023, respectively, and net investment gain of \$19,521 for the year ended September 30, 2024 were not certified by American Funds.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the modified cash basis financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Group Annuity Contracts

Based on the terms of the contracts, the TIAA Stable Value and a portion of the TIAA Traditional Annuity are considered benefit responsive. The total balance in the TIAA Traditional Annuity was \$15,690,529 and \$16,032,602 at September 30, 2024 and 2023, respectively. The benefit-responsive portion totaled \$8,854,042 and \$9,627,376 at September 30, 2024 and 2023, respectively. The contract issuers maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintage approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, it is between 1 and 3 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contracts are fully benefit responsive, contract value is the relevant measurement attribute for the portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
