Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Cranbrook Educational Community Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of September 30, 2024 and 2023 and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended September 30, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of September 30, 2024 and 2023 and for the year ended September 30, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. Basis of Accounting

We draw attention to Note 2 to the modified cash basis financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Emphasis of Matter

As explained in Note 5, the modified cash basis financial statements include investments valued at approximately \$14 million (19 percent of net assets) at September 30, 2024 and \$13 million (22 percent of net assets) at September 30, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by the qualified institution. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of modified cash basis financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Note 1 - Plan Description

The following description of Cranbrook Educational Community Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was originally established on October 19, 1964. All employees, with the exception of student and leased employees, of Cranbrook Educational Community (Cranbrook) are eligible to participate in the nonelective contributions of the Plan if they have completed one year of service and attained age 21. Employees of Cranbrook are eligible to participate in the matching contributions of the Plan after they have completed one year of service and attained age 21; if their original employment date was on or after July 1, 2008; or if their original employment date was prior to July 1, 2008 and they made a one-time irrevocable election to enroll in the base plus match plan. An employee is also credited with one year of service if he or she has completed one year of service during the 12-month period immediately preceding the date of his or her employment with Cranbrook with another nonprofit educational institution, cultural institution, or other organization, as defined in Section 501(c)(3) of the Internal Revenue Code. A participant must complete at least 1,000 hours of service to be credited with a year of service. As of October 1, 2022, the Plan was amended to no longer require full-time employees to complete one year of service to participate in the nonelective and matching contributions of the Plan. Full-time employees are eligible the first month following or concurrent with their date of hire.

Contributions

Cranbrook makes nonelective and matching contributions, as applicable, to the Plan on behalf of each participant at least quarterly. Nonelective contributions equal to 9 percent of compensation are made to employees hired before July 1, 2008 who have not made a one-time irrevocable election to be eligible to receive the 5 percent base rate plus matching contributions, if eligible, and to all participants who are employees represented by the American Federation of State, County and Municipal Employees (AFSCME) and were hired before April 1, 2009. All other eligible participants receive nonelective contributions equal to 5 percent of compensation. Plan nonelective contributions are not made on any amount of compensation in excess of amounts stated in Section 401(a)(17) of the Internal Revenue Code (IRC). Certain other limitations may apply, as discussed in the plan document and in compliance with other IRC limitations.

Participants eligible to receive matching contributions shall receive an allocation equal to a percentage of the lesser of the participant's elective contribution made to the Cranbrook Educational Community Section 403(b) Plan or compensation, based on the employee classification of which he or she is a member, as follows:

Classification A - Participants satisfying the eligibility requirements who have 1-5 years of participation equal a 1 percent match

Classification B - Participants satisfying the eligibility requirements who have 6-15 years of participation equal a 2 percent match

Classification C - Participants satisfying the eligibility requirements who have 16-30 years of participation equal a 3 percent match

Classification D - Participants satisfying the eligibility requirements who have 31 years or more of participation equal a 4 percent match

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions, other than rollovers, and loans are not permitted under the Plan.

Plan contributions are invested in one or more investment vehicles available to the participants with Teachers Insurance Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF).

Vesting

All participants whose original hire date was prior to July 1, 2008 and all participants who are AFSCME-represented employees and hired prior to April 1, 2009 are 100 percent vested and have a nonforfeitable interest in their entire nonelective and matching accounts (as applicable) under the Plan at all times. A participant whose original hire date is on or after July 1, 2008, or an AFSCME-represented employee whose original hire date is on or after April 1, 2009, is vested and has a nonforfeitable interest in a percentage of his or her nonelective and matching accounts according to the following schedule:

Participant Accounts

Each participant's account is credited with the allocations of employer contributions and plan earnings and charged with an allocation of administrative expenses. Determination of the allocation methodology of these amounts is outlined in the plan document. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures attributable to nonelective contributions are used to reduce the nonelective contribution payable to the Plan. Forfeitures attributable to matching contributions are used to reduce the matching contribution to the Plan.

Benefit Payments

The value of participants' accounts is payable to participants upon retirement, death, or other termination of employment. Participants can elect to receive, or have their beneficiary receive, benefits under any of the lifetime income options set forth in the contracts between TIAA-CREF and the participants and/or Cranbrook. Other distribution alternatives, including lump-sum distributions, are available subject to plan provisions. Certain amounts invested in the TIAA Traditional Annuity group annuity contract may not be distributed in a lump sum (see redemption restrictions below).

Redemption Restrictions

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participants to transfer or withdraw from the fund. Transfers from the Retirement Annuity (RA) and Transfer Payout Annuity (TPA) contracts must be paid out in 10 annual installments and from the Retirement Choice (RC) contracts in seven years. Withdrawals from the RA contract must be paid out in 10 annual installments and from the Retirement Choice contracts in seven years. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals. The TIAA Stable Value investment is immediately liquid to participants and does not have participant-level withdrawal restrictions. There are, however, equity wash provisions that prevent the immediate transfer of amounts to any competing funds available in the Plan.

Party-in-interest Transactions

Some plan assets are in investment funds managed by TIAA-CREF and TIAA Trust, N.A. or their affiliates. TIAA-CREF is a service provider of the Plan, and TIAA Trust, N.A. is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it is expected that the Plan will continue indefinitely, Cranbrook reserves the right at any time to amend, otherwise modify, or terminate the Plan or to discontinue any further contributions or payments under the Plan by resolution of its board. In the event of a termination of the Plan or complete discontinuance of plan contributions, Cranbrook will notify all participants of termination. If the Plan is terminated, participants become 100 percent vested in their account balances, and the net assets would be distributed to the participants according to the balances in the participants' accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on a modified cash basis of accounting, which is allowed by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The disclosure requirements specified in these rules and regulations differ in some respects from accounting principles generally accepted in the United States of America. Consequently, except as described in the next sentence, revenue is recorded when received rather than when earned, and expenses are recorded when paid rather than when the obligation is incurred. Additionally, these modified cash basis financial statements differ from the cash basis of accounting in that investments are recorded at fair value.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below.

Investments in registered investment companies are valued at net asset value (NAV) per share (or its equivalent) of the funds, which is valued based on the net asset values of the underlying net assets. Investments in the pooled separate account are valued at net asset value per share (or its equivalent) of the funds, which is based on the fair market value of the underlying net assets, which consist primarily of rental property subject to long-term leases, and have been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with the risks involved. The guaranteed investment account is considered non-benefit responsive and is presented at fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The TIAA Traditional Annuity is a guaranteed annuity contract issued by TIAA that invests in the general assets of TIAA. The TIAA Traditional Annuity includes the following contracts, which are all considered to be non-benefit responsive: Retirement Annuity, Interest Payment (IP), and Transfer Payout Annuity. The non-benefit-responsive portion is recorded at fair value. Since there are no specific securities in TIAA's general account related to these contracts and due to the contract terms, including the frequency of the interest rate reset intervals, contract value is the best estimate of fair value. Contract value represents principal invested, plus interest earned, less any withdrawals.

The TIAA Stable Value is a group annuity contract issued by TIAA that invests in a nonunitized separate account of TIAA. The TIAA Stable Value is considered benefit responsive and is presented at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals.

All other investments are valued based on quoted market prices. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Benefit Payments

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$784,559 and \$674,241 as of September 30, 2024 and 2023, respectively.

Allocated Insurance Contracts

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

Use of Estimates

The preparation of financial statements under the modified cash basis of accounting requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

Cranbrook paid certain administrative expenses of the Plan during the year ended September 30, 2024.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including April 18, 2025, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 4 - Certified Information

TIAA-CREF and TIAA Trust, N.A. hold the Plan's investment assets and execute all investment transactions. TIAA has the authority to certify the investment balances and related investment activity on behalf of TIAA Trust, N.A. The investment balances and related investment income and losses included in the accompanying modified cash basis financial statements and supplemental schedule of assets held at end of year - modified cash basis are based solely on information certified by TIAA-CREF, including TIAA, on behalf of TIAA Trust, N.A.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the modified cash basis financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Group Annuity Contracts

Based on the terms of the contracts, the TIAA Stable Value contract is considered benefit responsive. The investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintage approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, it is between 1 percent and 3 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contracts are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
