Independent Auditors' Report

To the Plan Administrator of
EYA Tax-Sheltered 403(b) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of EYA Tax-Sheltered 403(b) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements

June 30, 2024 and 2023

(1) Description of Plan

The following description of EYA Tax-Sheltered 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

(a) General

The Plan is a defined contribution plan sponsored by Eckerd Youth Alternatives, Inc. (the “Organization”) for the benefit of its employees. Employees are immediately eligible to enroll in the Plan upon hire. Employees eligible for a 401(k) plan or another 403(b) plan sponsored by the Organization are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan currently operates under an agreement with Empower Retirement LLC (“Empower”). Effective December 31, 2020, Empower acquired the retirement business of Massachusetts Mutual Life Insurance Company (“MassMutual”). All current participant contributions, employer contributions, and rollovers from other qualified plans are deposited into Empower. The Plan previously operated under an agreement with The Variable Annuity Life Insurance Company (“VALIC”). Due to restrictions on distributions of funds held with VALIC, certain participants still have investments in the Plan which are held at VALIC. The assets included within the statements of net assets available for benefits include funds held at Empower, MassMutual and VALIC.

(b) Contributions

Each year, participants may contribute the maximum amount of annual compensation allowable by law as pre-tax contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation.

(b) **Contributions - Continued**

The Organization makes fixed matching contributions equal to 50% of up to 10% of eligible compensation that participants contribute to the Plan. Participants must have completed one year of service (except for employees transferred to the Organization from Odle Management Group LLC on December 26, 2021), as defined in the Plan, and be an active employee on the last day of the plan year to receive a matching contribution. The Plan also provides for two separate and distinct discretionary employer contributions. The first discretionary employer contribution is determined based on the plan year. Participants must have completed 1,000 hours of service and be an active employee on the last day of the plan year to receive an allocation of the first discretionary employer contribution. The second discretionary employer contribution is determined based on the plan year quarter and is intended to satisfy the requirements of a prevailing wage contribution. As such, an employee is excluded from the second discretionary employer contribution if the employee does not perform services subject to the Service Contract Act or if the employee is a highly compensated employee performing services subject to the Service Contract Act. The allocation conditions described for the first discretionary employer contribution (i.e. must have completed 1,000 hours of service and be an active employee on the last day of the plan year) do not apply to the second discretionary employer contribution. The two discretionary employer contributions also have different vesting provisions as described in Note 1(e). Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

(c) **Participant Investment Account Options**

The Plan currently offers mutual funds, pooled separate accounts, a collective investment trust and guaranteed interest accounts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

(d) **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Organization’s matching and discretionary contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(1) Description of Plan - Continued

(e) Vesting

Participants' contributions plus actual earnings thereon as well as the Organization's discretionary contributions which are based on the plan year quarter are 100% vested immediately. The Organization's matching and discretionary contributions which are based on the plan year are subject to the following vesting schedule:

Regardless of years of service, participants will become 100% vested upon attainment of normal retirement age (age 65, as defined in the Plan), death or disability.

(f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions. Participants may not have more than one loan outstanding at any time. Loan repayment terms may not exceed five years unless the purpose of the loan is to acquire a principal residence.

(g) Payment of Benefits

On termination of service due to death, disability, retirement after attainment of normal retirement age or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or installments over a period of not more than the participant's assumed life expectancy. The Plan is subject to the Qualified Joint and Survivor Annuity rules, meaning that married participants must receive retirement benefits as a life annuity to the participant and a survivor annuity to the surviving spouse following the participant's death, unless the spouse consents to an alternative form of distribution. The Plan contains a mandatory distribution provision which states that if the value of a terminated participant's vested interest in his or her account does not exceed \$5,000, then the entire amount shall be automatically rolled over to an IRA in the participant's name in a lump sum even if the participant does not consent. The Plan also provides for in-service withdrawals for those age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

(1) Description of Plan - Continued

(h) Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$69,704 and \$186,800, respectively. These accounts will be used to reduce future Organization contributions or to pay plan expenses. For the year ended June 30, 2024, \$42,518 was used to pay plan expenses.

(i) Assets Pledged as Collateral

Prior to January 1, 2016, participants were permitted to obtain loans directly from VALIC. The minimum amount of the loan was \$1,000 and the maximum amount was the lesser of \$50,000, or 50% of the participant's account balance. The loans are secured by assets held in the participant's VALIC Fixed Account Plus account. The amount of plan assets pledged as collateral for loans issued to participants by VALIC at June 30, 2024 and 2023, was \$45,426 and \$63,728, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Contributions

Contributions from Plan participants and the matching and discretionary contributions from the Organization are recorded in the year in which participant compensation is earned.

(e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Administrative Expenses

Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(3) Information Prepared and Certified by the Custodians

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America ("EAIC") on behalf of MassMutual, VALIC, Empower Trust Company and VALIC Trust Company Inc., the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Investments at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest income on guaranteed interest accounts
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Codification Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Interest Accounts: The VALIC Fixed Account Plus and Short-Term Fixed Account are offered as investment options for Plan participants through a fixed and variable allocated annuity contract. These accounts promise contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible surrender charge for withdrawals from the funds in excess of a limitation as defined in the contract. Therefore, these accounts are not considered benefit-responsive and are valued at estimated fair value as determined by VALIC. As these investments are contract-based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals and expenses. VALIC will declare and credit interest in the contract periodically, but not less than annually. The interest rate will be set in advance of the period to which it relates and will be at least 3% per year. Unobservable inputs are the composite crediting rate.

Pooled Separate Accounts: Valued at the NAV of units of the separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no participant redemption restrictions; the redemption notice period is applicable to the Plan. The funds have no unfunded commitments.

Collective Investment Trust: Valued at the NAV of units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no participant redemption restrictions; the redemption notice period is applicable to the Plan. The fund has no unfunded commitments.

The Organization elected to present investments at fair value and investments at contract value as aggregated totals in the statement of net assets available for benefits as of June 30, 2024 and 2023. The statement of net assets available for benefits in the previously issued financial statements as of June 30, 2023 and 2022 presented investments at fair value and investments at contract value on a disaggregated basis by investment type.

During the year ended June 30, 2024, management determined that the VALIC Fixed Account Plus and Short-Term Fixed Account were not fully benefit-responsive and should therefore be recorded at fair value. These investments were previously reported at contract value. Accordingly, the statement of net assets available for benefits as of June 30, 2023, has been revised to present \$2,899,332 previously reported as investments at contract value to investments at fair value. Additionally, the fair value leveling table as of June 30, 2023, has been updated to include these investments.

(5) Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with MassMutual. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

MassMutual establishes a guaranteed interest rate on a semi-annual basis for deposits received during a rate period. MassMutual also establishes an annual minimum interest rate for each year of the agreement and a minimum interest rate that will apply for the duration of the agreement.

(5) **Fully Benefit-Responsive Investment Contract - Continued**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

(6) **Party-in-Interest Transactions**

Certain Plan investments are pooled separate accounts managed by VALIC and fully benefit-responsive investment contracts (i.e. guaranteed interest accounts) with MassMutual and VALIC. MassMutual and VALIC are custodians and recordkeepers for the Plan and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid approximately \$195,600 to EAIC and VALIC for recordkeeping services provided to the Plan for the year ended June 30, 2024. The Plan also paid approximately \$64,000 to a third-party administrator and approximately \$48,100 to an investment advisor for services provided to the Plan for the year ended June 30, 2024. Additionally, notes receivable from participants are managed by EAIC as of June 30, 2024. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

(7) **Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

(8) **Tax Status**

The Plan has adopted a volume submitter 403(b) plan document provided by Hill Ward & Henderson, Professional Association ("HWH"). The Internal Revenue Service ("IRS") has determined that the volume submitter plan document is designed in accordance with applicable sections of the IRC and informed HWH of such in a letter dated March 31, 2017. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

(8) Tax Status - Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Subsequent Events

During February 2025, Plan assets held at Empower Trust Company and MassMutual were transferred to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company.

The Plan has evaluated subsequent events through April 28, 2025, which is the date the financial statements were available to be issued.
